TELEPHONE COMPANY WINS.

Jury Decides It Can Chop, Hew and Hack at Will.

The jury in the case of the State of Oregon vs. D. Clinton, the foreman of the telephone gang which caused the mutilation of a shade tree in front of the D. J. Fry property, yesterday afternoon brought in a verdict of not guilty. This verdict was a surprise and a disappointment to many residents of Salem.

The case of S. S. Martin against J. C. Johnson was also tried before Judge Burnett yesterday afternoon, and in accordance with the instructions of the judge the jury brought in a verdict in favor of Martin. This was a suit instituted by Martin to recover possession of a horse and buggy seized by the constable by virtue of an execution issued by Justice Turner. He also sued for damages at the rate of \$2 per day, from the time the outfit was seized. Burnett held that, owing to the nature of the case tried in the justice's court the act of the constable in levying upon the property was illegal. The jury fixed the value of the horse, buggy and harness at \$208, and the damages at \$38.
