SCHOOL LAND FRAUDS

Kelliher and Turner Cases up on Demurrer in Circuit Court

The so-called school land frauds had another inning before Judge Burnett this morning, when arguments were made on the demurrers to the informations filed against A. T. Kelliher and H. H. Turner.

Attorney Bingham, arguing on the demurrer to the information charging the client with the forgery of a deed, alleging that the instrument which is claimed in the information to be forged was not a deed, but a certificate of sale. The certificate of sale is not mentioned in the statute which enumerates the instruments the forging of which constitutes a crime. In arguing on the plea for an abatement of the information against H. H. Turner, Attorney Carson held that Turner appeared before the grand jury as a witness in the very case for which he has been indicted, and as his name did not appear in the information, that the same was defective. He also held that the other information did not state facts sufficient to constitute a crime.

Assistant Prosecuting Attorney Charles McNary, in replying to these arguments, held that the instrument mentioned in the information was in fact a deed, and therefore subject to forgery. On the argument for the plea on abatement, he held that the names of all the witnesses who appeared before the grand jury were not necessary adjuncts to the information, and cited cases to substantiate his contentions.

PROBATE COURT MATTERS

Judge Scott Looks After the Business of Administrators

Judge Scott this morning made an order setting aside personal property to the value of \$158.50 belonging to the estate of Frances Trombly, Sr., for the use of his widow, Eliza Trombly.

A. D. Gardner, as administrator of the estate of Mary Hollenbeck, this morning filed his final account. The court fixed Monday, Dec. 4, as the day for hearing objections to the account.

Eva A. Beal, as guardian of the person of Philip Beal, a minor, was this morning given authority to sell 13 1/2 acres of land belonging to the estate of the minor.

The final account of W. H. Quisenberry, as administrator of the estate of James H. Shuford, was approved by the county court this morning, and he was discharged from his trust upon his filing a receipt showing the distribution of a balance to the legatees of \$197.86.

ANOTHER DESERT MYSTERY

The latest mystery is reported from Sand Springs. The name of the old lady who has disappeared is not given in the following story, which we clip from the Silver Lake Central Oregonian:

Something like a month ago an old lady, with a wagon and team and a dog following the outfit passed through Silver Lake, bound for Washington from Yainax agency. She bore a letter from some one at the latter place, requesting people along her line of travel to kindly render her what assistance they could, as she was old, feeble and deaf.

William Sherlock, of Paisley, not long after her departure from Silver Lake, went to Prineville on business, and on his way passed the old lady's camp at North Sand Springs. The horses, wagon with provisions, bedding, etc., and the dog were there, but no old lady. On his return he again came by the camp and everything was as before, except that during the interval the dog had died. Mr. Sherlock made careful search for some sign of a human being, but his efforts were fruitless. He found the letter which the old lady

had shown to various people in Silver Lake, but nothing that would in any way explain the mystery of her sudden disappearance.

North Sand Springs is a lonely spot about 50 miles north on the desert from Silver Lake. It is likely that this disappearance, as has been the case of many others in the vast unsettled country lying between here and Prineville, will forever remain a mystery.—Prineville Review.
