COSSACKS LOSE AT TIFLIS

Tiflis, Russia, Jan. 12.—Nearly 350 persons were killed or injured as a result of an attack by Cossacks upon the Armenian seminary here, following the throwing of two bombs from that institution at a passing patrol. Four Cossacks were wounded and a boy killed by the bombs. The building was shelled, and 30 burned to death, and 300 were hurt by the fire of bullets.

University Notes

The local oratorical contest which will decide who is to represent Willamette in the state intercollegiate in arch, will be held in the First M. E. church January 26. There will be four contestants, Andrew Marker, who represented the University last year; Hugh L. Pared, John Elliott and A. Carlson. More interest has been taken in oratory this year than for some time, and it is expected that Willamette will again make a good showing in the state contest.

The second basketball team of the University last night defeated Woodburn high school team by a score of 14 to 8. The game was played at Woodburn, and was interesting, though a trifle one-sided. The first game of the season will be played to-morrow night, and will be a practice game with the high school team. The high school girls have one of the best teams in the state, and there is no reason why several interesting matches should not be arranged between the two teams.

NEW YORK'S LATEST PLAYS

New York, Jan. 12.—The coming in of the new year witnessed the return to Weber's Music Hall of Joe Weber and his company and the revival of all the glories of the little play house. "Twiddle Twiddle" is the name of the new piece, but the name has as much to do with the happenings as did its predecessor, "Higgledy Piggledy." There exists a most minute particle of plot which concerns a millionaire sausage maker from Cincinnati, portrayed by Mr. Weber, and his daughter, who possesses a mad desire to get a titled husband. The latter role falls to gigantic Marie Dressler. Of the play as a whole it may be said that it is a long time since such a bevy of fresh, young and fascinating girls have been displayed here. Their prettiness could not be surpassed and their costuming and grouping was especially attractive. The piece abounds in brilliant, sparkling and genuine humor. Joe Weber scored in a new makeup and astonished everyone by singing a real song, "Marie Dressler, from her entrance in the first act as a graceful, willowy Spanish dancer to the end of the play, kept the audience convulsed with laughter. The songs are the best that have been heard here in a long time. "For you and the girl you love," and "My aycephantid Gipsy maid," giving promise of being the song hits of the new year.

At Daly's the third of Winston Churchill's tasks to undergo adaptation to the stage was presented for the first time. "The Crossing" deals with an episode in the early days of New Orleans when Louisiana was still a Spanish province. What there could have been in the story to have prompted its dramatization one cannot imagine after witnessing a performance of the play. The play seems to be nothing more than a jumble of absurd incidents presented in the old fashioned melodramatic way. There is present the same repentant mother confronted with her long lost offspring, the son seeking to avenge his mother and the cold blooded villainous portrayal with his devilish plots. Of the cast, the less said the better.

At Field's theater, Miss Clara Lipman and Louis Mann who made tremendous hits some years ago in "The Telephone Girl" and "The Girl From Paris," began an engagement in a new comedy called "Julie Con Bon." Briefly told the story concerns Julie Con Bon, a Paris milliner, who upon coming to America becomes acquainted with a man of good family. Their acquaintance ripens into mutual love, and the climax is reached when, despite the opposition of his mother, a society leader, and the discouragement of meeting Julie's father, a besotted and half witted Frenchman, the young man royally persists in his purpose of marrying the young milliner. The play is decidedly French and feminine and furnishes an opportunity of displaying a crowd of pretty milliners. Miss Lipman won the warmest approval with her well known charming French accent and shy love making. It is to be regretted, however, that Mr. Mann was cast in the role of a depraved old drunkard. He certainly added nothing to his reputation by consenting to lower himself to the portrayal of such a distasteful part.

Fresh from one of the greatest runs Chicago has ever seen, Pay Templeton opened at the New Amsterdam in Geo. Cohan's latest musical play, "Forty-five Minutes From Broadway." The locale of the story is New Rochelle, which, by the railroad time table, is three-quarters of an hour's ride from Broadway. There is very little plot to the play; what there is of it concerns plain Mary Jenkins, a housemaid who, through the loss of a will, has failed to inherit the millions left to her. The recipient of this wealth was a young man of the feather head type whose brain matter has served over and over again in comic weeklies as a subject for jest. Numbers of characters quite new to the suburbanites are introduced, among them being "Kid" Burns, a youthful retired prize fighter. Burns is the slangiest of all the slang youths on the stage and gives out more slang than is contained in all of George Ade's books. He has most of the good lines in the play and certainly gets them off in a creditable manner. Miss Templeton, weighting and measuring more than she did when she last appeared here, portrayed a role far different from that in which playgoers have seen her in the past. The plot goes with a rush. At times, it may be compared to a riot, then a cyclone. No one is furnished cause to complain on the score of dullness. The whirlwind of the thing takes in everything

from high class vaudeville to melodrama.

Great interest was awakened among lovers of grand opera in the long awaited revival of "Faust" in which Mile. Emma Eames made her re-entry at the Metropolitan and Caruso his first appearance as a singer of French. Mile. Eames never proved as charming a Marguerite, while Caruso aroused a tremendous enthusiasm after the duo of the first act, again after the "Salut Demeurs" and the male trio. "Tristan and Isolde" had its first performance of the season with Mme. Nordica America's greatest singer, in her favorite role of Tristan. "La Sonnambula," "Rigoletto" and Wagner's "Lohengrin" were repeated. It is interesting to note in connection with the latest named opera that the leading role of Elsa was played by Mme. Rappold, an American woman, who has risen to the place in grand opera without that course of European study heretofore considered so necessary.

Henrietta Crossman at the Garrick added a curtain raise to "Mary, Mary, Quite Contrary," enabling her thereby to appear in the broad contrasts of tragedy and comedy in the same evening. "Madeline," as the piece is entitled, is considered one of the strongest plays in the repertoire in which Mrs. Patrick Campbell is appearing in England. The story concerns Madeline Bray, a French actress who for eight years has received the attentions of Norman Luard, an attaché of the English embassy. At last, he tells her that his future demands his marriage to his cousin; that despite his marriage he will remain true to her. She makes him promise that before leaving Paris he will call on her. She puts on her daintiest finery and uses all her powers to win him back. He wavers in his purpose to give up so charming a creature, but finally tears himself away. When the actress realizes that her lover is to leave her, she draws a pistol to shoot him. His coolness in the face of death so stirs her admiration that she lets him go quickly lest she repent of her mercy. As he passes out of sight, she turns the pistol on herself. The play furnishes a very striking contrast to the jolly play which follows it.

Despite its enormous seating capacity the late comer who did not have the foresight to purchase his seats in advance is only able to obtain at the box office the mere privilege of standing within the doors of the Hippodrome. When this mammoth theater opened last season the ballet and spectacle presented at the huge play house were a sensational novelty. The city raved over it and the press declared that the limit had been reached so far as gorgeousness were concerned. Nevertheless, when "The Society Circus," the present spectacle, was presented, the top notch was moved up a little higher. London and Paris have had magnificent ballets and spectacles, but they are nothing in comparison with that seen on the gigantic stage of the Hippodrome.

At Proctor's Fifth Avenue, Sardou's "Geopatra," in which Sarah Bernhardt and Fannie Davenport starred many years ago, was presented in all its old time magnificence. Never before has such a pretentious production been presented by a stock company.
