CHICAGO'S HOUR OF SILENCE

City Pays Tribute to the Memory of Its Greatest Merchant Prince

Chicago, Jan. 19.—Business generally was suspended from 12 to 1 o'clock, Chicago paying respect to the memory of Marshall Field the tribute of an hour of silence. The funeral cortege of the city's greatest merchant passed from the home on the South Side to Graceland cemetery on the North Side today. Private services were held at the home. Only a few were admitted to the graveyard. His employees attended memorial services at the auditorium this afternoon.

Republican Editors of Missouri.

St. Joseph, Mo., Jan. 19.—The Republican editorial association of Missouri met here today for its annual convention. The attendance is unusually large this year. The meeting will last two days and the local Republicans have made great preparations for the entertainment of the visiting editors. This evening they will be the guests at a banquet given in their honor by the McKinley-Roosevelt club of this city. Among the prominent speakers who will answer to toasts at the banquet will be D. M. Burnside of Poplar Bluff, C. M. Harrison of Gallatin, Phil A. Griffith of Greenfield, B. F. Guthrie of Milan, P. E. Burton of Joplin, W. J. Sewall of Carthage and others.

Washington, Jan. 19.—According to a cablegram from Manila, the contract for a sewerage system in Manila has been awarded to the Atlantic Gulf and Pacific Company, of New York and San Francisco, at a bid of \$1,631,063.20.

Changes in Road Districts.

Changes have been made in the following road districts, at the recent sitting of the county court: No. 25 corrected to correspond with Aumaville precinct; No. 26 to agree with Turner precinct; No. 29 to agree with Sidney precinct; No. 33 was divided and a new road district, No. 33½, was formed, both within the boundaries of Mohama precinct.

Voters Registering.

Registration at the county clerk's office is proceeding at the rate of about 100 per day, and each mail brings a bunch of blanks from outside precincts. The fine weather of yesterday brought quite a number from the country to register at the clerk's office. The total registrations now number over 1200.

Jumped the Track.

New York, Jan. 19.—A train on the Kings county elevated plunged into the street at Chestnut street and Fulton avenue about noon, and four were killed.

Will Honor Lehigh President.

New York, Jan. 19.—The alumni and former students of Lehigh university in and about New York will give a dinner in honor of Dr. Henry S. Drinker, the new president of the university, at the Hotel Astor this evening. Dr. Drinker is the first alumnus of Lehigh to fill the position of president of that institution, which is not yet forty years old. This fact, together with the recent election of a number of alumni to positions on the board of trustees of the university, has created a great wave of interest among the alumni and it is expected that there will be a large attendance at the banquet this evening. Dr. Drinker has been practically a resident of New York for several years prior to his recent election to the presidency of Lehigh, having been the general solicitor of the Lehigh Valley railroad, with offices in this city.

A Powerful Petition.

Des Moines, Ia., Jan. 19.—The Iowa senate this morning petitioned the governor of New Jersey to pardon Mrs. Tolia, sentenced to hang for murder.

CHINESE DOING CHICAGO

Chicago, Jan. 19.—Chinese Commissioners Tuen Fang and Tai Hung Chik and suite of 58 arrived in Chicago this morning, and were greeted by the mayor and officials. They were driven to the hotel, where officers commanding the department of the lakes called. They inspected the county institutions at Dunning. They will remain over Sunday, inspecting clubs, universities, factories, libraries and banks. Chinese-American banquets and automobile tours are on the program.

An Idle Rumor.

Chicago, Jan. 19.—William Walling, a student of social conditions in Russia, called his brother, in this city, this morning, that his arrest, as rumored, for complicity in the revolutionary movement was neither hinted at nor possible, and says the rumor is absurd.

Blew the Safe.

Elwood, Ill., Jan. 19.—Robbers blew J. C. Beatties' bank, stole \$1000 and escaped. Residents heard the explosion, but were unarmed. The robbery was discovered this morning.

Michigan Robbers.

Michigan City, Ind., Jan. 19.—Robbers this morning entered the store of the Staiger Hardware Company and stole \$1100 worth of silverware.

THESE AT THE PIE COUNTER

Washington, Jan. 19.—It is announced by the state department that the first United States ambassador to Japan will be Luke E. Wright, of Tennessee, now governor-general of the Philippines. David E. Thompson, former ambassador to Brazil, will go to Mexico, and Lloyd Griseom, formerly of Tokio, will go to Brazil.

Vice-Governor Henry C. Ide, ranking member of the Philippine commission, will probably succeed Wright, although General James E. Smith, of California, is mentioned.

A Run on Its Banks.

Santa Cruz, Cal., Jan. 19.—The San Lorenzo river overflowed its banks last night, and yards near the river were flooded to a depth of several feet.

Will Vote Tuesday.

Washington, Jan. 19.—The house committee on interstate commerce decided to vote Tuesday on the rate bills under consideration.

DRAW NO COLOR LINE

Indianapolis, Ind., Jan. 19.—The Federation of miners considered a number of constitutional changes today, and voted down the amendment proposed to draw "a color line between the races."

Anniversary of Czar's Lucky Escape.

St. Petersburg, Jan. 19.—The miraculous escape from assassination of the czar and the other members of the royal family on the 19th day of January of last year was celebrated here today by impressive thanksgiving services in all the churches. This day being the Epiphany, when, according to an ancient custom, the czar, being the head of the Greek church in Russia, blesses the waters of the Neva, the whole city was in holiday attire. The blessing of the Neva is one of the greatest and most popular celebrations of Russia and usually attracts many thousands of people from all parts of the country. This year the ceremony was not as elaborate as in former years and greater precautions were taken to prevent a repetition of the attempt on the life of the czar, which menaced the festivities last year.

The ceremony of blessing the waters of the river had just ended, about 1 o'clock in the afternoon of January 19, 1905, and the czar still stood in the little chapel built out over the frozen Neva, in front of the Winter Palace, surrounded by members of the diplomatic corps and big dignitaries of the state, when the salute from the batteries on the big square in front of the Bouras was fired. A perfect hail of shot, as big as pigeons' eggs, struck the chapel and the walls and windows of the Winter Palace beyond the chapel, narrowly missing the czar and the members of the royal family, who occupied the windows and balconies of the palace overlooking the scene of the ceremony.

An investigation showed that a full load of grape shot had been fired from one of the cannons in the place in front of the Bouras. The gun had been carefully trained on the chapel, which stood in a line with the palace, and it was considered a miracle that neither the czar nor any member of his family was killed or injured. Many windows in the palace were shattered by the grape shots, but not a single person was injured. The police arrested the officers and men attending the battery and the latter were afterward court martialled. It was never ascertained whether the firing of the grape shot was an accident or intentional. The theory was advanced that the gun had been held in readiness for an attack by the mob of strikers and had been loaded with grape shot and that it had been neglected to remove the grape shell and substitute a blank cartridge when the time came to fire the salute.

Filipinos Will Hear of Smiths.

Washington, Jan. 19.—Ide has been appointed governor-general of the Philippines, to be succeeded June 1st by General James F. Smith, of California.

STORM DOES GOOD

Six Inches of Rain Fall Glad- dened California and Set Her Rivers Humming

Sacramento, Cal., Jan. 19.—The sun is shining in a clear sky today, and the storm is believed to be over. The river stood at 23 feet 6 inches at 10 o'clock this morning, and was slowly rising. A great volume of water is coming down the American and Yuba rivers, but no danger is apprehended, although the levee is known to be weak at the site of the Edwards break of two years ago. Fifty men are working on the levee two miles south of the city. They feel certain they can prevent a break unless the river rises a foot higher. The Yolo basin, covering 25,000 acres, is now full, but the river is believed to have reached its highest point. The total rainfall for the storm is over six inches, and great benefit will result.

BLACKS KILLED THIRTY

Victoria, B. C., Jan. 19.—Advice of massacres by blacks in New Guinea and North Australia were received by the steamer Moana today. In New Guinea a party of warriors made a raid on the village of Ekiriat, 30 miles from the capital, Port Moresby, and killed 33 of the inhabitants, who were sleeping. The bodies were much mutilated. The village was looted and destroyed, anything of value being carried off. The village constable escaped, though his loin cloth was pierced by spears thrown at him, and, after hiding in the bush for some days with two other survivors, he arrived at Port Moresby to report the massacre, and a force of armed constables was sent to punish the raiders.

The other massacre off Port Keats involved the killing by blacks of six white men and three natives. Messrs. Flinders and Benning, government engineers, engaged in well-boring, brought the news to Port Darwin. They stated that two white engineers had been murdered, and seven black men arrested and taken aboard a steam launch. The party on board the launch was surprised by the blacks and massacred, with the exception of a native boy, who jumped overboard and escaped. The white men were killed with tomahawks while sleeping. The men massacred were: Messrs. Bradshaw, Dancock, Skach and Ivanoff and two other engineers, names unknown.

A posse of civilians and police was organized to proceed to the scene of the tragedy.

MOORS PRAYED TODAY

Algeiras, Spain, Jan. 19.—The Mohammedan Sabbath was observed today, and there was no session of the Moroccan conference. The Moors used the villa as a temporary mosque, where they held services and prayed fervently for the preservation of their country.

BOLD MONTANA ROBBERS

Butte, Mont., Jan. 19.—The Driscoll saloon was entered by two masked bandits early this morning, each carrying a brace of guns. Twelve men were compelled to throw up their hands, while the robbers fired several shots over their heads. The cash register was looted of \$200. The outlaws escaped.

LIVED OVER A CENTURY

Grangeville, Idaho, Man Puts in 116 Years on the Earth

A dispatch from Grangeville, Idaho, Thursday says: Francis Marion Hughes aged 117 years, died Sunday last at his place. He was born in Buncombe county, N. C., in 1788, and it is believed that he came to the West at the time of the discovery of gold in California in 1849. Since that time he has lived in Oregon, Washington and Idaho. During his residence in the latter state he has been known as "Old Man Hughes."

In 1903 Mr. Hughes was run over by a wagon, and since that time he has been unable to provide for himself. A year later he was again injured by a horseman, sustaining two broken ribs. Arrangements were then made to send the old man to the poor farm, but he protested so strongly that business men of Grangeville raised money to keep him, and since that time he has been living at the home of William Hendricks.

GREAT PETITION FOR SENATE.

Women's Signatures Against Smoot Fill Eighty Volumes.

New York, Jan. 19.—Eighty volumes, containing the signatures of American women who desire to see Senator Reed Smoot, of Utah, ousted from the United States senate, will be sent to Washington this week. Six months ago the National League of Women's Organizations sent an appeal to every state in the Union, asking women to help in the fight against Smoot by signing a memorial to the United States senate asking the expulsion of Senator Smoot on the ground that he pledged his first allegiance to the Mormon hierarchy, thus setting it above the United States government.

The 80 volumes are to be distributed among the senators, and the protest they represent will be presented by Senator Burrows, of Michigan. Then each senator in turn will present the signatures from his state.

SENATE AFTER BIGELOW

Washington, Jan. 19.—The senate committee on canals met in executive session this morning to consider Bigelow's refusal to answer the question as to his informants on the canal charges. The house will consider the urgent deficiency bill, a total of nearly fifteen and a quarter millions, five and a quarter for the Panama canal.

BUTTE COPPER COMPANY

Butte, Mont., Jan. 19.—The Butte & London Copper Company, the biggest mining concern organized in Butte in recent years is announced. Chief Justice Brantly, of the state supreme bench is president of the company. It is capitalized at \$5,000,000.
