

VISIBLE ADVICE TO CLUBWOMEN

WORK IN INTEREST FOR BETTER SALOON, RATHER
THAN TRY TO WIPE IT OUT OF EXISTENCE

December 24 the Chicago Tribune published a report of a meeting of ten clubwomen which was held in the principal museum of the public library, Chicago, December 23. Some came together to hear a talk by Mr. C. H. Wentworth, of the Neighborhood Improvement Society for the reduction of the liquor traffic and all in its manufacture. He spoke of the Neighborhood Improvement Society of Cook county, and when he had finished they were prepared to denounce the liquor traffic and all engaged in the business. Wentworth disappointed them, however. What he said we herewith publish in part:

One was asked what might be the most potent influence in our city. Wentworth, "those results are of the greatest importance and most prolific, it would be far from the truth to say the school, and—"

"The church," came the feminine response, while 200 heads nodded approvingly. "The saloon," finished the speaker.

"The 200 radiant sparks of hope flickered a few years ago the church would have been considered a factor, but to hold upon the people of a great city is insignificant, and will grow more insignificant and knowledge in."

"The hope sparks went out. Wentworth paused and looked at him as if fearful of what might come. Then he went on. He defended the saloon, declared that beer was as healthful as any beverage which it had substituted, and said the saloon and his tin pall were invaluable. And he said many other things. The plan suggested," he continued, "is that of attempting to prohibit the frequenter of the saloon in the form of free lunch with a cheap meal in another place, and thereby make the accompaniment of beer go with the saloon lunch. The objection suggested is that all efforts to separate the workingman and his beer have failed. The saloon today is not only stronger than it was but is growing one. The second

objection is that any substitute to be provided for beer is at least as injurious to the system, if, indeed, beer can be proved to be injurious; and the third objection, an extremely important one, is that such places cannot be supported except for the short period when public interest is centered on the subject, and then only at an exceedingly limited number of places."

The speaker then declared that there are already too many cheap lunch counters in the city. He said although these are located conveniently in all parts of the city they are not largely patronized by workmen.

Speaking of the workman's love for his beer, Mr. Wentworth declared: "He doesn't want coffee—that is harmful; milk is debilitating; and water is polluted. He must drink; can you provide anything that will take the place of his beer?"

Looking at the saloon from what he called the "friendly point of view," Mr. Wentworth pointed out that the saloons of Chicago contribute \$4,000,000 annually to the city treasury, that they give employment to 40,000 people, and thus support probably 200,000 persons.

"These saloons are the clubhouses of the poor," he asserted, "for they have nowhere else to go. Are the churches and schoolhouses open to them? It is the refuge from storms of summer and winter to any of the unfortunate who have no other place to go. Suppose you close the saloon on Sunday, what will you do with the poor and the tramps during the cold of winter? You can't build 8000 club houses for them in all parts of the city."

In conclusion Mr. Wentworth urged the club women to work for a better saloon instead of trying to wipe it out of existence. He declared the saloons of the German type, where families could gather and listen to good music and eat good meals, would be a splendid thing for Chicago.

"If you expand this idea into the neighborhoods, take down the screens and curtains, eliminate all suggestions of secrecy, remove the bars which are made only for individuals, and substitute the restaurant and the music which are for the family, you will have created a revolution in our civic life."

THESE WILL VOTE

Registration during the past week has been heavy, and the per centage of voters registered to the total number of voters is by far the largest on record for the same length of time.

The registration books were opened January 2, and in the month that has intervened 1987 names have been enrolled on the roll, 1428 belonging to the Republican party, 386 to the Democratic ranks and 173 to various other parties.

The vote so far registered for Salem is 1026, and for the balance of the county, 961. The total registration in 1904 for the county outside of Salem was 4177 and in Salem was 1798. Thus it is seen that 57.06 per cent of the voters of Salem have registered, while only 23 per cent of the names from the county have been entered. There are about 200 names in the hands of the county clerk waiting entry in the registration book.

The clerks in the office of County Clerk Roland are kept busy checking signatures on the petitions being received from the candidates, and also on the initiative bills that have been in circulation.

Insufficiently extensive for such purposes, and additional land is not obtainable, the troops will merely drill and have other similar exercises. It is planned by General Bates to have the troops actually in camp for three months, or away from their posts for about four and one-half months. In this scheme there is no provision for a share for the national guard, although this will be possible if the state authorities choose to draw upon the militia fund for this purpose.
