PROPHET AFTER PROFITS

Dowie on His Way to Chicago to Get a Grip on the Company Money

Laredo, Tex., April 7.—Dowie entered the United States this morning. He was not in a private car, because none was available. When the train stopped at the international bridge for inspection the crowd of newspaper men were met at the car door by Dowie's associates, who would not permit them to come in close contact with the "prophet." They said Dowie's strength has increased under opposition.

Murder or Suicide.

New York, April 7.—Miller McGucken, son of the proprietor of the Hotel Sterling, was arrested here this morning, pending an investigation into the death of Delphine Love, who was supposed to have committed suicide yesterday after a quarrel, in another hotel, with McGucken, with whom she registered as man and wife.

Clerk Swiped the Coin.

Chicago, April 7.—John A. Linn, former clerk of the superior court, and present clerk of the circuit court of Cook county today pleaded guilty to charges of embezzlement and conspiracy in concealing public records, and was sentenced to from one to five years. He agreed to replace the stolen money, amounting to \$21,000.

Hager Was Stripped.

Hong Kong, China, April 7.—Dr. Charles K. Hager, the American missionary, was robbed April 3d by Chinese pirates, who held up three passenger boats while anchored in the Tung river. He was attacked by four pirates armed with Mausers. The boats were riddled and the cash and clothes and surgical instruments were taken from Hager.

Blew Up the Governor.

St. Petersburg, April 7.—Governor Neptsoff, of Tver, was assassinated on the streets of that city this morning by a bomb. He was driving on the main street, and his body was badly mutilated.

President Cannot Be There.

Washington, April 7.—The President has notified the League of American Municipalities that he will be unable to attend the convention in Chicago in September.

Held Last Meeting.

New York, April 7.—The anthracite coal roads and independent operators met in secret conference today for a final consideration of Mitchell's offer of arbitration.

Belt Caught Him.

Burke, Idaho, April 7.—David Taylor, a prominent mine and mill man, was caught in a belt at the Hercules mill this morning, and instantly killed.

Cambridge Won.

London, April 7.—Cambridge won the annual race from Oxford this morning by five lengths.

Holding Its Primaries.

Naples, Italy, April 6.—The eruption of Mount Vesuvius is now most violent. On the Pompeii side the main stream of lava has divided, one stream threatening Otto Nano, a town of 20,000 inhabitants, and the other is threatening Terredel Greco, with a population of 30,000. The danger is immediate, and calls for the evacuation of Boscoreale village, which is nearest the crater, and has a population of 9000 souls. From the new crater, which is 20 feet in circumference, the lava has already flowed two and a half miles.

GAMBLER SHOT THE SHERIFF

Good Old Days of Gold and Guns Come Back to Nevada

Manhattan, Nev., April 7.—Thomas Logan, sheriff of Nye county, was shot and killed by Walter Berrier, a gambler here, at 6 o'clock this morning. The men became involved in an altercation over Logan's efforts to eject Berrier from a disorderly house. Berrier began shooting, and the sheriff returned his fire, but without effect. Logan was shot through the head, dying two hours later. Berrier was arrested and hastened to Tonopah, to avoid lynching.

SCOTTY'S MONEY IS ALL IN

San Bernardino, Cal., April 7.—Walter Scott, the Death Valley miner, made a powerful financial showing at his arraignment this morning, and was released on a \$100,000 bond. He was arrested on a charge of conspiracy in concealing public records, and was sentenced to from one to five years. He agreed to replace the stolen money, amounting to \$21,000.

Great Britain's Canals.

London, April 7.—King Edward has appointed a royal commission, headed by Lord Shuttleworth, to inquire into the canals and inland navigation of the United Kingdom, and to report what changes are desirable in their extension and control.

The total length of British canals, according to the last official report, is less than 4000 miles, of which aggregate considerably over a fourth is owned or controlled by railway companies. The neglected condition of the British inland waterways generally has been the subject of agitation for many years and as long ago as 1893 a joint parliamentary committee was appointed, which recorded an emphatic opinion as to the necessity of sweeping improvement if the system of waterways, once the admiration of other nations, was to bear its proper share in the work of internal transport.

More recently the agitation has been renewed and fostered by certain chambers of commerce and last year the association of chambers adopted a resolution in favor of placing the canals in the hands of a public trust. A bill with that object was then introduced, but suffered the fate of withdrawal upon a technical failure to comply with standing orders.

The Dry Tortugas Transfer.

Washington, D. C., April 7.—The abandonment of Dry Tortugas as a naval coaling station will not be made without opposition, although Secretary Bonaparte is somewhat in favor of the transfer of the reservation to the treasury department, by which the place is desired for quarantine purposes. The secretary holds that there should be some consideration in the transfer and that the navy department should be compensated for some of the outlay at the place, which has amounted to \$500,000.

The naval general board has urged that the naval property at Dry Tortugas be transferred to Guantanamo. The wisdom of abandoning the coaling plant at the former place is much questioned in some quarters, notwithstanding the point made by the general board that it is difficult and costly to fortify, and would prove a menace to the government in time of war by inviting the enemy to attack and obtain the supply of coal kept at the station. On the other hand, it is maintained that it is necessary to keep a coaling station at the entrance to the gulf, and that there should be liberal expenditure of government funds in establishing the defenses, which will have to be built at Guantanamo, if that place is converted into a base and supply station and dock yard. The fight is becoming interesting, and it is likely that before there is a decision, naval officers who are in favor of keeping Dry Tortugas will be heard on that side of the question.

BUTTE PLAYS BALL

Butte, Mont., April 7.—Butte has decided to enter the new Northwest baseball league. Five hundred dollars as a guarantee were posted last night, following the election of the officers of the local organization. Charles McIntyre was elected manager. The season opens at Spokane April 24th.

Perry and Paul Jones.

San Diego, Cal., April 7.—The remainder of the Pacific squadron arrived at midnight from Magdalena bay, to remain until April 9, and then they go to Long Beach, and thence north. If all the claims are allowed Perry wrested the trophy from Paul Jones for torpedo work. Perry hit six targets with six shots. Paul Jones hit five out of six, but a protest was made that Perry used triple expansion pumps, against the rules.

Knocked the Mortgage.

Topeka, Kansas, April 7.—The supreme court today decided the Kansas City Livestock Exchange to be a trust. This invalidates all chattel mortgages on cattle given in Kansas to members of the exchange.

Contemplating Big Bond Issue.

New York, April 7.—The stock transfer books of the Southern Railway company were closed today, not to be reopened until April 19, the day after the special meeting of the stock holders of the company, which is to be held in Richmond, Va., on April 18. That meeting will be of great importance, as the directors of the company have decided to ask the stockholders to authorize an issue of \$200,000,000 development and general mortgage 4 per cent bonds.

Of this amount \$15,000,000 will be issued immediately, for the following purposes: \$4,962,774 to refund payments for equipment heretofore made and charged to capital; \$3,500,000 to refund investments in securities of and advanced to subordinate companies heretofore made and for the acquisition of property not heretofore funded, and \$6,536,226 for double track, revision of grades, new yards, shops, etc. The balance of \$185,000,000 will be reserved for the following purposes: \$31,128,000 to retire division prior lien bonds on properties acquired, for which no provision is made in the consolidated mortgage; \$16,000,000 to retire not later than April 1, 1909, collateral trust 5's; \$18,008,000 to retire, as they mature in the next 15 years, equipment capital obligations; \$10,000,000 to acquire capital stock of certain leased lines; \$10,000,000 to pay, not later than July 1, 1908, for the eastern division of the Tennessee Central and immediate improvements. After provisions for the foregoing obligations are made there will be left \$99,834,000, which will be used to provide for the further acquisitions and betterments, but to be issued only under strictly limited provisions of the mortgage and to be provided for as follows: In each year, not exceeding \$5,000,000, to be used for betterments and improvements on the entire system and for new equipment and in exchange for first mortgage bonds not exceeding in amount the actual cost thereof of railroading and terminals heretofore acquired. It is understood that a syndicate headed by J. P. Morgan & Co. has been formed to purchase the \$15,000,000 bonds to be issued at once.

To Have Permanent Exhibition.

Amsterdam, April 7.—An organization has been formed here under the name of "The International and Industrial Exhibition and Sale company" with the object of establishing a permanent exhibition of manufactured products of every description. Articles placed on exhibition cannot be sold. The exhibition building is situated in the best part of the city, between the state and municipal picture galleries, on the site of the international exhibition of 1892, and offers every facility for the display of goods. The necessary electric power, gas and water, will be furnished to operate machinery.

Baron W. Van Ittersum, a member of the board of trustees, has gone to the United States for the purpose of interesting American manufacturers in the enterprise. The company has agents in all the principal cities and towns of the Netherlands, who will distribute the journal of the company gratuitously throughout the various districts. The journal will be published semi-monthly and will be sent to all persons in the Netherlands and its colonies. That paper will make liberal notices of the various exhibits.

DOWIE ON THE TRAIL

San Antonio, Tex., April 6.—Dowie, after the train left Laredo, welcomed a correspondent. He denied entirely the charges of his wife and son and the over-seers, and said he would drive his wife and son "from the City of God." He says he has been true to every trust, and is answerable only to God. He says: "The charges are the foul mouthings of ingrates." He cursed them, and said "the receivership curtailing my authority are illegal acts. In the courts, as well as elsewhere, with my right hand I will smite my enemies. Women have proved the downfall of prophets of old, but they cast no spell on modern prophets. They say I lost millions in Wall street. It is a lie, and the lustful letters, purported to have been written by me are forgeries, and their authors shall be put in prison. All charges will be publicly refuted. Within a week Dowie will again be Zion's leader, and accepted as a holy man of God, and not as a charlatan."

San Antonio, Texas, April 7.—Dowie reached San Antonio at 1:10. He alighted with the salutation, "Peace be with you," to a crowd of Dowieites. He posed for a photograph and made a short address, saying: "It is impossible for these whom I have led from darkness into light to depose their creator." Going back to his Zion acceivers, he said "they would be cast into outer darkness." He spoke with strong gestures and flashing eyes. He walked unaided through the station and entered a carriage. He was followed through the streets to the hotel by a strong guard of followers.

Bad Man Captured.

Portland, Or., April 7.—Jake Mitchell, accused in five states of horse stealing, train robbery and the murder of two deputy sheriffs, and who has repeatedly declared that he would never be taken alive, was captured at Eugene and brought here this morning. He will be taken to Idaho to stand trial for murder. He robbed a Northern Pacific train in Montana two years ago, and killed one of the posse pursuing him. He was next hunted for horse stealing in Idaho, where he killed a pursuer.

Sam Will Fight.

San Francisco, April 7.—Sam Berger leaves tomorrow morning for Hartlett Springs, where he will take off 10 or 15 pounds, preparatory to a bout with Abe Attell. While it is certain that Berger is not satisfied with his match, there is no doubt but that he will fight, but possibly the match may be postponed.

ELKS TO HAVE A HOME

It is probable that the bids for the construction of the new Elk building, which is to be erected on the old R. M. Wade property, Court street, will be accepted at a meeting of the trustees of the lodge held this evening.

The building will be of beautiful design and will cost upwards of \$15,000. The plans of the edifice were drawn by a Portland architect, and have been accepted by the lodge. The building will be 100x150 feet, two stories high, and will be used exclusively for club purposes. The basement and lower floor will be occupied by the Illikee Club. The upper story will contain the Elks' quarters, and will include a large lounge room, banquet hall, ante-rooms, parlors and kitchen. The building will probably have a stucco facade, and the remainder may be finished in shingles. Work on the edifice is to begin immediately.

COAL STRIKE QUIET

Some of the Small Mines Weaken, But the Big Ones Are Out for a Fight

Springfield, Ill., April 7.—The end of the first week of the coal strike shows but little change. The operators have lost a few adherents. A hundred mines which have signed represent only a million tons. There are 932 mines in the 34 counties. Three hundred and eighty produce all but two million tons of the total output of thirty-seven million tons a year.

Indianapolis, Ind., April 7.—Eighteen per cent of the tonnage of Indiana has signed the 1905 scale. A dispatch this morning says the Pennsylvania railroad employees laid off last week on account of the threatened strike, have been ordered to report for work next week. This leads to the belief that the operators intend to make a settlement.

Stopping Waste On English Railroads

For many years the managers of the Northwestern and the Midland roads in England have, like many of their American counterparts, foolishly engaged in a costly and wasteful strife for competitive business. They have at last come to realize that the only result of such a contest is the needless expenditure of money. No additional traffic is created in such a strife, nor does the amount of business each road is able to secure by such methods differ materially from that which would move by their respective lines under normal conditions. Up to the present time millions of dollars have been spent in securing traffic and maintaining unnecessary high speeds. Hundreds of unnecessary trains have been run simply for the purpose of injuring each other. A realization of these conditions has finally culminated in an agreement which is made operative for a term of fifty years and under which the expenditures growing out of a contest for supremacy will be saved to the companies.

The trains which did not pay have been discontinued, and instead of each road seeking to run trains at the same time as those dispatched by the other company, it is now arranged to run them alternately, thus giving to their patrons more frequent service than was done under the former practice. The notable thing, however, in connection with this change of policy is the congratulatory notices of the English press because of the saving, not to the railroad, but to the public, which is effected thereby. Unlike their American contemporaries, the English newspapers are alive to the fact that the people pay the total cost of transportation, and that all unnecessary expense connected therewith constitutes an unnecessary tax which comes out of their pockets. It is not stated whether this agreement is in the form of a pool or not; presumably such is the case, for the English law recognizes the value and efficiency of such agreements.—The Railway and Engineering Journal.
