EARTHQUAKE IN CONNECTICUT FOR A CHANGE

Took Smallpox to Chicago.

Chicago, May 8.—Edward G. Adams, of 2874 Golden Gate Avenue, San Francisco, is confined in the hospital here suffering from smallpox. He was a refugee who left San Francisco with the disease after the earthquake.

Scranton, Pa., May 8.—The anthracite mine workers' convention today ratified the agreement made by the sub-committee Monday, and the miners return to work Monday.

LIKE A MINING CAMP

San Francisco Beginning to Come Like a Phoenix out of its Dead Ashes

San Francisco, May 8.—New San Francisco begins to look like a mining camp. Hundreds of temporary buildings and shacks are springing up in every direction like magic. The air is filled with flying dust and plaster, stirred up by men demolishing walls and preparing for new foundations by the army of workers. The number of teams was greatly augmented this morning.

Workmen this morning began shoveling debris from the top stories of the St. Francis hotel, which will be ready for occupancy in a short time.

One firm has closed contracts for 100 first-class buildings and contracts to clear the debris from 100 lots in the business section. The report from New York that a big syndicate to rebuild the city is a reality, greatly encouraged citizens, who are going forward on their own hook to reorganize their business. Those with small credit will be obliged to await the insurance settlement. It is now certain Market street will hold its own, and that the city will be built practically on the old lines, so far as the locations and forms of business is concerned.

Russian Methods.

St. Petersburg, May 8.—The meeting of the members of the new council of the empire was broken up by soldiers, at the instigation of the Czar. The building was surrounded by cavalry, and the police chief ordered the members to disperse. Twenty-eight members of the parliament signed a protest against this action. The Democrats are aroused, and demand the dismissal of the chief of police. Many workmen and leaders have been ordered to leave the city, and are not given time to remove their families.

Railroads Building.

San Francisco, May 8.—The United Railroads now has 2200 men at work, as against 3000 previous to the fire. Nearly 300 cars are in operation today. Practically every electric line outside of the burned district is running. The discovery was made today that many were carrying supplies that had been supplied for the Red Cross, and which were looted en route, many goods being taken. The matter will be investigated.

Arbor Day in Montana.

Helena, Mont., May 8.—Today is Arbor day in this state and, in accordance with the governor's proclamation it is generally observed as a legal holiday. In all public schools exercises are held in keeping with the character of the day, and school children and many citizens planted trees in the schoolyards, public parks, along the highways and in the yards of their residences.

A Fire in Chicago.

Chicago, May 8.—Fire destroyed the Chicago, Milwaukee and St. Paul freight house today, with its contents, and a number of cars. The loss is estimated at \$300,000.

Two Bishops to Come West.

Chicago, May 8.—Bishop Moore, of the Methodist church, has been assigned to visit the conferences in California. Bishop Warren will visit the Washington conferences.

Powder Will Blow Up.

Zenia, Ohio, May 8.—The Miami Powder Company glazing mill blew up today, causing \$1000 damage. The building was wrecked.

Throw a Derrick.

Madrid, Spain, May 8.—A stone thrown at the royal automobile today missed King Alfonso, but struck his sister. Her injury is not serious.

Constantinople, May 8.—Nedjim Edin Bey, procurator general of Tripoli, was murdered by Ali Shamamyl Pasha, former military governor of Seatari, who seized the procurator by the throat choking and biting him until he was dead.

No West Point Sharp Shooters.

West Point, N. Y., May 8.—General A. I. Mills, superintendent of the military academy, has decided there shall be no rifle practice among the cadets outside of the routine work in that line. It was hoped that this year the cadets would be represented by a team at the national match at Seagirt in September, and the marksmen who form the team at the naval academy had hoped they would have an opportunity to shoot in competition with the West Pointers on May 26th, when the academies have their baseball game at West Point. General Mills, however, finds that it would take much time to get the cadets in condition for competitive work with visiting teams. He thinks the time can more profitably be used in the work of the institution, and he does not see the necessity of making rifle practice part of the athletic training, as is the case at Annapolis.

Lancaster Conference Meets.

Lancaster, Pa., May 8.—The annual spring meeting of the Lancaster Conference of the Lutheran Ministerium of Pennsylvania opened here this morning at Christ church with a confessional service. The Rev. R. G. Welder preached the conference sermon. The first business session will be held this afternoon, when the report of the president and the other officers and of the committees will be submitted. Other routine business will follow, and later in the afternoon there will be a discussion of the topic "The Tithing System in Systematic benevolence," which will be introduced by the Rev. J. W. Smith. The conference will close on Wednesday afternoon.

From the Philippines.

Washington, May 8.—Ide cables the Filipinos and American residents of the Philippines send sympathy on account of the Frisco disaster, and states funds have been contributed by all nationalities.

Nobody Cares, Anyway.

Paris, May 8.—The final inquiries as to the possibility of a reconciliation between Count and Countess Boni Castellane were resumed today. The countess will file a revised bill as soon as the present proceedings are completed.

Russia Wants Gorky.

Moscow, Russia, May 8.—It is rumored that the government will ask that Gorky be extradited.

Railroad Wreck.

Atlanta, Ga., May 8.—It is reported seven persons were killed today in a wreck on the Southern near here.

Exploded Bombs.

Paris, May 8.—Two bombs were exploded this afternoon in Rue des Plantes, and three persons injured.

Canada Donates \$100,000 to the San Francisco Sufferers

San Francisco, May 8.—Max Miller, a jeweler, left his home on Twentieth street yesterday to deposit diamonds worth \$500 in a vault at Oakland. He has not been seen since, and it is believed he has met with foul play.

At a meeting of the general committee this morning Mayor Schmitz read a telegram from the Toronto Star, in which the Canadian parliament offered \$100,000 to San Francisco. The offer had already been refused by President Roosevelt, after which it was sent direct to this city, and Chairman Phelan wired his acceptance. The funds now available amount to \$2,313,681. Governor Pardee today agreed to give a week's notice before the discontinuance of legal holidays.

TWO HOP CONTRACTS FILED.

First Sale of This Year's Crop Recorded.

In the county recorder's office yesterday two hop contracts were filed for record. Each was made by Suey Gee, a Chinaman, who contracted with Benjamin Schwartz & Sons, of New York, for the sale of his hops—7000 pounds for each of the years 1906 and 1907. The contract price of the hops is to be 9 cents per pound, a part of the money to be advanced for harvesting purposes, the remainder to be paid on delivery.—Albany Herald.

State News

The Chemawa Indians met defeat at the hands of the Dallas college Saturday by a score of 14 to 9.

In the intercollegiate debate Saturday evening between teams representing O. A. C. and Pullman college, the honors were decided in favor of Pullman.

Merrill Moores, the former well-known athlete, who graduated last season from that college, is now at Cornell, and has made first place in the jump on the Cornell track team.

Marion McClain, Walter C. Winslow, Misses Nellie Foshey, Norman Hendricks, Victoria Mitchell and Loris Johnson have been selected to try for the Failing and Beekman oratory prizes at the graduating exercises of the U. of O. in June.

Prestley G. Eubanks, a pioneer citizen of Douglas county, died at his home at Oakland Saturday, May 5th, aged 68 years. Mr. Eubanks came to Oregon in 1852, and settled at Oregon City, going from there two years later to Oakland, where he was one of the first settlers.

Bicycle Stolen.

Miss Nellie Peterson, one of the local telephone operators, lost a bicycle Sunday. She left the wheel in front of the "hello" building when she went on duty, and it was missing when she looked for it again. Last evening Miss Peterson saw a wheel in North Salem that she thought was hers, but the rider was too far away for her to be sure. The wheel was a Hartford.

IMMENSE FLOODS IN CHINA

Causes Great Loss of Life---Foreigners Said to be All Safe

Chicago, May 8.—Washington dispatches state that immense floods prevail in the Hunan province, China, causing great loss of life and property. Foreigners are safe.

Will Walk for Science.

Philadelphia, May 8.—Edward Payson Weston, the veteran pedestrian, started from here today to walk to New York. A large crowd was present when he started from the city hall at 11 o'clock this forenoon, and the old man was cheered by the crowd on his way. Three years ago Mr. Weston was asked to walk from here to New York in the interest of science, but deferred it from time to time. He is now 68 years old, but believes he can walk as fast as he could 30 years ago.

The late Professor R. Ogden Doremus was one of the physicians who signed the request that Mr. Weston make the trip. Before, during and after the walk Mr. Weston will be watched by physicians. He was subjected to a careful examination before he started on his long walk this forenoon and was found in excellent condition. Several physicians in automobile are accompanying Mr. Weston. He expects to reach the ferryhouse at the Pennsylvania railroad station in Jersey City at 11 o'clock tomorrow forenoon.

Mexican War Veterans at the Capital.

Washington, May 8.—The 33rd annual reunion of the National Association of Veterans of the Mexican War opened here today for a two days' session. The attendance is surprisingly large. Many of the members are accompanied by their wives and families. An interesting program has been prepared for the occasion, including a number of social features and a visit to President Roosevelt at the White House.

The Week's Weather.

The past week was dry and warm. A few small showers occurred in the coast counties and also in the foothills of the Blue Mountains; but the amount of rainfall was inconsequential, and droughty conditions prevail in all parts of the state.

The mornings, as a rule, were cool, with temperatures dangerously near the frost mark, but, fortunately, the dryness of the atmosphere prevented frost from forming except in a very few localities, and in these places the frosts that did occur were too light to cause serious damage. The afternoons were warmer than usual, especially during the opening and closing days of the week. Gentle northwesterly winds prevailed during the entire week, except in the Columbia River valley, where they were disagreeably high on one or two days, but not sufficiently high to be destructive.
