

GENERAL APPROPRIATION BILL CARRIES

Will Legalize the Claims of All the Normal Schools and Higher Education

Secretary of State Dunbar admits that the general appropriation bill, on which the referendum was taken, and which it was generally supposed would be defeated by popular vote, has been carried, and all the items contained therein will have to be paid.

Many of the claims against the state have been hypothecated at 90 cents on the dollar, and holders will now get par and probably be allowed interest from date until paid. All claims against the state for which taxes are levied will be paid as soon as the vote can be canvassed and warrants issued.

As the direct vote of the people has sustained the general appropriation bill, that measure will go into effect as soon as the vote is canvassed, and the governor issues his proclamation, and in ten days the act receiving a majority of the votes cast shall be in full force and effect.

All persons having claims against the state will then be able to present

the same and have warrants issued for the full amount of the same, but not for the interest. This applies to all claims for which taxes are levied, and the state board levied for all but the normal schools, the State University, the Agricultural College, and for some improvements and additions to the state institutions, amounting to several thousand dollars. But bills for these institutions will have to be audited and warrants issued for the same, even if there is no money to pay them.

Sustaining the general appropriation bill virtually by a vote of the people sustains the normal schools and all the institutions of higher education, and they have all been running, except Weston, and will put in claims for the full amount of their running expenses. The only effect of taking the referendum has been to pile up a lot of interest claims against the state. These interest claims will have to be allowed by the legislature, as many of the holders of large claims will not present them until interest is allowed for all the claims outstanding. It will pay those who have certificates against the state to hold them until the legislature allows the interest claims, as giving them up now may invalidate all claims for interest.

CANAL BUILT ABOVE VALLEY. High-Line Ditch in Jackson County Will Have Length of 135 Miles.

A canal along the hillside for 135 miles, 400 feet above the Rogue river valley, is what the High Line Ditch Company, with headquarters at Portland, hopes to have completed by this time next year. Milo P. Ward, a well-known Portlander, has been engaged for seven years in financing the scheme, and has secured ample capital from Indianapolis to put the ditch through, from the headgates on Upper Rogue river to where it will debauch into the same stream at Gold Hill, Jackson county.

"We have just bought the power plant at Gold Hill and have expended \$80,000 in the purchase and improvements," Mr. Ward said today, "and we have spent \$20,000 more on the works at the head gates and on the first 20-mile section of the ditch, which is to be 20 feet wide and six feet deep narrowing to 14 feet in width at its terminus. Contracts for digging the entire ditch will be let this summer, and the cost of construction is to be \$920,000.

"The high-line ditch will supply water for irrigating, and for placer mining to the farms and mines along its route, where water is badly needed at present. Gold in considerable quantity exists in the gravel below the line of the ditch and can be obtained by piling from our canal. Besides this, new orchards, alfalfa beds and vegetable gardens will be cultivated where now the land is too dry in the summer season for successful farming.

"The land along the hillside has been propped solid enough to hold water at such great heights, and there is no fear of leaks or breaks in the banks. The high-line ditch will prove

A blessing to a large section of Jackson county, which has hitherto suffered from lack of water in the dry months of summer and early fall."
