The lay-out band, too, was a sight worth seeing. It receded the days when Populism was at its zenith in the state and when men went about with bayonets in their hair to be praised of men.

The parade and the thousands of patriotic people assembled at Marion park just at noon, and after a few selections by the different bands, the president of day, Hon. Frank Davey, made a brief opening address. The chorus of sixty voices, under the direction of Dr. Epley, sang a number of national and other airs, and Rev. David Everett invoked the blessing of Divine Providence on the exercises. Charles Roth, assisted by the chorus, gave a fine rendition of the "Song of the Flag," and Miss May Clasper, in splendid voice and perfect interpretation, read the Declaration of Independence.

This was followed by the singing of a song composed by Dr. J. H. Parvin of Salem, by Miss Beryl Emerson.

Then after the excellent speech of Mr. Greer, the chorus sang the "Star Spangled Banner," there was more band music and the crowd dispersed for luncheon.

Ex-Governor's Address.

Mr. Greer made a very able and interesting address. He related some of the causes that led up to the birth of the nation and gave an eloquent eulogy of the immortal author of the Declaration of Independence, Thomas Jefferson. The orator also touched upon modern topics.

The evening excursion numbered about 150. It was a jolly crowd, and all seemed pleased by the manner in which they were treated while here.

On Willamette River.

At 8 o'clock 5000 or more people assembled on the banks of the Willamette river, just above the steel bridge, to witness the launch races, aquatic sports and the prettiest and best pyrotechnic display that has ever been seen in this city.

These sports continued until nearly 10 o'clock, and then hundreds of the visitors made their way to the Elms' Skidoo, where they spent the rest of the evening.

The success of the celebration was not only due to the vigorous work of the heads of the committees, but to the willingness of sub-committees to assist in every way, and to bear their share of the burden in the preparations for this big affair.

All are entitled to the unstinted praise of the people of this city, and words of praise for the various committees are heard on every side.

"Well done" is peculiarly appropriate as a greeting to all who helped in this remarkably successful celebration.

Wednesday's Death Roll.

The accidents reported as a result of the celebration are not yet all in, but up to 10 o'clock this morning 33 deaths and 1057 injuries were known to have occurred.

As many of the wounds were caused by toy pistols, it is probable the death roll will be more than doubled.

Eastern Oregon Judgeship.

The presence in the city of Hon. Thomas H. Crawford, of Union county, gives an excellent opportunity for the Salem witnesses to talk politics.

Mr. Crawford says his visit to the capital has no political significance, and in fact he has two suits in the supreme court this afternoon.

Yet, it is well known that Judge Crawford is a receptive candidate, at least, for the vacancy on this bench that will occur when Judge Robert Eakin, of the district composed of Union and Wallowa counties, resigns.

Judge Eakin will take his place on the supreme bench next January, taking the position of Justice Thomas G. Halley, and the appointment for the district judgeship will be in the hands of Governor Chamberlain.

If Judge Crawford was the only candidate for this position, the work of the governor would be easy, but there are at least two other applicants.

One of them is Judge Frank B. Wilson, of Astoria, and another is Judge Ramsey of La Grande. All three of these gentlemen are excellent lawyers, good Democrats, and men who have done signal service for their party.

Two years ago when the office of district attorney was created for Union and Wallowa counties, the appointment was given to Clarence Crawford, a son of Judge Tom Crawford.

The young man filled this place with credit and ability, but was not a candidate for re-election.

It is argued by some that this will lessen Judge Tom's chances, as the governor will hesitate to give two appointments in one county to members of the same family.

People who keep their ears nearest the soil say that Judge Ramsey's chances are the best.

All this depends, for immediate action, on the remote contingency that Judge Eakin will resign at an early date.

Judge Eakin can hold on to his present job until the end of the year; but some of his friends say he may resign during the summer in order that he may settle in Salem before September, on account of being here before the opening of the schools, and for other personal and family reasons.

On the other hand, it is said that he may send in his resignation now to take effect on the 31st day of December, and thus draw his salary until the beginning of his term as chief justice of the supreme court.

Another Paper Railroad.

The Eastern Oregon Railroad and Power Company has been incorporated. The articles of incorporation were filed with the secretary of state this morning, and the incorporators are W. H. Hurd, Anthony Muir and P. J. Barnes.

It is proposed to construct a railroad from Sumpter to a point on the Columbia river between Unadilla and The Dalles, and then from Sumpter to a point on the Snake river near Huntington on the Snake river; and the Harbison line of railroad. The company has the right under the articles of incorporation to run steamboats on the Snake and Columbia rivers, connecting with the terminals of the railroad. The capital stock of the company is only placed at \$25,000.

SUPREME COURT BUSY.

Two Cases Argued Today, Both an Appeal From Union County.

Two cases are being argued by counsel before the supreme court today.

One of these is the suit of Nollie and wife against Richmond, and others, appealed from Union county.

In 1894, Nollie had a large amount of property which was incumbered with an indebtedness of \$70,000. He transferred his property to a trustee to pay his indebtedness and with an arrangement that the remainder should be divided between himself and the trustee.

The hard times of that period followed and his creditors obtained a judgment and his property was sold at low prices and there was residue from the payment of his debts.

He brought suit to recover the estate, alleging fraud and conspiracy. He lost in the circuit court of Union county and appealed to the supreme court.

Some of the lands lost by Nollie were sold for less than \$10 per acre, and are now worth \$60 or more per acre.

Crawford and Crawford, of La Grande, are counsel for W. T. Wright, a defendant; Chamberlain & Thomas represent the Ainsworth Bank and others and Leroy L. Lomax and Gustav Anderson are counsel for the appellant.

The other suit being argued today is that of G. H. Lindsey against the Grand Ronde Lumber Company, also appealed from the circuit court of Union county.

Lindsey was a logger in the employ of the Grand Ronde Lumber Company, and was injured while at work. He sued for damages and got a judgment from which the mill people appealed. The suit is for \$17,000.

Crawford and Crawford represent the appellants and Snow & McCamant of Portland are counsel for the respondents.

Council Meeting Tonight.

An adjourned meeting of the city council will be held tonight. The specific purpose of the meeting is to consider the application of the Willamette Traction Company for an amended franchise, giving it a right to lay tracks and operate a railroad through almost the entire length of the city.

At the meeting Monday night, the committee on streets, to which was referred the matter, was not ready to report. It is not known if the committee will have agreed on the proposition tonight. Judging by talk among the citizens it is likely that some concessions will be asked from the railroad company before this valuable franchise is given.

It has been suggested that the company be required to build and operate a certain part of its line by fall as one of the conditions.

To Settle State Boundaries.

Attorney-General Crawford has notified Governor Chamberlain that the attorneys representing the two states will begin taking testimony Monday, July 9th, in the boundary line suit of the state of Washington against the state of Oregon.

Mr. Crawford says the work will begin at Portland, and will then be carried to Astoria, Aberdeen, Olympia, and finally to Salem. The attorney-general asks that the governor set aside \$250 to pay for the expenses of taking this testimony.

The part of the boundary line in dispute is in the Columbia river below Astoria, the shifting of this channel at Sand Island causing the dispute.

After Jail Birds.

Harry Draper, the Spokane detective, whose bloodhounds assisted in the capture of the outlaw, Smith, near Aurora, is again on the track of three jail birds, who escaped from the Astoria county jail near Lewiston, Idaho, last evening.

The men were arrested for breaking into a number of Clatsop business houses, and were lodged in the county jail. They cut three bars of the cage, and those of the outer corridor and escaped.

Pool Balls Stolen.

Three pool balls and a white billiard ball were stolen from the Lefe Hill cigar and billiard parlors on the Fourth. The pool balls are numbered 9, 13, and 14, and a reward will be paid for their discovery.

Some young fellows deliberately took them as souvenirs, and if they can be found they will be given something else to remember the day by.

Four Thousand Dollars in Property Will Go to Four Cousins.

The estate of the late Harper Le Granor, whose death occurred in Salem last Friday and who was buried in this city Saturday afternoon, was Tuesday admitted to probate upon the petition of Charles Pfeiffer, and Mr. Pfeiffer was appointed administrator upon the request of the relatives of the deceased.

The estate is valued at \$4000, and consists of real estate and personal property. The heirs are: Mrs. Jennie F. Chapman, Salem; E. A. Thatcher, Salem; Helen T. Thrall, Portland; and Sarah T. Bell, Enterprise, all of them cousins to deceased.—Albany Herald.
