LAND FRAUD CASES

Conditions in Wisconsin That Caused the Re-Arrest of Timber Land Sharks

(Evening Telegram.)

That there are intimate business and political relations between the United States commissioners, lawyers and defendants involved in the celebrated "Wisconsin indictment" returned by the federal grand jury April 3 last, has come to be generally believed by those who have watched land-fraud developments. The act of the department of justice at the instance of United States District Attorney W. C. Bristol, in ordering the re-arrest of the eight Wisconsin defendants recently released from custody, after hearings had before Commissioners McDonald and Dillett, and the investigation that led up to it, have laid bare a state of affairs leaving little wonder that the commissioners usurped the powers of the high courts.

When Joseph and John Black and August Anderson were released by Commissioner C. F. Dillett, of Shawano, 24 hours in advance of the arrival of witnesses and evidence dispatched by District Attorney Bristol, investigation revealed the fact that Commissioner Dillett is a member of the law firm of Wallich, Dillett & Larson, who are the regularly retained counsel of the Blacks and Anderson, who are interested in the banking and lumber business at Shawano, Wis. It was also noted that Larson acted as counsel for the defendants, appearing before a commissioner's court presided over by Dillett, a member of the firm. Moreover, one of the lawyers was J. C. Thompson, of Oshkosh, who co-operated with Larson in the defense. On the face of it, there was nothing wrong about Thompson's appearance, but it looks somewhat different when Thompson is examined in his home town—Oshkosh.

Here Thompson, it has been ascertained, is a law partner of Commissioner McDonald, before whom Leander Choate, James and Benjamin Doughty, Thomas Daly and James Bray were given a preliminary hearing and released. Thompson appeared as counsel for these defendants and argued for their release before a commissioner's court presided over by McDonald, his own law partner.

Thus the same condition of community of interest is presented in this case as in the Shawano case, where Larson appeared before his own law partner on behalf of clients of the firm. It is also said that Commissioner McDonald is a young man and a close personal friend of Leander Choate, who is among the defenders released. The report also comes from Wisconsin that practically all the parties involved in these cases, including the lawyers and commissioners, are identified with the same political faction—the Spooner contingent.

When this state of facts was brought to the attention of the government, District Attorney Bristol immediately suspected collusion and lost no time in urging the department of justice to cause the rearrest of the defendants. This has been done, and it is practically certain that the next hearing will be conducted before a United States commissioner selected by Attorney General Moody.

NEVADA TO THE FRONT

Another Rich Discovery Made Thirty Miles South of Oregon Line

The Baker City Herald of July 10 says:

Two prospecting parties left Baker last evening by different routes for a point in Nevada just below Denio, and about thirty miles south of the Oregon line, where according to reports Sumpter parties have made a strike, which in richness rivals the great Tonipah district in Nevada. Two parties were started last evening by Judge Thomas C. Burke, into the new field, and yesterday at Sumpter James Howard, president of the Sumpter bank, started a crowd of prospectors to the new field. Manager Boggs of the Mayflower is said to be starting prospectors in the new region, and Manager Bain from the Cable Cove mining district is already on his way.

The strike was made in the new field by James Ellis of Sumpter, who was sent into the Nevada country just below Denio, Ore., by James Howard, president of the First National bank of that city. In going into Nevada Mr. Ellis had no idea of any particular point in which to prospect and while the Nevada country south of Denio is and has been more or less known for its mineral deposits, it was a mere chance that he started his investigations in that locality.

Letters from Mr. Ellis to Howard and other friends were exceedingly conservative in regard to prospects until recently, when he became enthusiastic, ending with a final letter received by Mr. Howard on Saturday last urging him to come at once. This letter, which was accompanied by samples of ore, stated that his discovery revealed a ledge 18 feet wide which seemingly extended through the country where it was traceable for a distance of six miles and the ore from which carried values in gold and copper, upwards of \$300 per ton.

Mr. Howard was in Baker on Saturday but great secrecy attended his visit here and nothing was given out by him at that time except to personal friends. Later the facts were ascertained and it is reliably stated that the samples of ore which Mr. Howard had with him revealed native gold in a quartz formation charged heavily with hehaleoprite.

Outfits are going out from Sumpter daily and many have already gone and others are preparing to go from Baker. The infection has also reached Pendleton and the intermediate towns and it begins to look as if the entire country had suddenly awakened to the possibilities in this new camp. In the letter which Mr. Ellis recently sent out he stated that inside of thirty days there would be 5000 people staking ground in the vicinity of his find, and it begins to look as if the prophecy would be more than fulfilled.

The exact location of this new Nevada strike is not known by anyone in Baker City, but it can be approximated by the fact that it is about thirty-two miles south and perhaps a little west of the town of Denio. It is said to be about ten miles from Quinn river crossing located on the main wagon road between Denio and Winnemucca. It is absolutely virgin country and it is said to be entirely unprospected. There is said to be much iron in evidence on the surface, and a perfect network of ledges indicate in nearly every instance the presence of copper.
