THE TRANSCIENT AND THE REAL.

Thomas Nelson Page, the southern novelist, sometimes writes admirable verse, and the current number of the Atlantic contains proof of this in two stanzas from his pen, under the title "Theocritus on Agradina." The permanence of true art in a world of false ideals and fading achievements has never been better expressed than by the Virginian writer since Keats wrote his immortal "Ode on a Grecian Urn":

Thou silent form, dost tease us out of thought As doth eternity, Cold Pastoral!

When old age shall this generation waste, Thou shalt remain, in midst of other woe Than ours, a friend to man, to whom thou say'st,

"Beauty is truth, truth beauty"—that is all

Ye know on earth, and all ye need to know.

With similar point but with a different text—the Dorian poet of Sicily, of whose life no single fact is known save what we can gather from his imperishable Idylls—Mr. Page sings in the following strong and well finished verses:

The spacious cities hummed with toll; The monarch reared his towers to the skies;

Men delved the fruitful soil And studied to be wise. Along the highway's rocky coil The mailed legions rang;

Smiling unheeded mid the mull The Poet sang.

The glittering cities long are heaps; The stately towers lie level with the plain;

The desert serpent sleeps Where sored the marble fane. The stealthy, bead-eyed lizard creeps Where gleamed the Tyrant's throne;

That grandeur dark Oblivion steeped; The song sings on.

Militiamen Are Going to Camp Tacoma.

"Willamette Camp" is once again broken up, and the tents have been folded. The militiamen who have been practicing there since Monday left this morning for Portland, and tomorrow will leave for Camp Tacoma, from whence they will be detached to American Lake, where practice will continue for the training of the ride team that will represent Oregon at the big national tournament at Sea Girt, New Jersey, August 27th. There will be more than 5000 troops at Camp Tacoma to take part in the manoeuvres that will be held there. The state of Oregon will send about 800 men, and the members of Company M, of this city, will leave tomorrow morning on train No. 14, at 5:23 a. m.

SOME SPEEDY ONES

Finest Lot of Trotters Ever Brought to Salem, Now in Training

The State Fair, beginning September 10th next, promises to be the best ever held in Oregon. Nearly all the counties have awakened to the importance of displaying their products, and there is no doubt but the exhibits of agricultural products and live stock will excel anything ever shown on the coast.

The speed program is a splendid one, the prizes being large enough to attract the best and speediest horses on the coast. Already there are between 50 and 60 horses in training, and the morning hours show some pretty speed contests in the tryouts. Among those having horses in training is the veteran, Sam Casto, known from Los Angeles to Victoria, who has a stable of 12, headed by Redskin, 2:16 1/2. Redskin is entered for the \$2,000 stake, and there will be some fast going if he does not get a place. Casto also has Mike Duff, and several other promising youngsters.

John Swayne has a stable of fine lookers, and certainly some speedy ones among them.

Sim Lindsay, another veteran horseman, of La Grande, has charge of the N. K. West stables, and, while he does not say anything, one can see that he expects some of them to come in for first money. Among them are "Commonwealth," and "Royal Salim."

Rube Kaiser, of Corvallis, has a stable of young horses, including Pilot Lord, who is entered for the big stake.

J. F. Waldron has several good ones, among them one entered in the 2:27 class.

Among those in Mr. Cox's stables are Blacksmith and Lou Miller, both entered in the big events.

S. S. Bailey, of Seattle, has Omaha, 2:10 1/2, another 2:11 1/2, both up for the big stakes.

Besides these there are Deillah, 2:08, and Zolac, her sire, with a record of 2:07.

There are many others, and those who like to see horse "go" can have a little fair of their own any morning by going out to see the speedy ones worked out. They are sent for all they are worth, and all it lacks of being a genuine racing match is the crowds in the grand stand to go wild as the horses come neck and neck under the wire. The roads are somewhat dusty, and the main road to the fairground is closed. Those desiring to go out to the grounds will go out by the tile works. There are three gates to open, but it is well worth the trouble, and well worth getting up in the early morning to see.

WILL CAMP OUT.

City of Tents Will Be the Largest in Years.

"Our city of tents at the fair grounds will be the largest in years," said Mayor-elect Albert Tozier this morning. Present indications are that most of the camping area will be entirely filled during the state fair. Already a large number of inquiries have been received from the people who come from year to year, and who desire to have the same place to pitch their tents as they had formerly. Twelve hundred people encamped under the oaks last year, and a larger number is expected this year, as the general interest taken in the fair is greater than it has ever been before.

The trees have been treated to a coat of whitewash, the underbrush has been cleared out, and everything is in readiness for the big event. Many of the campers have signified their intention to come several days ahead of the fair, so as to enjoy the pleasures of camp life to the fullest extent. Most of the campers come from Albany, Brooks, Woodburn, Independence and other surrounding neighborhoods, but the counties of Washington, Benton and Polk send large contingents. It is believed that the camp life at the fair will be well nigh ideal this year, for a new system of sewerage has been installed, and excellent provisions has been made for the water supply.

Imported Wives.

Washington, Aug. 10.—Upon the desk of Commissioner General of Immigration Sargent is evidence which added to what has heretofore come to the knowledge of the officials, indicates the existence of a scheme of the Mormon church for the upbuilding of Monmonism through the violation of the immigration laws. The evidence relates to the case of a mere child, Susan Henry, aged 11, brought to this country from Edinburgh, Scotland, through the port of Boston by a Mormon elder named Buchman, who intended to take the child and a number of women to a company him to Shelley, Idaho.

It was stated at the bureau that missionaries of the Mormon church appear to be carrying on a systematic search in the British isles, Germany and Scandinavian countries for sturdy, vigorous young girls and women, who are brought to this country through the promises of wealth, luxury and good homes, but really for the purpose of making them the wives of Mormons, so the sect will be increased in number as speedily as possible.

The actions of the child, Susan Henry, aroused the suspicions of the inspectors, and she was detained and her case investigated.
