TRANSACTION ROUTINE BUSINESS

City Fathers Held Lengthy Session Last Night and Discussed Many Matters

City council was in session a long time last night, and a considerable volume of routine business was disposed of.

Two ordinances of importance were introduced, one regulating the prices and use of water, and the other controlling the prices and service of gas and electric lights. Both the ordinances were read and referred to the committee, and will be considered at the city hall, at a meeting to which the public will be invited.

A petition was presented asking for the improvement of Court street from Commercial to Church, and the request was granted.

The manhole in the sewer at Liberty and Trade streets was ordered built to the proper height to admit of filling in the street to the required grade.

Alex. Cornoyer was granted a liquor license.

The committee on fire and water reported favorably on the fire alarm system to be installed on a month's trial. The cost will be \$946.

The report of the Emerson Milling Company showed that the cost of the work done on the Willamette river bridge is \$889.96, and that the city is to pay one-third of the amount.

An amended plan of the fill at the approaches of the bridge over Mill creek on Commercial street was adopted.

Alderman Gesner wanted the council to authorize the purchase of a book on cement bridges to go in the city library, but on motion of John Bayne it was referred to the committee on bridges.

The matter of the sidewalk on State street, along the University campus, came up. City Attorney Condit reported that the ordinance permitting the walk to be laid on the natural grade, saving the shade trees, could not be complied with. There was considerable discussion, and the matter was again referred to the street committee.

Ward No. 2—City hall.
Ward No. 3—Yankke's barn.
Ward No. 4—Low's barn.
Ward No. 5—Wade's shop, North Liberty.
Ward No. 6—Car barn, East State street.
Ward No. 7—Jory's dryer, Brush street.

Alderman Haas then submitted the two ordinances referred to, which were turned over to the proper committee, and, on motion of Mr. Gesner, it was decided that they be considered in public.

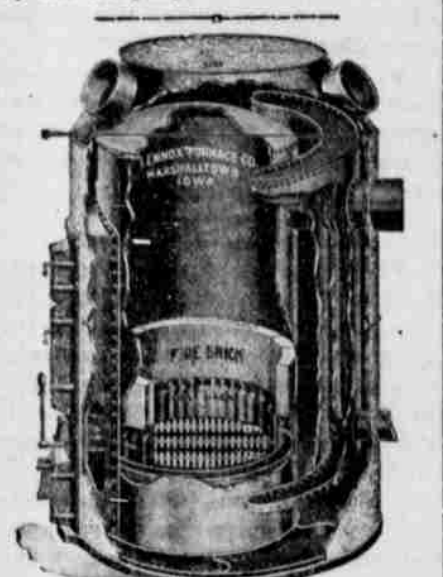
