**TURNER  
TO HAVE  
SALOON**

**Community Turns Over New  
Leaf After Years of Total  
Abstinence**

After a period of over five years in "total dryness," the pious little town of Turner has turned over a new leaf for the new year and, despite strenuous opposition, has elected to go "wet" in future, by the action of the city council, which voted to issue a saloon license by the close margin of one vote.

The last person to have conducted a saloon in Turner was Josh Lindsey, many years ago, and ever since the little community, which is about equally divided on the liquor question, has remained on the "dry" list. Mayor Henry Earl is strongly opposed to the saloon business, as is Alderman John Watson, and had the mayor been given an opportunity to cast a vote upon the question the town would still be "dry." The other three councilmen are in favor of licensing a saloon. Dr. J. W. Ransom, F. O. Knight and Irwin Robertson, but one did not vote upon the issue, and still Alderman Watson was outdone by one vote.

The church and prohibition element, headed by Rev. J. H. Fowler, was lined up strong against the license question, and made a bitter fight to overcome the wave of "open town" that suddenly struck the community, but their efforts were unavailing, as the result of the council vote shows. Numerous petitions are in for the license, but as yet, none has been issued. Only one will be granted, it is understood, under the new order of the council.

**CANNERY  
DECLARES  
DIVIDEND**

**Annual Meeting Well Attended  
By Stockholders Good  
Showing**

Tuesday afternoon the annual meeting of the Mutual Cannery association was held at the cannery building, and there was a good attendance present, including about 50 fruit growers. A new constitution was adopted reducing the number of directors from nine to three, and otherwise modifying and strengthening the form of organization. The report of the manager was read and adopted and the following named gentlemen were elected directors: Geo. W. Holcomb, S. P. Kimball and Joseph Plasher. At the close of the meeting Mr. Holcomb was called upon for some remarks, when that gentleman stated to those present that it was his idea to keep this institution in line with what its name implied, namely a mutual cannery. The interests of the management and the fruit growers were identical, and that so far as it lay within his power he should always keep it so. He expressed broad views on co-operation, and prophesied that the dividends of this concern would never be below those of similar institutions anywhere in the country. In fact this annual meeting by a unanimous vote asked the new board of directors to declare a dividend of seven per cent, which Mr. Holcomb assured them would be done. He spoke for the new board, two of whom are Salem gentlemen, the hearty support of all the fruit growers of Polk and Marion counties. He announced that they would be prepared to contract for all kinds of canning fruits, and invited all growers who had not contracted and wished to, as well as those who would like to extend their acreage of fruits, to freely confer with any of the new board, when he assured them they would receive the highest price paid anywhere in Oregon.

It is a gratifying fact to all stockholders that they can not only get their money back on their investment, but also get the neat dividend of seven per cent. This in view of the fact that many subscribers with the feeling that they would simply donate the amount of their stock, surely speaks volumes for the management of the enterprise.
