TAXATION COMMITTEE REPORTS

With the exception of a few minor amendments as to the change of dates from the first to the third Monday of March for the meeting of the county courts for the levying of the taxes all of the bills of the tax commission, house bills Nos. 85, 86, 87 and 88, by Freeman, were reported back favorably to the house by the committee on assessment and taxation this morning, and house bills 325 and 326, by Newell, repealing the poll, road poll and assessment of bank stock statutes, were also reported favorably, but house bill No. 9, providing for the assessment of a road poll tax of \$4, Rothchild's taxation of legacies, inheritances, etc., and Hackson's mortgage tax law will probably never see the light of day.

When Mr. Newell introduced the bills to repeal the poll road poll and the assessment of bank stock bills it was understood that these features were covered in the bill submitted by the tax commission, and so they were, but it developed at the meeting Wednesday afternoon that there was a predominance of sentiment against the assessment of a road poll tax, and it was decided to cut it out altogether. This was the sense of the committee, and the report today was in full accordance with this opinion, hence the road poll tax bill will probably never see the light of day again. The reason for opposing the road poll tax law was that it was not made compulsory on the part of the residents outside of road districts to pay the amount, and that it was therefore an unjust tax upon those within.

It was also decided to pocket the bill that provides that 10 per cent of the revenue received from the issuance of liquor licenses in the cities be turned into the state treasury, but, upon second thought, it is possible that this bill will be reconsidered and a favorable report decided upon. This report of the committee cleans up the work upon the tax commission bills, and the only thing that is left unsettled is the manner of making the assessment. Senator Kay, a member of the senate committee, objects to the present manner prescribed in the commission bill, and contends that it would be more equitable to apportion it between the county expenditures and valuations, upon the basis of half and half, and this matter will be left to the senate.

TEXTBOOK TRUST BILL KILLER

Davey and Campbell
Out Plan to Pack
mission

It required only a few minutes effort on the part of Speaker Dyer on the floor of the house to pack the everlasting quietus on the Beach's bill, making it impossible on the part of the governor to point two persons "actively and professionally engaged in school work" which was exploded by Mr. Dyer as a preconcentrated attempt to part of a certain ring of school principals to return to the old system composing the personnel of the mission which resulted in the scandal and corruption and, put to a vote, was lost by a vote of 18 ayes and 38 nays.

Campbell of Clackamas.

Mr. Davey was ably supported by his opposition to the bill by Campbell, of Clackamas, who stated inasmuch as no complaint had been heard from the public of the commission, he regarded the suggestion for a change with suspicion. He reiterated Mr. Davey's allusion to collusion and graft. The bill was supported by Beveridge and man, of Multnomah, and McCaleb, of Clatsop, whose principal contention were that the educators should have representation upon the commission, and the argument smacked a bit of party politics when Beveridge said the time had come when the legislature should take the bit in its teeth, and compel the Democratic governor to appoint persons properly qualified for the work. New Washington also fought the bill on the same grounds as Messrs. Dyer and Campbell.

The house adopted Senator Miller's bill, providing for the change of the time of meeting of the commission to May 1 of each year, also Senator Wheelton's bill relating to school districts, and re-referred to Miller's, of Linn and Miller's bill providing for the compulsory education of children. This bill was drafted by School Superintendent Ackerman to replace the old bill which was found ineffective, and many respects inoperative. The part of the morning's session was devoted to second reading of bills listening to the reports of committees, and house bill No. 52, relative to, by Northrup, was passed, providing for recording instruments sale of machinery.

JUVENILE COURT BILL.

The house passed Senator Miller's bill providing for the organization of juvenile courts in the several counties of the state, upon the same principle as that conducted in Multnomah county, for the treatment, control of dependent, delinquent and neglected children. The bill, which, without doubt, will become law, for Governor Chamberlain, known to be heartily in favor of the system or correcting errors in the makes it the duty of the county to sit in all cases of this character and it falls upon the district attorney to prosecute all delinquents complained of.
