Whitman College News Letter.

The railroads have granted a one and one-third open rate for all persons who wish to visit Walla Walla at the time of the tri-state inter-scholastic track meet and declamation contest on May 2 and 3. This contest on May 2 and 3. This 3, returning on May 4 or earlier. It will make it possible for a great many people in the adjoining towns to come and form a part of the immense crowd which is expected for the meet. In addition to this a special train from Spokane will be run on May 2, stopping only at Garfield, Colfax and Starbuck and the Spokane high school alone promises to bring 200 on that train. A list of places of entertainment is being carefully prepared by the committee of the Commercial club, and strangers arriving in town will be provided with comfortable places of lodging. The quarter mile track has been put in superb condition. The 200-yard straightaway has been broadened so that now ten runners can compete at once without crowding, or eight courses of hurdles can be used. It is absolutely level, and is regarded by experts as the finest running track in the northwest. Fast time ought to be made at the coming meet.

The freshmen class won the inter-class meet Saturday, and thus became possessors of the solid silver trophy cup which a friend of the college has offered as a prize to stimulate interest in track athletics. They won forty-seven points against the fourth year academy class thirty-nine and sophomores twenty-seven. Owing to the bad weather no special records were made except in the discus throwing, won by Philbrook '11, with a throw of 112 feet 8 inches.

The spring meeting of the choral union will take place on May 22, singing Gounod's "Redemption," with a chorus of 200 voices. Professor Jackson has been very successful in building up the union as also in developing the vocal department of the conservatory of music. The glee club ended its season with a fine home concert and \$200 profits.

A valuable collection of fine photographs has just been received from Prof. Louis F. Anderson in Athens, Greece, where he has spent several months of his year's leave of absence. They will be mounted and exhibited permanently. The college chapel has also been improved by the recent hanging of some fine steel engravings of Washington, Hamilton, Jefferson, Marshall and Lincoln.

Wages No Object if Principle of Saving is Ignored

One evening last week coming out of the Hotel Oregon, Miss Riverias asked to be introduced to Henry Hewitt. She begged Mr. Hewitt to tell her how she could become a millionaire.

Miss Riverias is a stenographer who came here from Portland to make her home. She has some money and has invested in ten acres on the west side which will be valuable town property.

Mr. Hewitt in reply to her question said, "Have good counsel always, and make no bad bargains. Then make it a rule to save a half or two-thirds of your income, and do this die dog or eat a hatchet. You are sure in time to be a millionaire."

Mr. Hewitt is a plain blunt man. His fortune has been accumulated by the exercise of good horse sense.

He points out the plain road for all those who wish to become rich. Too many people are waiting like Micawber for something to turn up, for their ship to come in or a rich uncle to die. They do not rely upon their own efforts.

The principal of saving is a sure and fast road to wealth. No matter how small a man's salary may be if he begins to save a little he has laid the foundation of fortune.

Many a hard working man ignores this principle of saving when it is only a dime to be laid aside. You may look about you in the mills and note that the man who gets \$5 a day is just as poor as the man who earns but \$2. The man with the higher wages has no more wants than his less remunerated brother, but he has not learned to economize, to save.

The man with a hoe is a man with the hoe because he isn't capable of doing anything else. He has not yet learned to exercise his brain. There is a sure ladder for any man out of the depths if he is willing to climb. Many an imposed upon hard worker has been led to believe that the only way to relieve his condition is some new fad in legislation like socialism.

The man who has not learned to save would not be benefitted with a wage of \$10,000 a year. That is, he would be as poor at the end of the year as his neighbor who works for a dollar a day.

Moreover this man who has not learned to save even at the close of his allotted three score years and ten is crowding away the newer generation of laborers. The man who does not save and remains down in the depths is the working man's greatest foe.

It is a wise provision of nature to keep the man down, the man with the hoe, who has not learned to save, the man who dissipates a month's earnings in one night's carouse. Nature does all things well.

Mr. Hewitt might have added one other precept to his excellent formula and that is to have steady employment. Thousands of ill advised creatures will remain idle six days in a week if on the seventh they can obtain a double wage. The strike that compels men to remain out of employment for months and months is always a bad policy for the laborer. This is why so many working men prefer not to join the unions. A strike is not the way to settle labor problems.—Coos Bay Harbor.
