HAYWOOD ILL FROM SMOKING

ATTACK OF HEART FAILURE

Doctors Worked On Him Several Hours and Gave Him Morphine

Salem, June 1.—Haywood's illness this morning caused the postponement of the trial until this afternoon. He passed a restless night suffering from an attack of heart trouble, caused by excessive smoking. This morning he was seized with an attack of neuralgia, caused by toxic poisoning, and suffered such pain that he was unable to stand. Doctors were called hurriedly, and worked over several hours, being compelled to administer a heavy dose of morphine to allay the pain. The court lawyers for the defense announced that if Haywood was not able to appear this afternoon the trial will go over until Monday. Haywood's condition, according to the doctor, is due entirely to lack of exercise.

TROUBLES IN CHINA INCREASING

MANY FLOCK TO REBEL STANDARD

Rebels Attack Officials Only, and Foreigners Are Not Disturbed

Washington, June 1.—Hong Kong advices estimate that 50,000 armed rebels are in the revolt. More are joining the standard of the rebellion daily. There was an outbreak recently 40 miles from Nanning, but only officials were attacked. This is a feature of all the disturbances so far reported, and the government believes foreigners are unlikely to be attacked. All precautions are being taken, however. Consul Paddock, at Amoy, has been directed to keep the department of state fully advised, and to call upon Admiral Dayton if aid is needed. It is reported that 30,000 rebels are operating south of Amoy.

Amoy, China, June 1.—Rebel and imperial troops clashed today between here and Swatow, and there were several hundred casualties, mostly among the rebels, who retreated.

FIRED THE BREWERY UNIONS

FOUR HUNDRED LOCALS CUT OUT

But the Red Thirst Quencher Will Be Brewed Just the Same

Washington, June 1.—The Brewery Workers' Union, comprising 400 locals, was expelled today from the American Federation by the order of Gompers. This is in accord with the dispatch from Chicago yesterday, which said:

"The last barrel of 'union beer' in Chicago and the whole country, according to an edict of the American Federation of Labor, will be manufactured today. At midnight the Brewery Workers' Union will cease to exist in the eyes of the national labor leaders, and the 2,000,000 organized workmen in the United States will be asked to 'get on the water wagon,' or use some other kind of beverage. The brewery employees have rebelled against President Gompers and the national executive council, and they are to be disciplined. The method adopted is that of expulsion."

"The trouble has been growing for several years. Two months ago the national labor council met in Washington and gave the Brewery Workers' Union until June 1 to comply with an order to oust all engineers, firemen and teamsters from its organization. These men were under the protection of the Brewery Men's Union, who took a vote, and 98 per cent of the membership favored resistance to the order, which brought about the present situation. Secretary Kemper, of the local union, said that 3000 brewery workers in Chicago will go on brewing beer whether the American Federation of Labor regards it officially as a 'union' product or not."

TURN SOD FOR GREAT EXPOSITION

SEATTLE CELEBRATES THE EVENT

Alaska-Yukon-Pacific Fair the Coast's Next Attraction

Seattle, June 1.—Amid the blare of many bands, the cheer of many thousands of spectators, and the waving of hundreds of American flags, the first sod of the ground of the Alaska-Yukon-Pacific Exposition of 1909, was turned today by its president, John Edward Chilberg.

The day was observed as a general holiday in Seattle. For the ceremony thousands of visitors had come to the city, from all parts of the state. Hon. John Barrett, appointed by President Theodore Roosevelt as his personal representative for the occasion, was the principal speaker. Mr. Barrett, who is universally known as President of the International Bureau of American Republics, was in an especially representative position to speak for the entire continent, and his remarks were listened to by the vast crowd on the grounds and cheered to the echo.

Besides the formal exercises on the grounds there was a splendid parade in the morning through the main portion of the city. Mr. Barrett is the guest of the Exposition and will be entertained extensively during his stay in Seattle.

In addition to the great crowds present, many prominent men were in attendance by special invitation. The governors of nearby states, and mayors of the principal coast cities, and various other officials outside of Seattle were invited, and helped to make the day the success it was.

The big military parade started at noon and after traversing the main streets entered the Union depot where special trains took the official party and the troops to the grounds, where the exercises were held in the large natural amphitheatre.

John Barrett in his address pointed out what a great future the Pacific West had in store and what the exposition would do toward developing this section of the country. Mr. Barrett also explained how the exposition will increase commerce on the Pacific ocean between the Orient and the United States and between the countries of North and South America.

Others who made addresses are as follows: Gov. Albert E. Mead, of Washington; Mayor Wm. H. Moore, of Seattle; President J. E. Chilberg, of the exposition; W. A. Williams, representing Gov. Chamberlain, of Oregon; John P. Hartman, Board of Regents Washington University; Henry A. McLean, Washington State Commission; I. A. Nadeau, director general of the exposition, was master of the ceremonies.

GRAFTERS BEFORE THE COURT

CALHOUN DEMANDS TRANSCRIPT

Wants to Know What Evidence Prosecution Has Before He Pleads

San Francisco, June 1.—Abe Ruef, Patrick Calhoun, Mayor Schmitz and Louis Glass appeared in court today for arraignment on indictments charging them with bribing supervisors, the first trio in the overhead trolley case, and Glass in the Pacific telephone case. Glass made a motion to dismiss the indictment on the ground of insufficiency of the evidence. The hearing of the motion was postponed until Monday. Calhoun insisted upon being supplied with a transcript of the evidence taken before the grand jury before being arraigned. Schmitz made a similar claim. The cases were postponed until Thursday. Ruef asked for postponement of his trial until one day after that of Schmitz and Calhoun, and his request was granted.

A Glorious Fourth.

There was an enthusiastic Fourth of July meeting last night, at which time \$500 was appropriated for music. Mayor Rodgers reported that the Salem band had been secured and that arrangements were being made to engage the Victor Point, Chemawa, Reform School and the Summit bands. The oration of the day will be delivered by Senator Mulkey, of Ashland, who is recognized as one of the most eloquent speakers in Oregon. The method and arrangements for choosing the Goddess of Liberty have not been reported by the committee that has charge of the work, but probably action will be taken on that business at the next meeting.
