Washington, June 5.—The President, Bonaparte and Kellogg held a conference today about Harriman. The President desires to prosecute the Harriman combine, and Harriman personally, if such action is feasible. There is a difference of opinion among the President's advisers in regard to its feasibility. No formal announcement followed the conference.

EARTHQUAKE SOME PLACE.

Tells on Itself at the Government Weather Bureau.

Washington, June 5.—The weather bureau gives out a bulletin that a "distant earthquake of relatively small intensity was recorded last night by the seismograph, beginning about 10:29 and lasting nearly an hour. A relatively stronger motion was recorded between 10:37 and 10:50, being distinctly greater in an east and west direction. The maximum amount of motion was very small, only about two-tenths of a millimeter. The disturbance was probably two or three thousand miles distant, and probably south of Washington."

"Next Friends" Win.

Concord, N. H., June 5.—Judge Chamberlain today denied the motion of the trustees recently appointed to take charge of Mrs. Eddy's property for leave to be substituted as plaintiffs instead of "next friends," who began litigation to secure an accounting for the property.

TRIAL OF MAYOR BEGINS

Ex-Supervisor Tells Jury of the Deals Framed Up By Schmitz to Hold Up and Levy Tribute On the French Restaurants

San Francisco, June 5.—The actual trial of Schmitz on the charge of extorting money from French restaurants began this morning, when, after Heney made the opening address, in which he lashed Schmitz without mercy, ex-Police Commissioner Reagan took the stand and told of the deals framed up by the mayor and the orders given the police commission by which these deals were carried through. Reagan told of the mayor ordering him to go after the French restaurants, and of how the licenses were held up. He testified that the mayor in the fall of 1904, three years after his election, found the French restaurants immoral, and decided that they should be closed up. Reagan investigated them and reported to the mayor. He didn't know of the mayor's purpose at the time. When the licenses came up for renewal they were held up.

MODEST LITTLE QUAKE

San Francisco, June 5.—An earthquake of easy, undulating movement and of several seconds duration occurred at 12:40 this morning. It was felt by many other California cities, but no damage is reported anywhere.

Blew Up the Ship.

Paris, June 5.—A dispatch from Tunis says a coaster, with 70 men aboard, carrying contraband arms and ammunition, was blown up by the crew today, off Tunis, to escape capture.

Sheridan Man Missing.

A dispatch from Venice, Cal., Tuesday, says: Benjamin Stillman, who recently came from Sheridan, Or., on a visit, is missing from his son's home in Los Angeles. Foul play is suspected, as the home was found in disorder and \$400 missing. Stillman was aged 71.

Another dispatch from Sheridan adds this information: "Benjamin H. Stillman and Son, William Stillman, left their mountain ranch on Salmon river, 20 miles west of here, about a week ago. Their destination was Los Angeles. They disposed of their ranch and stock before leaving. Both were considered very eccentric."

Grant 3 Per Cent Advance.

Dover, N. H., June 5.—The cotton manufacturers of this district, including the Cochro Manufacturing Co. of this city, the Great Falls Manufacturing Co. of Somersworth, and the Salmon Falls Manufacturing Co., employing respectively 2200, 2000 and 700 hands, have announced a five per cent increase in wages to go into effect this month.

At the same time the working schedule will be reduced from 60 to 58 hours per week, in accordance with the law enacted at the recent session of the New Hampshire legislature. This is the second five per cent increase in wages since Christmas.

Want President Appointed.

Boston, June 5.—Friends of the Mass Institute of Technology are disappointed because no president is yet chosen. They say Wheeler is still considering the offer, which is still open for him, according to the trustees.

CROKER WINS THE DERBY

Epsom Downs, Eng., June 5.—Orby, Richard Croker's entry, with J. Reiff, American, up, won the derby today. This is the third time in the history of this event that an American has won.

Orby came home two lengths ahead and won from eight of the best horses in the world. Hundreds of Americans who bet on Orby from patriotic motives, made a great killing. Orby figuring only as a nine to one shot. The king was among the enormous throng of spectators. There was a heavy track on account of the morning rains, and this aided Orby.

FOUND BODY IN A WELL

Minneapolis, June 5.—The body of Mrs. Catherine McCart, who disappeared May 21st, was found today in an abandoned well on the farm of her brother-in-law, George Katsbach. Her head had been crushed by a blunt instrument. Officers surrounded the house, which Katsbach has barricaded and is inside. At the time of her disappearance he said the woman left his house for a neighboring farm.

A later report says Katsbach has eluded the posse, and is on a west-bound train.

Minneapolis, June 5.—Katsbach's body was found in the woods near his farm this afternoon. It is supposed he committed suicide.

A Peculiar Accident.

Birmingham, Ala., June 5.—Three men were probably fatally hurt by a train carrying pots of molten metal, which collided with a street car. The metal covered the motorman and two passengers, and ignited the car, which was entirely consumed.

Watching the Packers.

Washington, June 5.—The President's attention has been called to the raising of the price of meats, and he is likely to start an investigation by the department of justice, to ascertain if the raise is the result of natural processes or caused by collusion on the part of the packers.

the most serious of accusations against her husband, his devoted wife was one of the first to enter the court room where the Haywood murder trial is progressing. At the fall she talked an hour with Haywood before he was ushered up stairs. The sheriff has detailed additional guards to the aisles. He does not intend to take any chances of Orchard's safety when he testifies. Taking the testimony began at once. J. M. Burnell, the Nampa hotel proprietor, testified that Orchard and Simpkins registered at his hotel late in 1905. Orchard registered as Hogan, and Simpkins registered under his own name. Guy Feight told of seeing Orchard and Simpkins in Caldwell in November, and identified his photograph. Anton Hinkley, another Nampa hotel man, and John Connors, of the Silver City hotel, gave important testimony. C. H. Wentz, a Wallace mining man, and former friend of Simpkins, who declared he taught Simpkins to write, identified his signature on the register as that of Simpkins. He also identified his photograph.

Orchard was the next witness. He seemed well although somewhat nervous. He crossed the room close enough to Haywood so the latter could have touched him, had he so desired, but the defendant paid no attention to the informer. Orchard's first few statements were made in such a low tone that he could hardly be heard, but he gained confidence as he went on, and soon was speaking clearly and distinctly. He said he was born in Northumber-

land county, Ontario, Canada, in 1866. His true name is Albert Horeley. He came to Idaho in 1896, and went to work as a mucker in a mine near Burke, in March, 1899. He worked a month, and joined the Western Federation there. on the Mullan union, and then went on to Wardner.

The three unions lined up and marched to the Bunker Hill mine. When within 100 yards the shooting began, but it was a mistake, being between union men, as there were no non union men in the mill. The powder was taken into the mill. Orchard lighted the fuse, and the mill was destroyed. After the mill was blown up they went back home. One man named Smith was killed, though another one was killed as the result of the mistaken fight. Five days later federal troops arrived, being called by Stouenbergh. Orchard left town fearing arrest. He drifted about Montana, Utah, Arizona and California, arriving at Cripple Creek, Colorado in 1905. He worked in the Vindicator mine, and stayed there until August, 1905. He quit because a general strike was declared which lasted as long as he stayed. Moyer was president and Haywood secretary of the federation at that time. The strike at Cripple creek was in charge of W. F. Davis, who led the attack on the Wardner mill. He said S. Davis offered him \$200 if he would blow up the Vindicator tunnel. He got a man by the name of Joe Scholls to go with him, the plan being to blow up the non-union workers, but they were discovered and forced to retreat. In November Davis asked him to set a bomb in the Vindicator, so that when the men were going to work it would explode. He couldn't plant it. He was promised \$500 by Davis if he would
