CANDIDATES FOR SCHOOL DIRECTOR

Two Young Men Have Been Brought Out For the Places

Next Monday is the date for the annual school election, at which time two directors are to be elected in this district, one to succeed Dr. W. H. Byrd (Democrat) whose term expires, and one to fill the vacancy caused by the removal of Hamlin Smith (Republican) to Vancouver. The latter was a South Salem man, and was elected as a representative of that section. It is now understood that the people of that section have agreed upon Mr. W. P. Babcock to represent them. A petition has been generally signed by South Salem voters, asking him to be a candidate, and it is learned from School Clerk Johnson that Mr. Babcock has filed his acceptance. It is also learned that a petition has been circulated for Frank Holmes, the attorney, and that he has consented to be a candidate.

FATHER ANSELM IS DEAD.

Widely-Known and Deeply-Learned Priest Passes Away.

Rev. Father Anselm, O. S. B., of Sacred Heart church, of Portland, one of the best-known Catholic priests of the Pacific Northwest, died suddenly at the Sacred Heart parish house, 832 Milwaukee street, last night of heart disease. He had been ailing for a few days, but was not considered by his physicians to be in a serious condition. Father Anselm was 50 years of age, and was born in Wurtemberg, Germany. He was ordained in Engelberg, Switzerland, 25 years ago. In 1880 he came to Oregon, where he labored in the educational and mission field.

Father Anselm is said to have been one of the most learned men on the North Pacific coast. For a number of years he was professor of Hebrew, Greek history and moral theology at Mount Angel college. He spoke Syriac and a number of modern languages fluently. Nevertheless his manner was that of a simple and trusting child. No man could have been more modest of his learning.

The funeral will be held from Sacred Heart church, Milwaukee and Kaywood streets, tomorrow at 9 o'clock. Archbishop Christie will officiate, assisted by Rev. J. H. Black, deacon; Rev. Joseph Gallagher, sub-deacon; Right Reverend James Raun, assistant priest; Rev. P. De-Rov and Rev. Joseph Buchholzer, deacon, and Rev. George Thompson, master of ceremonies. Many others of the clergy in the city and state will be present. Interment will be made in Mount Angel cemetery, Saturday morning at 10 o'clock.

Iron Workers' Strike Settled.

San Francisco, June 13.—The iron workers' strike was settled this morning, and the men will go to work Monday. Seven thousand are affected.

Circuit Court Business.

The following business has been transacted in the circuit court by Judge Galloway:

The demurrer to the complaint in the case of Oscar W. T. Muehlaupt vs. The German Evangelical Reformed Bethany Church, of Salem, Oregon, et al., was overruled, and the defendant given ten days to answer. The testimony in the divorce proceedings of Lee Peterson vs. Rhoda Peterson was yesterday taken in part and continued.

The hearing in the injunction suit which was filed June 12 by Stevens, of Multnomah county, has been set for Friday, June 21st.

The U. of O. mandamus proceedings will be argued Monday, June 24. The armory bill case will probably be taken up on the 21st or 22d.

In the matter of the guardianship of Elizabeth Herren a motion to dismiss action was made by Attorney Condit and Attorney Kaiser, by consent, was given until the 22d in which to amend complaint or file counter motion.

Growing Use of Gas Engines.

The Allis-Chalmers company has received from the United States steel corporation, the steel trust, an order for the largest number and the largest type of gas engines ever placed with one concern in the history of the engine building business.

The orders thus far booked call for thirty-six engines, aggregating 144,000 horse power, and weighing 1,500,000 pounds each.

The great bulk and weight of these engines may be gathered from the fact that a total of 2300 freight cars will be required to transport them to the various plants of the steel trust. The contract calls for the delivery of the engines as follows: Twenty-five engines will be installed in the mammoth new plant now being built at Gary, Ind.; seven will go to the famous Homestead, Pa., plant, and four will be shipped to the Illinois Steel Company at South Chicago.

The United States Steel Corporation has discovered a process whereby the gas from its blast furnaces, which now goes to waste, may be used as power for its engines.

The adoption of the gas engine by the steel trust opens up another field for this comparatively new engine. During the past year the Allis-Chalmers Company has supplied many large users of power with gas engines of high capacity, and in some instances, as in the case of the Milwaukee-Northern Railway, their engines have invaded fields hitherto closed to them.—Milwaukee Free Press.

Earthquake in Jamaica.

Kingston, Jamaica, June 13.—A severe earthquake early this morning shook the city. Hundreds left their beds in a panic.

Servants Will Win.

The servant girl problem has been solved in New Zealand a report says: This is how they did it: The domestic servants got together and organized a union and formulated a list of demands and regulations affecting pay, hours, holidays, afternoons out, intervals for meals, rest, horses or automobiles to church, and so on. The leaders sent these to the mistresses, inviting them to sign the contract and "obviate the unpleasantness of having to appear, personally or by agent before the conciliation board, or arbitration court." The mistresses are resenting the demands, but everyone knows there will be peace. The government does not allow strikes. Whatever the judgment of the arbitration court may be, housewives and maids must accept it or be marched off to jail.

Was held 18 days in Caldwell and then brought to Boise. After three weeks' confinement McParland came. Never met him before, and never had any business arrangements with him. Remained alone with McParland an hour. McParland told him about his experiences with the Molly Maguires. First, however, he desired to discuss the Bible with him. He denied McParland had talked about the Western Federation, but later stated he might have said something about it; that the detective knew he, Orchard, did the killing, and was not alone in the job. McParland referred to the Bible story of the killing of Uriah by order of King David, and the order to steal the former's wife. McParland then told him the story of "Kelly, the Bum," and how he, after he gave his evidence in the Molly Maguire case, was given \$800 to leave the country. McParland also mentioned a number of other persons who had turned state's evidence, and finally told him that all the states were fair with their best witnesses.

Orchard became angered at Richardson's apparent attempt to show that McParland was willing to do anything to secure the conviction of Haywood. He said: "McParland stopped all crimes after he got there. Witness didn't know this prior to McParland going into the anthracite district only three murders had been committed, but while he was there 23 were committed."

He began his confession to McParland on the third visit of the latter. This was late in January. He spent the entire forenoon in telling his story. He knew from McParland that the Pinkerton agency wanted the officers of the federation for the crimes he had committed. He declared that at that time he felt badly, and contemplated suicide, but was afraid to die until he had made a clean breast of everything. He said that later he intended to kill himself with the crystal of his watch, but didn't. He insisted that his confession was a duty to himself, society and God. He said he was a Mason, and admitted that he knew Peabody, Goddard, Bell and others he intended to kill were Masons.
