CONSPIRE TO HANG HAYWOOD

Government Accused of Packing the Convention

STIR UP PRETTY SCANDAL

BOGUS DELEGATES

Garfield Denies the Administration Wants to Pack the Convention But Delegates Think the Presence of the Land Office Is Suspicious

Denver, Colo., June 19.—The land convention this morning developed a scandal that threatens the convention with an open fight, with the probable ousting of the Roosevelt sympathizers. As the organized convention is controlled by anti-administration men. Through them Secretary Johnson, of Denver, charges the convention was packed this morning with bogus delegates by Mark Woodruff, superintendent of the forest reserves of Colorado. Wood, who is on the credentials committee, is charged with giving tickets to men not delegates, and administrationites. A counter charge

is made that an attempt was made to pack the convention, claiming that the Colorado and Wyoming delegates were determined to control, and to criticize the President at all hazards. Wyoming is specially bitter against the Roosevelt policies. The first clash came when the Texas cattlemen and Roosevelt sympathizers demanded representation, and the convention refused to seat them. Garfield made a speech, saying the government was not desirous of packing the convention.

Frank Mondell, of Wyoming, this morning addressed the land convention. He said: "The bulk of the known coal lands in this country are still withdrawn from entry under the coal land laws. The West is facing probably a serious coal famine next winter, because it is impossible to acquire government land for the new mines. In most of the coal fields of the Western states and territories where the population is increasing, when the provisions of the railroad rate bill prohibiting the roads engaging in commercial coal operations are put in practice, the source of their past supplies of coal will soon be exhausted."

A Fool Suggestion Vetoed.

Washington, June 19.—The administration has vetoed the suggestion to send an entire battleship squadron to the Pacific coast as a precautionary measure on account of the Japanese trouble. No additional troops to the Pacific naval forces will be made.

DARROW MAKES CHARGES

IT IS A CONSPIRACY

Says Borah, Hawley and the Pinkertons Would Hang Haywood Guilty Or Innocent, and Have Conspired to Accomplish That Result

Boise, June 19.—The state will probably complete its case against Haywood tonight. Darrow will then open for the defense. He said today he would consume three hours with his recital, indicating how the defense will refute Orchard's story. Darrow will make a flat charge of conspiracy on the part of Governor Gooding, Hawley, Borah, McPartland, and declare they are willing to go to any length to get the accused hanged. Ed. Bryce, first president of the Miners' Federation, identified certain issues of the Miners' Magazine in his story, and the initial number setting forth the plans of that magazine. The prosecution then set about getting before the jury the Miners' Magazine, in order to show that it advocated the assassination of certain Colorado officials and mine owners. The defense objected to such evidence, declaring it incompetent and not binding upon Haywood. A lengthy argument followed. Richardson claimed the articles in the magazine were simply ordinary newspaper abuse, and as such were not competent.

Richardson quoted at length from the decision in the Chicago anarchist case known as the "Spies case," in support of his position. He read the most inflammatory articles used in the Spies case, showing they named the time, place and method of killing the police, and argued this was not parallel with the articles in the Miners' Magazine, which simply condemn the course of officials and mine owners. The arguments consumed nearly two hours. The court announced he would examine the exhibits personally before deciding. Court then adjourned until 2 o'clock when it may decide, but stated that the matter was too important to be quickly disposed of, and further time might be needed.

ORCHARD IN ALASKA.

His Confession Evidently Far From Complete.

Juneau, Alaska, June 19.—It is believed here that Orchard spent several months in Juneau in 1904, and attempted to assassinate Joseph MacDonald, superintendent of the Treadwell mines. MacDonald was marked for death while connected with the Bunker Hill and Sullivan mines in Idaho. One shot was fired through a bathroom window at his Treadwell residence. Another attempt was made while he was driving up the Silver Bow Basin. MacDonald shot and killed one assailant at the Treadwell. His detectives claim to have spotted Orchard and forced him to leave Alaska. Many recognize the picture of Orchard. It is thought Orchard followed Bradley here on his annual trip to inspect the Treadwell mines.

Train Wrecked and Burned.

Salinas, Cal., June 19.—A Southern Pacific freight train, northbound, was wrecked at Santa Margarita last night, near the bottom of the Cuesta grade. After being derailed the cars took fire and eight were consumed.

SAVED BABY'S LIFE.

Sister Caught Her "Just Like a Basket Ball."

Chicago, June 19.—Falling from a fourth floor porch, 2-year-old Vera Moese escaped uninjured Monday because her 8-year-old sister Gladys at the risk of her own life, rushed beneath the falling child and caught her in her arms.

"I caught her just like a basket-ball," Gladys explained after she had picked herself up unhurt from the ground on which she and the rescued baby had rolled.

Gladys' attention was attracted by the scream of a woman who lives in the third flat. She was on her back porch, and saw the child fall from the top of the railing, 50 feet to the back yard, where Gladys was playing. Mrs. Moese also saw her child topple off. Supposing it meant instant death, she started to go down stairs. On the way she swooned and fell headlong down one flight, suffering slight bruises and a severe nervous shock. She is under a physician's care.

OBJECT TO CONTRACT SYSTEM

Denver, June 19.—The Federation of Miners this morning discussed the resolution preventing contracts with employers. The radical element is in favor of a change in the constitution forbidding future binding agreements with mine owners. The five-year contract with the Butte miners started the discussion which may change the entire policy of the union. It is claimed the contract is only of advantage to the employers.

Died on Way to Reunion.

Forest Grove, Or., June 19.—On his way to attend the reunion of Indian War Veterans and pioneers at Portland, George W. Olds, pioneer of 1852, and a veteran of the Indian war of 1855, died on the train between Gaston and Forest Grove yesterday morning from heart trouble, due to senility. The remains were taken back to McMinnville.

Mr. Olds was a prominent Yamhill county farmer, 76 years old. He was born in Michigan and joined the great trans-continental movement of 55 years ago, which numbered in its ranks so many hundred early settlers. Mrs. Olds is a pioneer of about the same period, and was with him on the train.

Mr. Olds leaves one daughter, Mrs. James Durham, a resident of Portland.

Telegraphers Decide to Strike.

Chicago, June 19.—The New York general executive board of the telegraphers' union has decided on a strike. The matter is now in the hands of President Small. The decision to strike was announced in a statement made by Acting President Koenekamp, of the union. He says the strike is approved against either or both the Western Union and Postal, and said that plans for the campaign have been made, and the men are ready for the struggle."

Lumber Schooner Ashore.

San Francisco, June 19.—The five-masted schooner, Lewis, out of Grays harbor, lumber laden, is ashore on the Farallon Islands. Captain Dwyer, of Portland, Oregon, is in command. She lost her bearings in a dense fog, and was beached at 2:30 this morning. No loss of life is reported.

Riots in Portugal.

Lisbon, June 19.—Street rioting here today resulted in two deaths and several injured. The outburst is against King Carlos, who is attempting to rule the country without a parliament. Troops have been called out.

READY TO BEGIN STRIKE

MAY START TODAY

Telegraphers Demand More Pay and Shorter Hours, and Their Demands Are Refused by Both the Postal and Western Union

Oakland, Cal., June 19.—W. W. McCandlish, president of local 16 of the Commercial Telegraphers Union of America says:

Matters have reached a climax in the strike situation and the prospects of a walkout seems inevitable, in view of the stand taken by the Postal and Western Union companies that they will not entertain our demands for increased pay and shorter hours. Our plans have been completed, and it is but a question of hours when the fight for recognition of the union and a betterment of working conditions and increases will be on.

A small force will remain on duty in the East to manage the strike there. Secretary Russell will handle it at Chicago. It is reported the strike will start in this city and spread to the larger cities, leaving the small cities free to conduct their business.

ISSUES BONDS TO DECEIVE

New York, June 19.—All of Wall street was puzzled today over the 200 per cent dividend declared by the Adams Express Company in the form of an issue of \$24,000,000 40-year four per cent bonds. Conservative interests in the financial district were at a loss to explain why a bond issue imposing fixed charges for the next 40 years was created to distribute an unexpected dividend.

One reason why the 200 per cent dividend was declared at this time was that under the Hepburn rate law the Adams Express Company for the first time in its history would be forced to make a statement of its affairs. Up to the present time none of the express companies have ever published a statement of earnings, liabilities or assets. In fact there is only one copy of the Adams Express Company's charter, and that is kept locked up in a safe. When the shares were listed on the stock exchange it was not customary to demand a copy of the charter, together with statements of earnings, assets, liabilities, mortgages, etc.

According to the recently passed rate law, express companies, as well as sleeping car companies, are declared "common carriers" and all common carriers were directed by the law to report on June 30 of each year in detail. For the first time, therefore, the Adams Express Company will have to tell the amount of capital stock, surplus fund, if any, and the number of stockholders; the funded floating debts; cost and value of carriers' property, franchises, equipment, and details of balance of profit and loss.

These detailed reports must contain all the required statistics for the preceding 12 months and must be made under oath and turned over to the interstate commerce commission not later than September 20.

Not Jack Simpkins.

Fort Collins, Colo., June 19.—The coroner today failed to identify the suicide on the Baldwin ranch as Jack Simpkins, connected with the Haywood case.

Gunboat Sinks.

London, June 19.—A British torpedo boat sunk off Day Head this afternoon, after an explosion. The crew were rescued.

FRANCE FACES TROUBLE

Narbonne, France, June 19.—An attempt was made last night to arrest M. Marcel Albert, leader of the winegrowers' movement, and M. Ferroul, ex-mayor of Narbonne. The situation is full of menace. Practically the whole population is disturbed, and the wildest excitement prevails. At 9:30 o'clock the town rang and the mob made for the Palace de la Hotel de Ville, seized from girders from houses under erection and erected barricades in preparation for cavalry charges. Elaborate arrangements of signals were made to summon the whole countryside to the town. Mr. Albert's house was surrounded by a large bodyguard. The slightest untoward incident is likely to precipitate fighting and the sacking of the government buildings.

Paris, June 19.—M. Farouie, the head grower, was arrested by 10,000 soldiers. The growers are planning to give battle. The army seized the city of Narbonne. Bloodshed is expected.

SWARM LIKE BEES

The great relay race for bargains is on at the Meyers store today. When the doors opened this morning 500 fair faces greeted the salesmen who were in waiting; but not more than one-fourth of the throng could be accommodated on the inside, hence the management arranged to have the shoppers enter in squads.
