

MOYER ON WITNESS STAND

A Hundred Workmen Buried in Wrecked Building

YELLOW JOURNALS WARLIKE INVENT THEIR NEWS

Japan Guiltless of the Daily Charges Made Against Her—Matter Would Soon Die Out If Sensational News-Mongers Would Quit Lying

Washington, July 10.—The Japanese embassy authorizes a denial of the report from The Hague that Japan had notified the United States that if it could not control the situation in San Francisco, the Japanese government would feel at liberty to deal with California direct.

Sakamoto Did Not Say It.
Tokyo, July 10.—The interview with Admiral Sakamoto, in which he said the American naval officers were deficient in professional training and practice, but brilliant as social figures will be withdrawn by Heichi tomorrow. In the same issue Heichi

will print an unsigned interview with a Japanese naval expert, praising the efficiency of the American navy and its gunnery. It is officially denied that Aoki will return home.

New York, July 10.—Admiral Yamamoto, minister of marine, during the Russia-Japanese war, and one of Japan's best fighters, arrived here today. He told the reporters he wanted peace. His visit has no significance as to war talk. He planned the trip months ago. He said if the newspapers knew the real conditions in Japan they would not print such exaggerated stories. He will be the guest of President Roosevelt Friday.

Drowned in Rogue River.

Medford, Or., July 10.—Frederick Barneburg, a pioneer of southern Oregon, was drowned in Rogue river, while engaged in fishing for trout, yesterday morning at 10 o'clock, at Roe Island, immediately above the Bybee bridge. The remains were recovered about noon, nearly a half mile further down stream. Mr. Barneburg was among the most enthusiastic fishermen here and drove out alone in his buggy early this morning, as was his custom, and it was only by accident any one saw his mishap and was able to give the alarm and recover the body.

LABOR LEADER TESTIFIES IS A GOOD WITNESS

Answers Comprehensively and Without Hesitation All Questions Concerning the Federation and His Own Actions and Movements Since He Joined the Federation

Boise, July 10.—The opening hour was consumed in reading depositions. Two minor witnesses were put on the stand and then Moyer was called. The news that Moyer was on the stand spread quickly, and the court room rapidly filled. In 1897 Moyer said he joined the federation, served as president of the Lead, S. D., local union; was elected a member of the executive board of the federation in 1899, and served until June, 1902, when he was chosen president, succeeding Ed. Boyce. He met Haywood in 1900, and had known him intimately ever since. Moyer is a good witness and answers comprehensively without hesitation. He identified the constitution of the federation which was offered in evidence. He detailed at length the duties of the various officials of the federation, and explained that under the by-laws he was compelled to travel a great deal, and was absent, up to the time of his arrest, probably 50 per cent of the time from headquarters. He explained that strike orders were called by a vote of two-thirds of the local unions, approved for the executive committees. It was the rule of the organization to protect its members whenever arrests were made in connection with trouble growing out of strikes. The executive board, after he was elected president, adopted a resolution that legal aid would be furnished members of the federation arrested at any time. At the time he was arrested Jack Simpkins was a member of the executive board for the states of Idaho, Washington and Oregon. He had known Simpkins since 1902.

He first met Adams at Cripple Creek at a labor picnic. He met Orchard at the headquarters in Denver in January, 1904, but knew little of him until the trial of the train wrecking case in the following March. He denied he ever gave Orchard money for the Victorator explosion or for any other act of violence. He never met Orchard, except as a member of the federation, and never gave him money to use illegally. He swore Orchard lied when he said he gave him \$100 in the hall at Victor, and told him to do everything possible to kill scabs. The witness made positive denials all along this line.

He never met Steunenberg, and had no personal animosity against him. He gave financial aid to the strikers in the Coeur d'Alenes, and believed their cause just. Returning to affairs in Cripple Creek district, he said that before the strike began it was the richest mining camp in the world, and all the miners were members of the union. The first strike was in Colorado City in February, 1902. He gave a history of this strike, and said the company discriminated against union men. In August a general strike was declared. Moyer reviewed the strike, and said no real trouble was reported until after the militia went into the district. He and his associates counseled moderation, deprecated violence and did their best to keep the men cool. He reviewed his connection with the strike; told of his arrest at Telluride, and of the refusal of the militia to recognize the court's

orders; how he was harrassed by the militia, and generally reviewed the entire Cripple Creek matter. His testimony differed but little from that of numerous others.

After the train wrecking case Orchard came to his office, and said he was going to Silverton. Moyer told him he was going to Ouray, and asked him to go with him as a guard. Orchard had a revolver. He told him he could let him have an automatic-pull shotgun if he wanted it. He had Pettibone get two, one for each of them, and packed them in suit cases. Accompanied by Orchard, he left for Ouray two days later. Darrow interrupted to ask if his shotgun was used to kill Gregory with. He said no, that the shotgun had never been discharged up to the time of his arrest, and was still in his apartments at Denver, and was never used.

NATIONAL EDUCATORS.

Nominate Officers at the Los Angeles Convention.

Los Angeles, July 10.—The long and bitter fight waged by Margaret Haley and her supporters to overthrow the ruling officials of the National Education Association was lost without opposition. E. G. Cooley, superintendent of public schools of Chicago, was this morning placed in nomination for the office of president. Cooley was nominated by W. O. Thompson, who withdrew from the presidential race. Nathan Schaffer, of Harrisburg, Pa., the retiring president, was nominated for vice-president, and Arthur Chamberlain, of Pasadena, was nominated for treasurer. The formal ratification of the nominations will take place this afternoon. Candidates for the secretary, board of trustees and one member of the executive committee were not named by the nominating convention.

TO TRY FOR GLIDDEN TROPHY

Cleveland, July 10.—At minute intervals this morning 82 autos participating in the tour for the Glidden trophy, left this city for Toledo for the first day's run. The tourists were preceded by three pilot cars. Forty-seven of the 82 will contest for the cup. Thirteen runabouts will contest for the honor trophy. Racing is prohibited.

The route includes several large cities, among them Chicago, Indianapolis, Columbus, Pittsburg, Baltimore, Philadelphia and New York. The great calcade of automobiles number over 100 cars of all makes and designs. The private entries are far in excess of those of previous years. While a considerable portion of the route is through a level country with good highways, there will be a sufficient number of hills to test the endurance of the cars and the temper of the tourists.

The Glidden trophy is to be awarded to the club whose entrants proportionately finish with the greatest number of points to their credit. The governing conditions of the tour present several interesting changes from those of last year. The same plan for a time schedule for each day's run is in force, and penalties will be provided for those arriving at a checking station before or after the running time. Last year there was no penalty attached for repairs or replacements, provided the contestant could make the same, and get into the next control on time. In the present tour such penalties will be provided.

Garfield in Seattle.

Seattle, July 10.—Secretary of the Interior, Garfield arrived here last night on an inspection tour of government works, and was a guest at an informal reception at the Rainier Club. He will address the Republican club tonight. Fairbanks is due this afternoon.

CAUGHT IN FALLING BUILDING MANY ARE KILLED

Big Factory Building Collapses and Carries Workmen Down to Death—Fifteen Taken From Ruins At 2 O'Clock Eight of Them Dead

Philadelphia, July 10.—Bridge-man Bros.' iron pipe factory collapsed this morning, and from 30 to 40 are reported dead. Eight of 15 taken from the ruins were dead, and the other seven severely hurt. All are in the hospital. Police ambulances rushed to the scene, and the police and firemen began rescue work immediately. At 2 o'clock the 15 taken out were lying on the pavement. It was not known that eight were dead until the ambulances reached the hospitals. Wagons and push carts were pressed into service.

In the hospitals the injured lay bleeding in cot after cot, and the stretcher supply was exhausted. Ambulances dashed through the streets with the injured. Fourteen bodies were recovered up to 2:45. A hundred men were working on the four-story addition in the course of construction when it collapsed, and all were caught. Forty are still unaccounted for. Survivors say the roof sagged, crashing downward, and the front wall and side supports crumbled in. The building was located at Fifteenth and Washington avenue.

INDICT SANTA FE RAILROAD

Chicago, July 10.—The federal grand jury this morning returned an indictment against the Santa Fe road, charging it with granting \$35,000 in rebates to the United States Sugar and Land Company. The indictment contains 45 counts.

It is charged that the Santa Fe gave the sugar concern rebates on shipments of building material used in construction of the refinery at Garden City, Kansas, in 1900. Frederick H. Colvin, of Salida, Colorado, and Edward Eoke, of Chicago, were indicted for using the mails in selling alleged worthless stock in a mining prospect.

Bar Association Reorganized.

Monday evening of this week about 25 attorneys met at the Marion county court house to perfect the organization of the Marion County Bar Association, and the following officers were elected: President, J. H. McNary; vice-president, Thos. Brown, of Woodburn; secretary and treasurer, C. W. Corby. Several committees were provided for, and further meetings will be held in the near future. There is a general feeling among the attorneys that a bar association is a good thing for the betterment of legal conditions generally.

Begins Serving Time.

Portland, July 10.—Dr. Alonzo Van Gesner, partner of Congressman Williamson, convicted with the latter of subornation of perjury in the land slide, today began serving his sentence of five months' imprisonment in the county jail. Williamson has appealed to the federal supreme court.

SLASHED WITH SCYTHE.

Albany Man Probably Fatally Injured.

Albany, Or., July 10.—Using a scythe as a weapon, D. F. Young, a local painter, cut and perhaps fatally wounded Joshua Ballard here last night. Young was mowing in front of his home in East Albany, just before dark, when Ballard approached and a quarrel ensued. This ended in a fight, when Young picked up the scythe and attacked Ballard with it. Ballard's left wrist was cut, the tendon in his right arm being severed and he received a severe gash in the head. He may recover if blood poisoning does not set in. Young had not been arrested at a late hour last night.

Bad feeling has existed for a month between Young and Ballard, who were neighbors. It has been very bitter since Ballard's five children, including a 2-year-old baby, were all taken away from him and sent to the Boys' and Girls' Aid Society in Portland. Ballard declares Young was instrumental in securing that action. Ballard has long been a notorious character here.

ENDEAVORERS GATHERING.

Seattle Convention Will Continue in Session Until Monday.

Seattle, Wash., July 10.—Young people by the thousands from all parts of the world, with many older and more distinguished religious teachers and preachers to leaven the great mass of youth and enthusiasm, poured into Seattle today in an ever-increasing flood that is likely to stretch the hospitable provisions of the Northwestern metropolis to the limit. In honor of the delegates to the twenty-third international Christian Endeavor convention, the city has been transformed into a bower of green and white, the colors of the society, all of the larger stores and buildings and numerous residences have been decorated without stint.

Prominent speakers from various parts of the world, including Vice-President Fairbanks, will deliver addresses during the convention, which, opening this afternoon, will continue until next Monday. The session at the Hotel Lincoln this afternoon will dispose of routine matters, including the election of officers and the annual meeting of the board of trustees. Governor Albert E. Mead, of Washington, will extend a greeting to the visitors on behalf of the state, while Mayor Walter Moore will offer the hospitality of Seattle. A response on behalf of the delegates will be made by the Rev. John Pollock, of Belfast, Ireland, president of the European Christian Endeavor Society. These exercises will take place late in the afternoon, and will be followed by the inauguration of General Secretary Shaw and the annual address of the Rev. Dr. Francis E. Clark, president and founder of the organization.

Caught Too Late.

Washington, July 10.—Criminal action against high officials of the Harriman railroad system cannot be taken in the land grafting cases of the Southern Pacific in Nevada. The Oakland, California, land office, after an investigation, has notified the Washington officials that the statute of limitation will bar criminal proceedings. Civil suits will be started to recover the land claimed by the railroads.

Nothing to Arbitrate.

Rome, July 10.—Secretary Hitt, of the American embassy here, said today the Kaiser or Italy's king may be appealed to arbitrate the differences between Japan and the United States. He thinks the situation is growing serious.
