RAILROAD COMMISSION HEARING

About a score of the heads of the operating departments of Oregon railroads have been in the city today, having an all-day hearing before the Oregon Railroad Commission, on the condition of station houses and cars, and other features of this branch of the public service. All three of the commissioners were in attendance, and several private cars of managers are on the sidings.

A telegram was received from an official of the O. R. & N. Co., that in backing a switch engine through the yards at The Dalles, a squaw was run over and her collar bone broken. The Indian woman was deaf and nearly blind.

Viewed the Premises—

The jury in the condemnation case of State vs. Thiel, the German farmer who refuses to sell his land to the state as part of the site for the feeble minded institute, were sent out to view the premises this forenoon. This is the last case to be tried by jury at this term, the rest of the jurors having been dismissed.

To Repair Big Bridge—

There was a meeting this morning of representatives of this city and Marion and Polk counties, to take steps leading to the proper care and repairs of the big steel bridge. A committee composed of County Judge Scott, County Commissioner Teal, of Polk county, and Alderman Fraser, of the Salem city council, was appointed to prepare plans and specifications for an 120-foot span and for painting the bridge, and receive bids on the same after public advertisement.

Students Re-examined—

Out of a class of 16 graduates who received medical diplomas only three were able to pass the examination before the State Medical Board, and those who failed have just been through a second examination, which was held at Portland, but the result is not yet known.

Dr. L. F. Griffith, of the state insane asylum, and Dr. F. E. Smith, of this city, have returned from attending the State Medical Society meeting at Astoria.

Hoover Postoffice—

R. N. Hoover, of the new town of Hoover, on the C. & E., was in the city today to receive his commission as postmaster of the new office that has been established at that live sawmill town. There are nearly 100 people living there and an effort will be made to secure a public school.

Regents Meet—

The regents of the Oregon Agricultural College meet at Corvallis Wednesday, and the regents of the Oregon state normal schools meet at Salem Thursday. The four presidents of the state normal schools meet at Salem Wednesday to consider the adoption of a uniform course of study. Secretary C. L. Starr, of Polk county, is in the city today to make arrangements for renting a home here, and will bring his mother to Salem, where he will make his home.

DIED.

SHANNON.—At the family home in Eugene, Monday, July 15, 1907. Mrs. Elizabeth Shannon, aged 78 years, of paralysis.

Mrs. Shannon was one of Oregon's pioneer women, having come to Oregon with her parents, from Indiana, in 1845, who first located on Howell prairie. Later she married Westley Shannon, and they moved to Salem, where they resided for a number of years. They afterwards went to Eugene, where she lived until the time of her death. Her husband preceded her a number of years ago. They had no children.

Funeral services will be conducted by Rev. P. S. Knight, from the First Congregational church tomorrow morning at 10 o'clock. Interment in I. O. O. F. cemetery beside the grave of her husband.

NOACK.—At the family home at 805 South Twentieth street, Salem, Oregon, Sunday, July 14, 1907. George Noack, aged 77 years and 4 days, of heart trouble.

The deceased has been sick for many weeks. He leaves six grown children and a wife, who, unaided, cared for her husband during his long illness. The family had been residents of this city but a short time and are of German nationality. Mr. Noack's funeral took place at 2:30 Monday from his late residence, and he was buried in City View cemetery.

Elks Elect Officers.

Philadelphia, July 16.—Judge Melvin, grand exalted ruler, today called the first business session of the Elks to order. A thousand delegates were present. The election of officers was one of the first duties. The indications are that John K. Tener, of Charleroi, Pa., will be grand exalted ruler. John Kohler, of Kenosha, Wis., and T. B. Mills, of Superior, Wis., are in the fight for grand trusteeships. The new constitution adopted at Denver went into effect. It is copied after the federal form of government.

CITY COUNCIL MEETS.

Discusses Bridge Situation and Allows a Few Bills.

At the meeting of the Salem city council last night the usual grist of bills was allowed, and a general discussion of bridges followed. The usual statements were made about the North Commercial street bridge, and the usual extensions of time were made. The most optimistic members of the city government hope to have the bridge open by state fair time. Business people generally dread the undertaking of repairing the big steel bridge across the Willamette, as many think if the bridge is once closed to travel it could not be opened inside of two years. Some of the city council favor exacting a heavy bond that repairs shall not close the bridge to travel.

East State Street.

Alderman Gesner accused the street commissioner with a desire to be the whole thing, when he insisted the council was the whole thing. Alderman Greenbaum demanded results for the large expenditure of money. Aldermen Stockton and Downing defended the street committee, and explained what was being done to push the paving as fast as possible. Mayor Rodgers applied the brakes, and brought the discussion to a timely termination with his usual good common sense, applied at the right moment.

More Alarm Bells.

Alderman Stockton introduced an ordinance requiring trains to limit their speed through the city, and for the erection of more electric alarm bells at various places where the S. P. crosses streets.

To Open Chemeketa Street.

Stockton moved that Chemeketa street be opened, and that a competent surveyor be employed to survey the same. It was put in the hands of his committee, and Mrs. Clark, whose house for 40 years has stood at the head of the street, was represented by Attorney Bingham, who said she would open the street for \$2700 to \$3000.

After the Home Company.

Alderman Gesner brought up the matter of enforcing the indemnity bond of \$5000 against the Home Telephone Company, and asked that an investigation be made by City Attorney Condit, and on his motion this prevailed.

WILL REOPEN THE ANGELUS

A. G. Magers to Establish a First-Class Modern Cafe.

"The Angelus," on Commercial street, which has been closed for some time, is to be reopened in the near future by A. G. Magers. Mr. Magers has been considering the move for some time, realizing that Salem needed a first-class cafe, and needed it very much. A new front will be put on the building, and will be thoroughly remodeled made over. Old Mission furniture will be used, and the rooms will be made the most handsome and attractive place of the kind ever opened in Salem. The service will be first class, and, in fact, will be a modern up-to-date cafe, the equal of any in Oregon. Mr. Magers expects to have the new Angelus opened to the public about the middle of August.

Some Timely Recipes.

Dressing for Boiled Beets—One teaspoonful of vinegar, one tablespoonful each of butter and sugar, and a little salt. Mix all together in a sauce pan, and when it boils, add one-fourth cupful of sweet cream blended with a teaspoonful of flour. Let cook up a minute, stirring, and pour over the boiled and chopped beets.

Roasted Beets—Wash and lay the tender beets in a pan and set in a hot oven; turn often, but do not break the skin; when baked tender, skin and chop up with salt, pepper, and a little vinegar in which a little flour has been mixed smooth; add a lump of butter, heat up and serve.

Broccoli—Strip off all but the top leaves, remove the outside skin from the stalks and small branches, then boil until tender in salted water. Season with salt, pepper and butter after draining.

Stewed Carrots—Slice lengthwise and boil until tender; then, in a saucepan, heat one cupful of sweet cream and two tablespoonfuls of butter; put the carrots in this, season with salt and pepper and stew slowly for ten minutes, stirring gently to prevent burning.

Cauliflower with Cheese—Pick of the outside leaves and cut the stem close to the head; wash well, then soak one hour, head down, in cold salted water. Tie up in a piece of cheese cloth, plunge in salted boiling water and cook for half an hour, drain, and turn into a deep dish. In a saucepan, mix one tablespoonful of butter and one of flour until smooth; add half a pint of milk, stirring constantly until it boils; then add four tablespoonfuls of grated cheese and half a teaspoonful of salt. Pour over the cauliflower and serve hot.

Egg Plant—Cut the slices half an inch thick, peel, and let stand in salted water a half hour; then dip each slice in flour, and pile up; when the flour becomes moist, fry in very hot lard, browning on both sides, take up and spread a little butter on the top of each slice. Or, the slices may be dipped in beaten egg, then in rolled cracker-crumbs, and fried until brown in very hot lard.
