Hops at Ten Cents—
One of the largest of the largest hop deals made thus far this season occurred today, when the Ireland Wells company of Corvallis, contracted to sell their 1907 hop crop amounting to 20,000 pounds to Chas. S. May & Co. of Albany, N. Y. The contract price agreed upon is 10 cents a pound. The hops contracted for Chas. S. May & Co. are grown in the Osborn hop yard, consisting of 30 acres a mile east of Corvallis in Linn county.—Albany Herald.

THE BEST SHOW ON EARTH

The Ringling Brothers circus was at Baker City Tuesday and this is what the Democrat of that city says of it:

It can be said truthfully that never before have Ringling Brothers themselves, or any other circus, had on the streets of Baker City a finer or more expensive comparison parade than that which appeared yesterday morning. The main band wagon was drawn by 24 horses. The uniforms of the people taking part in the parade and the comparisons of the animals, were all finished and complete. There were twelve ponies on one vehicle and 24 ponies on another. The horseback band was perhaps the feature of the parade, while the 32 elephants made a whole show in themselves. The callopes, the orchestra, the "rube" band, and the revolutionary life and drum corps stirred up the hearts of many an old soldier who watched the parade from the sidewalk.

Ringling Bros. always did put up the best show on the road, but yesterday they far exceeded their high reputation. The trained animals, including elephants, horses, ponies, dogs, monkeys, were simply perfect in their various acts. Three rings and two stages were occupied all the time and the air was filled with performers on trapezes and wire ropes, clever bicycle riders, tumblers and acrobats, skilled riders, men and women, amused the immense throng. The tent seats 15,000 people and the large troupe of clowns called forth large applause. The concert and feeding the animals after the show was another feature worth seeing.

DIED ON THE TRAIL

A dispatch from Silverton yesterday says that Henry Long, who resides near that place died while walking from the Clackamas Hot Springs to the forks of the Molalla. In company with George and Roy Thomas he had been at the springs for some time for his health. Long left an hour earlier than the others, and when they were within about five miles of the Molalla they came upon the body of Long lying in the trail face down and dead. It is supposed that death was the result of some heart trouble, and was instantaneous. Soon after finding the body two other men came along the trail and the four improvising a litter carried the body to the wagon road, a distance of about six miles, where Mr. Long's team was awaiting them. The task was an arduous one, as the trail is a rough one, and the body weighed 240 pounds. Mr. Long was about 62 years old and had been a resident of Oregon for many years.

WILL RUSH WORK ON ELECTRIC ROAD

Bridge the Willamette at Once—Line from Albany.

While in Eugene yesterday A. Welch and party conferred with J. O. Storey, president of the Eugene & Eastern railway, and details of construction of the line to Springfield and up the McKenzie were gone over. The Register learned last evening that the contract for the bridge across the Willamette at Springfield will be let at once, and building of the road will be rushed to completion. Construction of this line is now settled beyond all controversy, and it will not be many days before the electric cars will go humming into Springfield and beyond.

When seen last evening and asked about the line from Salem south to Eugene, Mr. Welch said he had every reason to believe that Salem and Albany would each grant franchises through their respective cities. Mr. Welch says the line will be built to Eugene beyond doubt, and that it will be a competitor of the Southern Pacific through the valley.

A conference was held last evening in the interest of construction of the road from Albany to this city. Early developments promise gratifying news for Eugene in the matter of electric railway connection with Portland.

\$5,000 Purse at Seattle.

Seattle, Wash., Aug. 16.—Few racing events ever held on the Pacific coast have attracted as much attention as is now being manifested in the "1909" handicap, with \$5,000 guaranteed, which will be run tomorrow at the Meadows track. For weeks trainers have been putting the crack thoroughbreds here into the best possible condition for the great event. Of the \$5,000 purse, \$800 will go to second and \$400 to the third horse. The event is for three year olds and upwards and the distance a mile and a quarter. Until the running of the Alaska-Yukon-Pacific handicap in 1909, for which a \$20,000 purse is to be hung up, the "1909" handicap will be the feature of the summer race meetings here. The A.-Y.-P. stake will be the largest ever offered on the Pacific coast. The Burns handicap, worth \$10,000, is at present the big event on the coast, but the exposition purse will double it.
