decided not to interfere with present temperance laws. It also favored the local option plan, with a county as a unit.

### For Tariff Reform.

CRIMINAL CASES IN BURNETT'S COURT

The six prisoners in the county jail, who were arraigned and instructed before Judge Burnett yesterday by District Attorney McNary this morning plead not guilty and their cases will be heard as follows before a jury: Hans E. Hansen, accused of stealing a team from Wm. T. Claggett, Friday, April 10; L. Smith and Jack Wilson, who are under arrest for robbing the second-hand store of C. Dillman on the night of January 22, Monday, April 13; Chas. Wright, accused of stealing a horse from Chas. Yately of Mission Bottom; Harry Sampson, alleged burglar, and A. L. Moser, accused of passing bogus checks, Tuesday, April 14.

Judge Burnett this morning overruled the motion for judgment on pleadings for the defendant in the suit of James Higgins against L. T. Towlek, and set the case for hearing, April 15.

ARMY OFFICER EXILED

Washington, April 1.—Both President Roosevelt and Secretary of War Taft have turned a deaf ear to the pleas of Mrs. William F. Stewart, of this city that her husband, Colonel Stewart, of the Coast artillery, whom friends have sought to picture in the light of an "American Dreyfus," be recalled from his present isolated detail at the deserted post, Fort Grant, Arizona.

Investigation today by the United Press revealed a case unparalleled in the history of the American army. No charge has been made against him. He has not been court-martialed, and has never had a hearing, yet it is admitted at the war department that the transfer and attendant humiliation and punishment are in the nature of a chastisement.

In response to inquiries for the justification of such unprecedented measures, the excuse was offered that the records of the war department show lack of discipline at every post commanded by Colonel Stewart in the past few years. Despite this the officer has violated no rules and his superiors find no grounds for bringing a court-martial, adopted the expedient of giving him a command where his alleged lack of ability as a disciplinarian would not matter.

For weeks the faithful wife of Colonel Stewart has labored in vain to bring influence to bear to get her husband restored to his old command on the Florida coast but she has met only rebuffs at every turn. The matter is now said to be in the hands of President Roosevelt alone.

The latter has announced that the reasons which impelled the war department to detail Colonel Stewart for the nerve-breaking desert still obtain and that he will have to remain there indefinitely. The only consolation held out to the wife by the war department is that her husband may resign if he wishes to and that his resignation will be accepted.

As this, however, would cheat the old veteran out of his chances of being retired a brigadier general in two years more, he refuses to surrender his command.

tration so affects the welfare of all, that the people will never concede that any citizen can refuse to accept it when tendered.

Mr. Roosevelt, however, has not declared that he will receive the electorate vote of the nation. We need not fear that he would think of refusing it. He is too good a soldier and too patriotic an American to refuse to obey the command of the people, to stay in the harness until he finishes the good work he has inaugurated.

If the American people will stop to think for a moment they will realize that, "barring death or serious illness, President Roosevelt must and will be selected and elected for a second elective term." The people are with him in the great work he has undertaken. They have the utmost faith in his honesty of purpose. They appreciate his transcendent ability to deal with the great problems now confronting the state. They realize his courage, his initiative, his vast experience, his tremendous capacity for effective work. They believe in his purpose to enforce the law impartially, without respect to person, wealth, or station. They have an abiding faith in the ultimate good that will result to this nation from his persistent campaign against legal and moral wrong doing. They comprehend the value of having such a man as chief executive.

No other man has such a hold upon the confidence of the people. No other man can gain such confidence without years of trial. The people know what Roosevelt is; they do not know what some other man may become. The policies of Roosevelt are in course of execution. Few, at this time, have reached ultimate conclusion. To place another man at the head of this government would mean, for some time to come, delay, uncertainty, if not possible disappointment, in the successful carrying out of the problems of government that President has essayed to solve.

For President Roosevelt to be permitted to give up the reins of government at the end of his first elective term because of such illogical and paltry reasons as have been offered, against the wish of the great mass of the people, in the present condition of governmental affairs, would be worse than folly.

There is but one logical and reasonable thing to do under the circumstances, and that is for the Republican national convention at Chicago to nominate Mr. Roosevelt as the choice of the Republican party for President. It might not be so logical, but it would be the sensible thing for the Democratic convention to take a similar course. If Mr. Roosevelt feels that he cannot consistently accept another nomination, the people will not insist that he do so. They will, however, insist that he be on hand when the time comes for his inauguration.

## SWINDLE STATE BY SIDE COMPANIES

Springfield, Ill., April 1.—False and fraudulent statements, a conspiracy to defraud and swindle the state of Illinois, are charged in the amended bill against the Illinois Central railroad, by the state, which is seeking to recover \$15,000,000 back taxes. The bill probably will be filed this week and a hearing had on the case or the demurrer at the May term of court.

The state charges that the charter line, upon which 7 per cent of the gross earnings should have been paid to the state in lieu of taxation has been mulcted in every conceivable manner by the most cunning legal minds money could employ. Subsidary companies it is charged, have been formed always with the single purpose of defrauding the state.
