

SHOW NO RESPECT FOR NAVY

Salem High School won over the U. S. Flagship Charleston baseball team here yesterday by the score of 4 to 1.

The day was an ideal one for baseball, the stores closed at four o'clock and everybody went out to see the game.

The true American spirit was shown in the decorations which everywhere prevailed of the national colors.

The crowd that was out surpassed any crowd ever seen on the Willamette field.

The game started with the Tars at the bat. They went down in one, two, three order with two strike outs.

In the first time up Salem started their scoring when Roberts came over the plate on a wild throw to second.

One of the blue jackets got first on an error, stole second and third and came home on a well placed bunt.

They played ball for this one point and it looked as if they would get more but went down without another score.

Salem got a man on second that inning but no score. In the fourth Salem made a pretty double.

With a man on first a sailor bunted to Kay, the one on first with a big lead tried for third.

Kay threw to Gabrielson and Gabrielson back to Kay. In the last of that inning Perkins should have scored but cut third and was called out.

In the fifth the Charleston men had a man on second and third but failed to score.

In the last of the fifth Salem made two more runs, Roberts coming through with a hit as usual at just the right time to count.

Perkins did some pretty backing and a nice throw in the sixth and also a score in that inning making the final score 4 to 1 as there was no scoring after that.

POSTMASTER AND EX-COUNCILMAN

The case of Richard Parrott of Butteville, charged with assault and battery upon Randolph Woolworth

66 years of age on March 27, was tried before Judge Webster yesterday afternoon, and after much argument and taking of evidence the jury, consisting of J. M. Lawrence, Sam Adolph, August Huckestein and A. A. Lee, found the defendant not guilty.

The prosecution was conducted by City Attorney Keyes, and Carey Martin handled the case for Parrott. The story of the affair, as it appears from the evidence is this: Woolworth had placed some tiling across the road in front of his place in order to carry off the water from his side of the thoroughfare.

In doing this the water was made to run down the road in front of his neighbor's property, a merchant by the name of Vandellour. Vandellour objected to this, and got permission from the road supervisor to remove the tiling.

Vandellour employed Parrott to help him in this work and this appears to be the cause of the trouble, for Woolworth was on bad terms with Parrot.

Parrot claims that Woolworth once forced him out of the town council, and at another time falsely accused him of irregularities in his conduct of the Butteville post office and reported him to the authorities at Washington.

Woolworth came up and saw Parrott digging out the tiling, and remarked to Vandellour that "he could not get anyone else in the country to help at the job but that dirty little pup."

This made Parrott angry, but he claims that he said nothing to Woolworth except to tell him to go off about his business, and that he was doing the work by the authority of the road supervisor.

Woolworth then went away, and the two men agreed to say nothing more to him if he returned.

Both Vandellour and Parrott swore that they were deathly afraid of Woolworth, and that at the time he had something in his hip pocket which they believed to be a revolver.

Further testimony developed the fact that Woolworth had been in the habit of carrying a revolver, and that on the afternoon of the 27th after the dispute with Parrott, he had exhibited the gun to some of the citizens of the village, with the remark that he "would fix Parrott if he ever struck him again."

Woolworth, however, said that he only carried the gun to kill dogs and cats that were troubling his chickens.

In a few minutes Woolworth returned and made other remarks about Parrott. Parrott swore that Woolworth, who was standing about four feet away, advanced and reached for his hip pocket, and that he (Parrott) fearing for his life seized Woolworth's right arm with one hand, and with the other struck him in the face, knocking him over in the ditch.

Parrott says that Woolworth then declared that "he had enough for an old man", and that he got up out of the ditch and went away. Woolworth claimed that he had no gun on his person during the conversation with Parrott and Vandellour.

The jury was only out five minutes when they returned with the verdict of "Not guilty."

Woolworth then went away, and the two men agreed to say nothing more to him if he returned.

Adams is the man who ruled that No Statement No. 1 man should be allowed to go to the state convention, and did other brilliant things in the interest of harmony and success.

Fair treatment of public service corporations would indicate that when they come through with street improvements and all the city council asks of them, that the city council keep its part of the agreement to annul obsolete provisions of franchises and grant such amendments as are in keeping with sound public policies, and a growing Capital City.

Up to the first of June the first office of the Secretary of State collected \$34,000 fees for 1908 and turned them into the state treasury. Under four years of Secretary Dunbar a court says he collected \$103,000 and put it in his pocket, and probably a great deal more that no record was kept upon. That was part of the old machine graft that it took five years of agitation on the part of this paper alone to abolish.

After it was adopted as part of the Republican platform the Oregonian ridiculed it and fought it just as it now fights Statement No. 1. Furnish ridiculed the flat salary law and Mr. Fulton went out and made a state campaign for Furnish and ignored the whole subject.

Then Dunbar and his machine friends got the law staved off four years and took the fees he pledged himself in accepting the nomination not to take, and now he has a verdict against him. He and his machine advisers said it was against the constitution just as they say now Statement No. 1, and direct election of Senators is against the constitution. But the reform was established and Secretary Benson collects the fees, takes a flat salary and puts all he collects in the state treasury.

Now it's constitutional. The people should see to it that their verdict is respected and after awhile that will be constitutional. The people make the constitution not the machine.
