John F. Carrol of the Portland Telegram is a Republican to our liking. He supported Cake but accepted the verdict of the people.

He has an editorial Friday that hits the nail on the head, as he is very capable of doing when he sets about it.

He has a little preachment on "Legislators and their Obligations," and it reads as follows:

"It is all right to speculate when a pledge is not a pledge but when it is said and done in its last analysis a pledge is always a pledge and nothing else. The men elected on a Statement No. 1 platform solemnly obligated themselves to the people that in the event of their election they would vote in the legislature for any one whom the people, by their votes designated as their choice for United States senator. If they are honorable men they are left with no option. They accepted the nominations with their eyes wide open and they could have been in no doubt as to the quality of the obligation that went with it. Few if any of them are in any doubt and it is impossible to conceive how an honorable man could have any honest doubts.

"If a man has been elected on a Republican choice platform or if he has been elected without pledges then the matter is strictly up to him. He may do whatever his judgment or conscience dictates in the matter of voting for a United States senator and there are no reasonable grounds upon which his constituents can call him to account. But with the other men it is different. With respect to the election of senator they are simply trustees to carry out the will of the people who elected them. They are left without option in this respect for they have given up their option. They are in the attitude of the secretary of a convention, as one member-elect of the legislature put it, who is instructed to cast the vote of the convention for a particular man. ing of the ballot is a purely outward formality and therefore, as a matter of course, he does as he is instructed to do, though if left to himself he would have done otherwise.

"Most members-elect of the legislature cheerfully accept this view of the case. They recognize and at the same time proclaim their obligation. But in this connection it is surprising how many of them have already been approached with attractive financial suggestions, provided they do the "right" thing in the legislature. It carries one back to the good old days when the legislators were appealed to through the sense of touch. The old way may have been better than the new way; there is something doubtless to be said on both sides, but the suggestions of bribery with which the air is already filled are not calculated to arouse any violent antagonisms against the new way of electing senators."

The man who was probably the champion medicine consumer of the world died a few days ago. In spite of the fact that he never had a day of sickness in his life this man who died from heart disease at the age of 78, had put more medicine into his insides than many a drug store contains. While the records which he kept of his consumption are incomplete, they show that during his life he got away with more than 1,000,000 pills, and more than 830 barrels of liquid medicine. In addition to this, he estimated shortly before his death that he had used something over 15,000 gallons of lotions externally, to say nothing of nearly 50 acres of plasters and the like. It was his habit to consume a couple of handfuls of whatever sort of pills he fancied before breakfast and during the day to sip liquid medicine as some men do highballs. In spite of the warnings of doctors the strange diet seemed to have had no effect upon him, although with advancing years he cut down his daily rations. He was often urged by his friends to make medicine taking a profession, the idea being that he could take a box or a bottle of this or that nostrum, and then receive pay for a testimonial. This, however, he refused to do.

WARSHIPS RESUME VOYAGE

San Francisco, June 8.—The battleships Maine and Alabama weighed anchor in the bay shortly after 7 o'clock this morning and passed out through the Golden Gate on their way to Hawaii. They are pathfinders of the Atlantic fleet and are going ahead to try the course for the main body of ships in the great cruises around the world.

The special service squadron is in command of Captain Giles B. Harbor of the Maine. It is expected that the two ships will maintain a schedule of 10 knots an hour and will arrive at Hampton Roads on October 22. They will not cover exactly the same itinerary as the 16 ship fleet, but will go over the main stretches of the long cruise.

One reason these two ships were chosen for the "pathfinders" is that both have boilers that demand the use of a greater amount of coal than is used on other ships and their voyage will be shorter than that of the fleet.

UNCLE SAM ROBBED OF \$85,750

Pittsburg, Penn., June 8.—Government agents today are investigating startling allegations contained in an answer to a civil suit filed here, in which members of the treasury department are alleged to have taken a bribe for putting through a deal by which Uncle Sam paid \$2000 a front foot for a postoffice site when property on either side of the lot is selling at \$400 a front foot.

The suit was brought by the law firm of Wise & Minor against John H. Armstrong, Snowden G. Lennox "and their associates" for commission alleged to be due for the sale of the land. Armstrong and Lennox in their answer state that the government was cheated out of \$85,750 in the purchase of the site which cost \$942,226.40. It is alleged that the chief promoter paid \$85,750 to certain persons in Washington to have the deal put through.

JOHNSON—At the home of her daughter, Mrs. Marla Polley, at 354 Winter street, Mrs. Mary Johnson, nearly 88 years of age. "Grandma Johnson," as she was familiarly known among her large circle of friends, was long a resident of Salem, coming here with her husband, the late Lewis Johnson, from Indiana in 1863 and had resided here ever since; all these years living in the same home.

Mrs. Johnson was born in Yorktown, Pennsylvania, June 15, 1820. The family name was Yost. She was married to James Miller in 1845, and to them were born four children all living, as follows: John H. Miller of Logansport, Ind.; Mrs. Marla Polley, Mrs. Mary Cox and Samuel Miller, residents of Salem. Three years after the death of Mr. Miller in 1859, she married Lewis Johnson and moved to Oregon, coming by way of the isthmus.

Since Mr. Johnson's death in 1887, she made her home with her daughters Mrs. Polley and Mrs. Cox, who most devotedly comforted her in her declining years. Her death was from old age, merely going to sleep like a tired child.

The funeral will be held at 2 p. m. Tuesday, 354 Winter street. Burial will be in Oddfellow's cemetery.

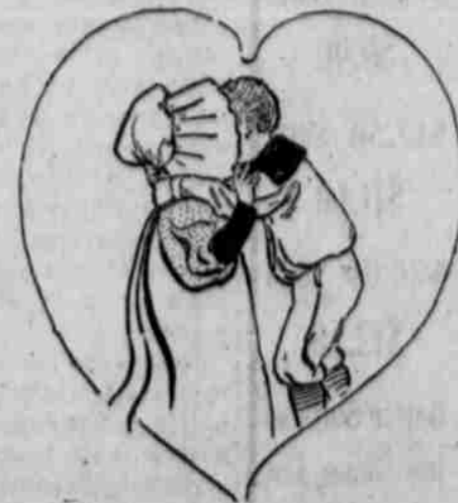
