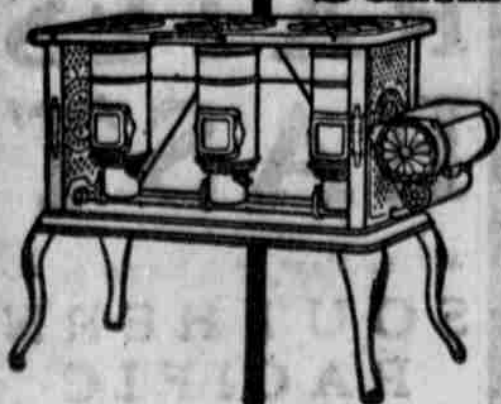

### OUT FOR DIRECTOR

Young Man Is a Candidate on a Platform of Putting Salem in the Front Rank as a School City.

Alderman Milliard of the Sixth ward has consented to be a candidate for school director at the election Monday. There are three petitions out for him, one containing nearly all the names of citizens in Englewood, where Mr. Milliard has resided since 1895, when he came to Oregon.

Another of his petitions is signed by many of the prominent businessmen of the city, and another by citizens of the school district generally. He is a young man of the highest character and has made a record by standing up for progress on all lines in the city council, and will make a progressive school director. Mr. Milliard has three children and has a vital interest in good schools.

## BIG BRIDGE DECLARED UNSAFE

### TRAFFIC SUSPENDED

Span in West Approach Breaks Down, and County Judge Orders Closed to Traffic—Ferry Will Be Established.

Friday afternoon the discovery was made that a combination span in the west approach to the big steel bridge connecting this city with west Salem was giving way and was unsafe for travel. County Judge Scott was at once informed and declared the bridge unsafe and closed to travel. The break was caused by rotting timbers in the combination span, but is not part of the big bridge proper, which is entirely safe. The repairs will be ordered made at

once, as a conference was immediately arranged between the city and county authorities of Marion and Polk counties and the city of Salem.

The break can be repaired in two weeks and in the meantime a temporary ferry will be made use of. It comes at a very busy season when the berries are ready for delivery at the cannery.

At the conference this morning Contractor W. F. Royal was instructed to proceed with the work of repairing the defective support as rapidly as possible, working both night and day, if necessary.
