work making up the temporary roll of delegates-wise bands are playing outside and delegations are cheering each other as they march and counter-march about the streets.

Some of the contests are being hard fought and for the first time since the preliminary work of the convention was begun there are evidences of acrimonious feeling that may yet crop out on the floor of the convention.

The national committee was called to order today by Chairman Taggart at 9 o'clock this morning.

Long before that hour representatives of the various aggrieved applicants for seats as delegates were about the corridors buttoning members and bringing every possible bit of influence to bear to emphasize the reason why their particular faction should be recognized.

"We are the only regular Democrats," was the burden of their cry, "and if you do not recognize our claims to the cause we will suffer."

After Secretary Woodson had read the list of contests, a motion was adopted that separate sub-committees should hear the evidence in the contests from each state and report their conclusions to the main body. It was decided to appoint these sub-committees at once and then the committee adjourned until 4 o'clock when the reports will be received and the roll call of the opening session completed.

The full list of contests was as follows:

- Idaho—Entire state delegation. Illinois—First, second, third, fourth, fifth, sixth, seventh, eighth, ninth and tenth districts. New York—Second, third, fourth, fifth and sixth districts. Ohio—Ninth and nineteenth districts. Pennsylvania—First, second, third, fourth, fifth and sixth districts. District of Columbia—Entire delegation.

The grounds of contests range from "irregularity" to allegations of fraud. The chief interest in the Idaho and New York contests. In the former, Ex-United States Senator Fred J. Dubois was waging the hardest battle of his political career.

The contestants were headed by John N. Nugent and Judge Perkin Nugent, in presenting the case for

the contests, alleged that Dubois, by reason of fraudulent practices had converted a minority into an apparent majority and had ridden rough shod over the legally elected delegates to the state convention at Twin Falls. He charged that there had been collusion with the Democratic state central committee chairman resulting in an invitation to the members of the "American party" which is the anti-mormon faction in Idaho, to send delegates to the Denver convention.

By this means, Nugent says, Dubois was seated as a delegate to the convention, having been the choice of the Americans in his home country.

and that his supporters are keeping up the fight only as a matter of principle. Formal assurances that Johnson will be nominee are still to be issued from his headquarters, but this is for a purpose. The Johnson folks are laying plans for 1912.

Theodore Knappen, assistant manager of his campaign and spokesman for the Minnesota governor, said: "We know we can't win but Johnson's name will be presented to the convention. We started this fight to stay in it to the finish and all this talk about Johnson's withdrawal is foolish. We are going through with it even though we recognize the fact that there is no hope for Governor Johnson being named as the party's nominee. When Bryan is nominated and defeated as he surely will be there will be a re-organization of the Democratic party with Governor Johnson as the leader."

"Johnson's campaign probably was not started right. I am of the opinion that if it had been started several months earlier and the people had had a chance to learn more about him, things would have been different. Some of his advisers thought it better to hold off the campaign until practically the last minute. That was the policy decided upon and I think it was wrong. We

The Dry Lands of Peru.

The arid lands of the United States, with five or six inches of rain a year, might be considered well watered if compared with some of Peru's dry wastes which are to be reclaimed. The showers that visit them are few and far between—once in from ten to 14 years. But when water is put on such land its fertility is phenomenal. The soil has lain inert for centuries, with any run-off to leach out the fertility stored from time immemorial. This has been found true in our own West. The drest region often has the strongest soil, once it is brought under irrigation and its salts dissolved and made available for plants.

Peru's rivers, which are soon to be utilized, flow down from snowy mountains and cross the arid country just as many of the rivers of our own arid regions do. To that extent the western part of the United States and the western portion of Peru have many features in common and the engineering experts who have recently gone down there from this country can make good use of the experience and technical knowledge gained at home.—Geological Survey Report.
