factory to Bryan and has been personally invited to accept the place.

While the delegates were assembling Texas jammed a big square banner on the top of its standard reading:

"Texas is for Gray for vice president."

The opening prayer was offered by Rev. Martin J. Corbett of Westfield, N. Y.

Chairman Clayton's voice having been lost entirely he called Congressman Ollie James to the chair to preside. A dispute in the Massachusetts delegation appeared, a delegate attempting to criticize the action of Massachusetts in yielding to Utah last night, but Chairman James ruled him out of order before he could make his contemplated speech.

Nominations for vice president were then declared in order. Senator Stone, of Missouri, moved that nominating speeches be limited to 10 minutes each and seconding speeches to five minutes each. This suggestion was applauded and carried through with a whoop of delight by the delegates.

Alabama yielded to Indiana and Thomas R. Marshall, Democratic nominee for governor of Indiana, was recognized to nominate John W. Kern of Indiana. Marshall, in excellent voice, paid a high tribute to the re-united Democracy, and remarked that with Bryan at the head of the ticket and Kern as his running mate every doubtful state would be carried this fall. Marshall created a big laugh when he declared that he came from a state where every man was either an orator or an author and all were politicians.

Former Governor Chas. S. Thomas of Colorado nominated Charles A. Towne in a brief speech, referring to his service in the house and senate. His nomination by the Colorado leader was believed to indicate that Towne did not have the support of his own state, New York.

Thomas admitted that the newspapers generally would oppose Towne's election but this he declared would not be a handicap.

Connecticut, when recognized, nominated Archibald McNeil through John J. Walsh of Norwalk, who declared that McNeil was the choice of the New England Democracy.

Delaware yielded to Georgia and H. D. Hill of that state nominated Clark Howell of the Atlanta.

Florida yielded to Missouri and Governor Joseph W. Folk took the platform to second the nomination of Kern of Indiana. Folk got a remarkable reception, the delegates and spectators climbing on chairs and yelling like made for nearly five min-

utes the whole Chairman James was vainly trying to restore order. Cries of "Let's nominate Joe Folk" went up from every section of the hall. Folk stood smiling through it all and finally when order was restored said:

"Gentlemen, in 1904 a mysterious stranger entered Missouri and in 1906 we ran him out. You gave us a candidate last night that will keep him out and keep Missouri where it belongs among the leaders of the Democratic hosts. Our platform and candidates this fall stand for all that is righteous in American politics and government and this re-united Democracy will press on from today until sweeping a victory is attained next fall."

Mitchell Withdrawn.

Idaho seconded Towne's nomination. When Illinois was recognized Ollie James relinquished the gavel to James Hamilton Lewis of that state who recognized Fred Kern of Chicago who withdrew the name of John Mitchell from the field and seconded the nomination of John W. Kern.

He characterized Mitchell as the greatest laborer the world had ever seen and said that his nomination would have absolutely wiped out party lines.

"Illinois," he said, "knows that there are more handsome women and children uplifted to a God in heaven to ble a John Mitchell than any other man in the world."

"Mitchell commissioned us last night to say that there was everything in the Democratic platform that any labor leader could fairly ask or expect, but he asked us to withdraw his name and permit him to continue his work of aiding the down trodden in the mines and factories of the United States."

There regretting that we cannot present his name we are constrained to second the nomination of the next best available candidate Kern of Indiana."

Indiana yielded to Alabama and Congressman Heflin seconded the nomination of Kern.

State Senator Lee of Maryland, seconded the nomination of Charles A. Towne.

Michigan, through Edward Wood, the new national committeeman, seconded the nomination of Kern.

When New York was reached Chas. F. Murphy announced: "New York presents no candidate."

ONE TERM IS ENOUGH FOR BRYAN

Lincoln, Neb., July 10.—William J. Bryan today made the following statement: "The presidency is the highest official position in the world and the one occupying it cannot afford to have his views upon public questions biased by personal ambitions, but recognizing his responsibility to God and his obligations to his countrymen, he should enter upon the discharge of his duties with a singleness of purpose. Believing that one can best do this when he is not planning for a second term I announce now, as on former occasions, that if elected I shall not be a candidate for re-election."

FROM THE FLEET 800 MILES OUT

On Board the Battleship Georgia, At Sea, July 10.—(By Wireless to the United Press.)—The Atlantic is 800 miles west of San Francisco at 11 o'clock this morning and the cruise is proceeding satisfactorily to the officers. The sea is quiet and the weather hazy, but pleasant.

Yesterday was taken up with fleet maneuvers. The vessels formed single line and squadron formation without change in their speed.

tion at the instance of Pence, who appears as complaining witness.

The petition alleges that Dunne has placed both the supreme court and the district court of appeals in contumely and contempt by statements made from the bench and in interviews given to the press.

Some of the statements alleged to have been made Dunne are cited in the petition. One dealing with the release of Schmitz is as follows:

"It seems to me, from reading the opinion, that the judge who wrote it thinks that I, and not the grand jury, was responsible for the indictment of his brother-in-law, Mr. Brobeck."

Another statement alleged to have been rendered by the judge is as follows:

It is to be regretted that the hearing of this appeal came up before a court which most members have relatives and intimate friends against whom indictments were returned by the grand jury that returned these true bills. In view of these facts I do not believe that the court was in a proper frame of mind to give this matter an impartial consideration and decide it strictly on its merits."

The petition has not yet come up for consideration in the supreme court.
