SHAH'S UNCLE LEADS

TEHERAN IN STATE OF TERROR  
—TOWN PLACARDED WITH THREATS AGAINST RULER—RUSSIA MAY TAKE HAND.

Teheran, July 13.—The news received here today that Zill Es-Sultan, uncle of Mohammed Ali Mirza, the shah, is advancing on the capital from the south with a large army of revolutionists, has thrown the Persian capital into a state of terror. ### GIRL IS BRUTALLY MURDERED

FIND BODY IN LAKE

GRUESOME DISCOVERY IN LAKE NEAR TROY, NEW YORK—HAD BEEN MISSING SINCE FOURTH—SKULL CRUSHED.

Troy, N. Y., July 13.—Showing evidences of a brutal murder, the result of fiendish motives, the body of Hazel Drew, a beautiful 19-year-old girl of Troy, was found today floating on the surface of Teal pond, 10 miles from the city. The whole community is shocked and astounded at the discovery of the revolting crime, which recalls the drowning of Grace Brown by Chester Gillette in Big Moose lake.

She had been missing from home since July 4 and a persistent search led to no trace until the discovery of the body.

The skull is crushed and physicians, who made an examination of the body, say there is no doubt that the girl was assaulted and horribly maltreated before her death.

Excitement has been increased by the testimony of several persons living on the road which leads from the city to the pond, that on the evening of the Fourth they saw a big automobile, with no lights, pass out toward the pond with two men and two women. When it returned later it carried two men but only one woman. This story is substantiated also by several persons who live at a hotel not far from the pond.

The police are following the automobile clew and by putting several of the girl's friends in the "sweat-box," they expect to learn today whether she might have been the occupant of the car, who did not return.

The body of the young girl was in bad condition after eight days in the water of the pond.

### THAW IS GIVEN A RESPITE

FROM MATTEWAN

DOES NOT GET HEARING BEFORE JURY, BUT WILL BE ALLOWED TO STAY IN WEALTHY SHERIFF'S ROOM.

White Plains, N. Y., July 13.—Without gaining his request for a hearing before a jury on the question of his state of mind, Harry K. Thaw is happy today because he will be permitted to remain in the jail at Poughkeepsie until the third Monday in September instead of going back to the asylum at Matteawan, which he desires.

Justice Mills adjourned the Thaw hearing today without announcing any decision on the question of the jury trial and the matter now goes over until September.

Thaw said he is more certain than ever that he soon will gain his freedom and looks upon the temporary result of his case as a victory. He likes the luxurious quarters of Sheriff Robert W. Chandler in the Poughkeepsie jail.

Every Thaw was not present at the hearing of her husband's application today. Assistant District Attorney Maher represented the state. Thaw introduced an affidavit made by Dr. Sillo, of New York, stating that Thaw's health was greatly impaired by his confinement at Matteawan and that Thaw would lose his reason if forced to return there.

### CHINESE SMUGGLER IS KILLED

Los Angeles, Cal., July 13.—The immigration officials here today decided to double the guard on the Mexican frontier as the result of the increased activity among the Mexicans who make a practice of smuggling Chinese into this state. Four Chinese were today lodged in the county jail here and will be deported. The Chinese were captured by Inspector Ames and three guards after a hard fight with Mexican guides on a small bridge near the canal that leads from the Colorado river to the Imperial valley. One of the Mexican guides was killed and three others escaped on the Mexican side of the line. The four Chinese were easily captured in the confusion.

#### Will Not Attack Roosevelt.

Lincoln, July 13.—At a conference between Bryan and the leaders of the Democratic party from all the States today, it was decided to let Roosevelt alone during the coming campaign. ### OLYMPIC GAMES AT STADIUM

ALL-WORLD MEET

AMERICAN ATHLETES LEAD PARADE — FAVORITES — EXPECTED TO WIN NEARLY ALL HONORS—MAKE GOOD START.

London, July 13.—Drenching rain failed to mar the success of the opening of the great Olympic games in the stadium at Sheperd's Bush, at 3 o'clock this afternoon, which was attended by more than a hundred thousand spectators, including King Edward and Queen Alexandra, the Duke and Duchess of Sparta, the Crown Prince and Princess of Sweden, the Duke of Argyll, the Duke and Duchess of Connaught and scores of other titled personages.

The American team of 35 fine looking athletes was given a great ovation as it passed in review before King Edward. The brawny Americans answered the ovation by waving the stars and stripes in salutation to the English king. The king entered over a path of flowers just preceding the parade of the 2500 athletes representing 20 countries.

In opening the games Edward made a formal address in which he complimented the committee on arrangements and spoke at some length in the praise of athletics in general. In conclusion, he said: "I hope the best teams will win."

Then the parade of athletes, led by the Americans, passed in review before the king who bowed to each team, which in return dipped its national flag.

The Americans were strong favorites on account of the supremacy they have maintained in the past. They are confident of making a better showing than ever before at the present meeting. The previous records are as follows:

Athens, 1896—15 events—America, 9; England, 4; Greece, 1; Denmark, 1.

Paris, 1900—24 events—America, 17; England, 4; France, 1; Holland, 1.

St. Louis, 1904—26 events—America, 24; Canada, 1; Germany, 1.

Athens, 1906—25 events—America, 11; Ireland, 3; Germany, 3; Sweden, 2; Finland, 1; Greece, 1; England, 1; France, 1; Canada, 1; Austria, 1.

Never in the history of the great games has such a great number of stars met in the contests and it is believed that the Americans will have the hardest battle on record to maintain their record of superiority.

The first heat of the 1500-meter run was won by J. P. Sullivan, of the Irish-American Athletic club of New York. Lightbody, of the Chicago Athletic club, was second. Meadows, of Canada, was third. Sullivan's time was 4 minutes, 7½ seconds, and Lightbody's time was 4 minutes, 8 2-5 seconds.

The outcome of the first heat was no surprise to the spectators and competing teams and it is predicted that the Americans will have no difficulty in winning the event. This race has been conceded to the American sprinters without question by everyone who has watched the work of the various contestants.

Melville Shepard, of the Irish-American team of New York, won the second heat in 4:05 minutes,

### PEASANT EATS HIS FAMILY

FAMINE SPREADS

THOUSANDS ARE DYING FROM HUNGER IN SIBERIA—GOVERNMENT AID IS ASKED—HUMAN FLESH FOR FOOD.

St. Petersburg, July 13.—Dispatches received here today say that conditions in Yakutsk province, Siberia, are daily growing worse. The famine has spread to such an extent that peasants have been impelled to resort to cannibalism. Thousands are dying and the government has been asked to rush more supplies to the stricken district. A peasant named Komoff and his son are awaiting trial at Yakutsk, the provincial capital, charged with having devoured Komoff's wife and two daughters, a younger son and a servant. The prisoners are charged with having killed the members of the family and then eaten them piece by piece. The neighbors claim that the Komoffs sold the human flesh at starvation prices to them. It was owing to the confessions of several neighbors that the Komoffs were arrested. After the authorities had unearthed several skeletons in Komoff's hovel, the father and son fled but were captured nearby.

According to reports received here bread is absolutely unobtainable in the province. The peasants pay a kopeck a pound for grass into which a little flour has been mixed, and use this for bread.

establishing a new record of 2-5 of a second better than Lightbody's at the Olympic games at St. Louis. J. P. Halstead, of the New York Athletic club, finished second and Butterfield, of England, finished third.

Battersby, of England, won the first heat of the 400-meter swim in 5:48 minutes. Lastores, of Hungary, finished second, and Goodwin, of New York, third.

Poster, of England, won the second heat of the 400-meter swimming race in 5:04 4-5 minutes.

N. F. Hallows, of England, won the third heat in the 1500-meter run, Laughl, of Italy, second; Riley, of the Irish-American club of New York, failed to finish.

Although it was generally conceded that the Americans would carry off the honors in the 1500-meter event, England refused to give up hope after entering stars of the magnitude of H. A. Wilson, who won the trial race at the stadium; J. E. Deakin, southern country cross country champion, and A. J. Robertson, the national and international cross country champion. Friends of G. Butterfield, the mile champion, were deeply disappointed in the showing he made in failing to finish better than in the first heat. Sweden also counted upon a place in this event, Kristian Halstrom being the favorite entry.

Halstead, who finished second in the second heat of the 1500-meter event, won the American tryout in 5:01 1-5. He ran under the colors of Cornell at that time. Wilson, of England, who won the British tryout for that event in 4:59 4-5, was off color today and did not even show. He defeated his nearest opponent 20 yards in the tryout.
