ELKS HAVE HOUSING GOOD TIME IN DALLAS (United Press Leased Wire.) Dallas, Tex., July 16.—Over 75,000 people watched the monster parade of the Elks today. The streets were thronged with people long before the parade of the "best people on earth" was scheduled to begin and the spectacle was one of the finest ever seen here. The visiting delegations in their purple and white costumes and carrying banners of their respective lodges, made a line over three miles long. Floats and plenty of funny stunts marked the parade at intervals. The members of the Los Angeles delegation today reported that a thief had looted their apartments last night. He had gained access to their suite during the night and when they awakened today, they found their spare cash and three gold watches valued at \$205 apiece, missing.

INTERSTATE COMMISSION RENDERS DECISIONS (United Press Leased Wire.) Washington, July 16.—Four important decisions were handed down today by the interstate commerce commission. They are: In cases where members of a family are entitled to a pass under the rulings of the commission, a household servant traveling with the family is entitled to a pass. A direct route between two points is a "reasonable route" for the shipper. In cases where the cost of a circuitous route is less for the railroad company, the shipper can demand no reparation. Eating houses conducted by railroads and supplied with food and provisions by the railroads at a less cost than the market price of such commodities will not be allowed to serve others than railroad travelers in the future. The interstate commerce commission has no authority over the conduct of belt lines owned by municipalities even though they participate in interstate shipments.

NARROW ESCAPE IN PASSENGER TRAIN (United Press Leased Wire.) Santa Fe, N. M., July 16.—Great loss of life was narrowly averted in Arroyo Chamez when a terrific cloudburst swept down the canyon and washed out a trestle just before the arrival of a passenger train on the Santa Fe railroad. Today 300 yards of the railroad tracks are missing and hundreds of dead sheep mark the path of the torrent. The cloudburst occurred late yesterday afternoon. A wall of water 10 feet high rushed down Arroyo Chamez and its roar could be heard for several miles. The engineer of a south-bound passenger train saw the flood coming and stopped the train just in time, else it would have been swept away.
