## MEYERS BROTHERS PROTEST

### INTEGRITY IS NOT QUESTIONED

Portland yellow journals have done a serious injury to Henry W. and Milton L. Meyers, of this city, by insinuating that they had anything to do with the disappearance of the box of valuable papers that was lost in shipment between this city and Portland by the Wells-Fargo Express Company. These young men feel, with justice, that their long and honorable business career should have protected them against such newspaper outrages as have been perpetrated against their good name and standing as business men. They have been the victims of constant publicity of a character that does not reflect very highly upon the newspapers that have engaged in it, and a strong reaction is setting in in their favor. While they may have made mistakes in dealing with a very difficult family situation, they have never laid themselves open to the insinuation that they were not good business men and honorable citizens, whose word was good among all men, and whose financial responsibility was of the highest character.

#### Without Foundation.

Any statement that detectives are on their trail, or that they were about to be arrested, as well as the statement in the Oregonian that they had retracted their obligations to their father's marriage, are denounced by them as without foundation. They are absolutely in control of their business, owing every share of stock but two shares, and owing no bills that are not easily to be met in the ordinary course of business. They feel that they are entitled to fair treatment in a community in which they have been active business factors, to the credit of the community, which they have helped to uphold. Before settling the last note due their father the sons say they asked no other indemnification than they would have asked of any other business man under similar circumstances, no more and no less, and to be assured that they would not have to pay the notes again. They cannot see why they should be made the continued victims of sensational journalism when they have not gone into the newspapers, and have tried to avoid publicity as much as possible.
