STEEL TRUST MAGNATE SHOOTS HIMSELF

CONSPIRACY TO SUBORN PERJURY NOT A CRIME IN OREGON

CITY COUNCIL ORDERS MORE PAVING WITH BITULITHIC

Social Committee Appointed to Create Fairmount Park District—Ten Blocks of Improvement Ordered in North Salem.

Double paving was ordered on four blocks—State to Front, Liberty and Cottage between State and Court. A resolution was adopted declaring North Hill creek a ditch on a report of a special committee consisting of Aldermen Lee, Elliott and Fraser.

Improvement of ten blocks in North Salem was ordered. The city council had a very good session Monday night, and passed a lot of business.

A new slaughter house ordinance was passed that contains, among other things, the following regulations:

All kettles must be kept in a separate apartment.

Flies must be stored in a separate room.

Chills must be disinfected and vats and troughs must be scrubbed daily.

For breaking any of the provisions of this ordinance a fine of from \$5 to \$50 may be imposed.

The interior must be thoroughly disinfected each day.

The interior must be thoroughly washed after every killing.

After killing meat must be immediately placed in a storehouse 80 feet from the slaughter house.

An ordinance was passed making the street assessments on North Cottage street, and vacating the street car track on Twelfth street.

The Routine Proceedings.

The Recorder called to order and the Mayor was put in the chair. He made a dignified and courteous pro tempore.

There was a quorum present on the call, Stockton and Waldo being absent.

Warrants were ordered drawn to enforce certain claims. The bill for paving plans of a barn \$10, was allowed to \$5, and allowed.

Bill of M. Ward for investigating quarry, for \$8, allowed.

Street Work Reported.

Report of committee on streets, reported final estimates on lower Main street. On question of cost of drain put in by the Warren Construction company at Twelfth and Main, the council divided, the noon adjourned the day.

Elliott also reported on the city plan, authorizing committee on Main to put in drain tile, water and gas. Carried.

Ratcliff stated that some of the property owners wanted the street 20 or 22 feet wide.

Under new business a petition of such and others for walk on east side of Second street, Pleasant Home avenue, along Englebart property, was read and ordered built. Elliott asked the lumber for this walk had been lying on the ground for over a year, and if this walk was not built would object to the material being used.

Application to raise Swarts building on Commercial street referred to committee on fire and water.

Paris, Oct. 29.—New complications are added to the Abruzzi-Elkins match today, when it became known that if the Italian duke married the American heiress, the proposed match between the Count of Turin and Princess Patricia of Connaught would not be sanctioned by King Edward.

Following the announcement that King Emmanuel had sanctioned the Abruzzi-Elkins match, and agreed to receive the American girl at court as a royal princess, it was discovered that King Edward was trying to prevent the wedding.

LAND FRAUD COUNSEL

CANNOT BE DISBARRED

State vs. Marion R. Biggs, disbarment proceedings, demurrer to petition of State Bar Association sustained.

Biggs was convicted of "conspiracy to suborn perjury," and served a term in jail under sentence of the federal court. State Bar Association brought action to disbar on the ground of this conviction.

Supreme court holds that while the Oregon statute makes perjury and subornation of perjury crimes, it does not make "conspiracy to suborn perjury" a crime, and hence dismisses the suit against Biggs.

JACKSON COUNTY RAPIST

GRANTED STAY OF EXECUTION

The supreme court today granted a stay of execution in the case of State vs. Coss, convicted in Jackson county of rape, and sentenced to seven years at the pen. Judge Hanna refused to grant stay of proceedings until a bill of exceptions could be prepared for an appeal.

Colvig and Reames appeared before the court, and when the order issued wired the sheriff not to leave for Salem today with his prisoner. The appeal will be heard the latter part of next week.

BRITISH SHIP APPREHENDED

VIENNA, OCT. 29.—According to a dispatch received here, an Austrian torpedo boat has arrested a British steamer near Cattaro, for carrying arms and ammunition to Montenegro, and the foreign office here is preparing for direct negotiations with Great Britain over the situation.

The seizure of the British vessel is expected to bring to a head the question of the recognition of the annexation of Bosnia and Herzegovina by negotiations between the two governments, and it is likely that the principal issues at stake in the Balkan situation may be settled before the conference of the powers.

According to information regarded as authentic here today, Turkey has opened negotiations with Austria regarding the annexation of the two Balkan provinces by Franz Josef, and there is every prospect that Turkey and Bulgaria will settle their difficulties.

Tonight the naval cadets, guides and interpreters gave a dinner to the bluejackets. This was one of the most interesting events of the reception. The American sailors had great fun with the Japanese boys, and the dinner was a great success.

Every one is looking forward with much pleasure to the great reception to be given by Admiral Togo tomorrow at the Imperial gardens. These gardens have not been open to the public since the great reception of the heroes of the Russian war.

Great preparations have been made for this reception, and it is expected to be one of the greatest and most beautiful functions in the history of the land of cherry blossoms.

There has been no suggestion of unpleasantness whatever during the visit here, and there is every prospect that the full program of the entertainment will be carried out without the slightest hitch.

AMERICAN SERVANTS WOULD HAVE U. S. INTERFERE

San Francisco, Oct. 29.—A stirring appeal to President Roosevelt by the Servians of this city for intervention by the United States in the affairs of Servia and Austria is on its way to Washington today. At a great mass meeting of the local Servians held last night it was resolved to appeal to Washington to save to Servia the states of Bosnia and Herzegovina from the rule of Franz Josef.

For two hours the excited audience listened to patriotic speeches in their mother tongue, recounting the history of Servia and its right to independence, and particularly to fair treatment at the hands of the European powers.

Hundreds swarmed forward at the conclusion of the meeting to announce themselves as volunteers to return to Servia to fight with her armies against the Austrians. Telegrams were received from all parts of the state, promising financial aid.

Daily scores are joining the volunteer companies that are drilling in several California cities. Among the volunteers are many Americans, who are anxious to join the Servian forces.

SUFFRAGETTES PREPARE TO WAR ON LEGISLATURE

San Francisco, Oct. 29.—The suffragettes of California are preparing today for an extensive campaign to disseminate the literature of their cause. They have started a movement which will culminate in a prolonged siege of the state legislature at its next session. Already headquarters adjacent to the capitol at Sacramento have been secured, and many of the leaders will remain in Sacramento from election day until the last day of the legislative session.

Prominent women throughout the state are receiving letters urging them to join in the movement for equal suffrage, and women lecturers are preparing to tour the state to lay the advantages of equal rights before audiences of women.

It has been suggested by some of the women that several of the suffragettes shall station themselves in the ferry building to sell suffrage pamphlets, and thus incur arrest, in order to advertise the cause.

TOGO'S NEPHEW JAILED

Chicago, Oct. 29.—Glaski Togo, a Japanese, who declares that he is a nephew of the famous Admiral Togo, is preparing today to bring action against the police for what he terms an outrage, because he was arrested for disorderly conduct yesterday. The Japanese is 24 years old.

He entered the Harrison street police station and demanded that a patrol wagon be sent to arrest a man whom, he declared, had assaulted him.

When the desk sergeant asked him who he was and what he wanted, he grew belligerent and threatened to knock the officer over. He was told that if he did not behave himself he would be locked up, and he became more abusive. He was thrown into jail, and later allowed to go.

Togo says he will proceed against the desk sergeant for false arrest.

POLK COUNTY TEACHERS' INSTITUTE CLOSED FRIDAY

Dallas, Or., Oct. 19.—The annual teachers' institute of Polk county closed here Friday after a most successful session. Nearly 100 teachers were registered and a number of prominent educators of Oregon attended. The work was carried on under the department plan and the new system met with much greater favor among the teachers and the institute instructors than the old plan of having the work of the primary, intermediate and advanced departments all carried on at the same session.

ENGAGEMENT IS OFFICIALLY RECOGNIZED

Rome, Oct. 29.—In accordance with the announcement made several weeks ago, the minister of marine today ordered the Italian cruisers Fiermosca and Euria to escort the Duke d'Abruzzi on his return to Italy after his marriage with Miss Katharine Elkins.

The Fiermosca is now at New York and the Euria, which is in South African waters, will sail at once for America.

The announcement is looked upon here as official recognition of the engagement.

It was also announced today that the bridal couple will sail for Italy aboard the cruiser Ethetaea, on their honeymoon.

WASHINGTON STATE WITHOUT SPEAKERS

Seattle, Wash., Oct. 29.—With the exception of Senator Felton, of Oregon, who will speak in Seattle October 31, there will be no National Republican speakers in Washington during the political campaign. Chairman Debruler, of the state committee, had hoped to have Senator LaFollette, of Wisconsin and Senator Dolliver, of Iowa, here during the last week, but LaFollette's western dates have been cancelled, and a telegram received at state headquarters from Joseph M. Dixon, head of the speakers' bureau of the national committee says:

"In order to put Dolliver in doubtful states, and save two days in the West, I have cancelled his dates in Oregon and Washington, and will send him East from San Francisco."

Congressman Cushman and Humphrey, of Washington, will confine all their work to the Pacific slope.

TO URGE REVISION OF PAPER TARIFF

(United Press Leased Wire.)

Duluth, Minn., Oct. 29.—After spending months investigating the wood pulp paper printing industry in Michigan, Wisconsin and Minnesota, the committee of six, appointed by congress to study the conditions, it was learned today, will recommend that the duty on the product be revised. Congressman Mann, who has been most active in the investigation, it is his belief that the committee will recommend a revision of the tariff on Canadian wood pulp and Canadian print, pulp paper. From our investigating it appears that the wood pulp supply in the Northwest will not last many years.

"At the present rate of consumption the supply will be exhausted in Wisconsin and Michigan now many paper mills have nearly all their spruce timber shipped from Minnesota, and it is easy to conceive the result, with the plants of three states working on this timid supply."
