THE KIND OF A MAN THE POLITICIANS WANT.

What kind of a man do the people want for governor? Politicians of both parties in this legislature bitterly complain of Governor Chamberlain's **VETOES OF SALARY RAISING BILLS.**

It is a noticeable fact that the people are not complaining of him.

What is a governor for if not to protect the people against **THE UNRESTRAINED DEPREDATIONS OF A LEGISLATURE?**

Unless a governor sat down hard on miscellaneous salary grabs, the legislature would degenerate into an indescribable bacchanalian orgy, **APPROPRIATING THE TAXPAYERS' MONEY.**

Those who cry out against a veto governor do not realize that such a man in the executive chair is an absolute necessity under modern political conditions and conflicting interests.

MOST PROGRESSIVE STATES IN THE UNION ELECT VETO GOVERNORS.

Those governors veto bills that are put through by selfish interests.

It would not be a crime **FOR A REPUBLICAN GOVERNOR IN OREGON TO VETO A BILL.**

It is perfectly proper for the chief executive of a state like Oregon to use the veto power to curb rapacity in any form, political or legislative.

The attitude of hostility **TO THE LEGITIMATE USE OF THE VETO POWER** on the part of Republicans would probably be the same toward a Republican governor.

For that very reason the people of this state, knowing the temper and disposition of legislatures, **HAVE BEEN SLOW TO GIVE THE REPUBLICANS THAT OFFICE.**

The truth is the people of this state, and large numbers of the Republicans themselves want a veto governor.

A Republican governor who would veto the same bills that Governor Chamberlain has vetoed **WOULD BE EQUALLY POPULAR.**

It is time the Republican leaders got wise to the fact that the veto power has wisely been lodged where it is and has generally been used wisely.

HOP GROWERS BILL CONTAINED A BAD SPOT AND AFTER HEATED DISCUSSION WAS INDEFINITELY POSTPONED--MOTION TO RE-REFER WAS LOST

House bill No. 167, the hop growers' bill, with minority report by Brattain, that it do not pass. An adoption of minority report debate became general. McCue made a plea for the bill. He cited substantial citizens who favored the cause. Prohibitionists had their rights, and so had other people. The people had a right to discriminate. "Let the people rule" was a cry and it had been much resorted to here. If those who advocated that principle would stand for what they believe in, this bill would pass. Buchanan took the other side of the case. He said he would vote for no change in the law. He would put it up to the people to initiate a bill like this if they wanted it, and not enact it here. Mr. McCue asked him if the people drafted the local option law, or the leaders of the Prohibition party? He said he supposed the Prohibition leaders had drafted the local option law. Brady said his county grew no hops, and raised no coyotes, and had no Crater Lake. But he wanted to be broad enough to recognize the rights and interests of others. This bill did put it up to the people. The local option law was passed under false propositions and misconceptions. The legislature had the right to amend this law.

Bonebrake attacked the preamble of the bill, which recited that the brewing interests were boycotting Oregon hops. The liquor interests were laying their hands on this industry and threatening to destroy it if this law was not amended to suit them. He was not attacking the hop industry, but he would not submit to a boycott from any source. The bill was a deceptive one. The people did not object to drinking beer, but objected to the saloon. Where beer was sold all other liquors would be sold. Richardson said it was a question whether the liquor element was to rule this state or not. This bill was to destroy the whole force of the local option law. Calkins said he was a Prohibitionist, and opposed this bill because it was an attempt to amend a system of laws enacted by the people. It would destroy that law. He showed that the bill was so drawn that if a precinct decided at an election, under this bill, in favor of beer or whiskey, it was fixed for all time, and could not be voted on again. That was unfair. Brady said that if that was the form of this bill he could not support the bill. Calkins said that was the fact. Jones moved to refer the bill. Lost. Brattain said if soft drink joints sold whiskey, why would not these beer saloons sell whiskey? If we were to have prohibition let us have it all over. McCue said he could not concede the argument that this legislature had not the right to amend any law enacted by the people. The legislature had time and again amended the laws enacted by the people. The essence of this matter was proper regulation, not theoretical prohibition. It was a farce and a failure in the dry counties, where he had seen young men from 15 to 20 reeling drunk on the streets. He asked the local optionists to give them the same right that they ask for themselves. "But you deny the right you claim for yourselves to those who want to have a separate vote on beer and whiskey. Is that Republicanism? I rejoice that we live in a free country, and I for one want to have this bill go back to the committee and have this clause amended. This feature of the bill was not in the original bill. The minority report was substituted, and the bill was indefinitely postponed.
