## SEATTLE'S HYPNOTIC SENSATION

[United Press Leased Wire.] Tacoma, Wash., March 12.—That Joshua Klein, the mysterious spiritual adviser, who is on trial in Judge Easterday's department of the superior court, accused of attempting to kill Miss Dora Culbertson, is using his hypnotic power to influence witnesses who are testifying against him, was openly charged by Prosecuting Attorney J. L. McMurray and Deputy Prosecutor Burmeister in court this morning.

The charge was made while Mrs. Sauvageot, mother of one of the girls who are said to be held under Klein's influence in Europe, was on the stand and just after she had broken down and exclaimed excitedly, "I can't testify correctly while that man is staring at me with his glassy eyes. Please take him away."

Then turning to the court she appealed earnestly that the man whom she had just accused of threatening her own life, and of trying to kill her sister, be excluded from the room.

The court replied that Klein could not be excluded from the room, according to law, and that, if he were influencing the witnesses the court was powerless to prevent it.

At the opening of court today Mrs. Sauvageot's testimony was commenced where it has been concluded yesterday. Counsel for the defense laid great stress on Mrs. Sauvageot's trip to Amden last year, when she brought Miss Dora Sauvageot back to New York with her. Mrs. Sauvageot said that her daughter wrote a letter to her, in which she told of being forced to remain at Klein's chatlet. The letter, according to her mother, had slipped by Klein, who usually read all the letters sent out from the chatlet.

After the mother had brought her daughter to America, Klein's influence again asserted itself, she said, and the man took her daughter away again to Switzerland.

"Oh, mother, I don't want to go back with him. He has cast a spell on me. If I go away this time, I don't think I shall ever see you and sister again," the girl is declared to have said.

During the recital of this incident Mrs. Sauvageot broke down and wept. While on the witness stand yesterday Miss Culbertson frequently had to think deeply to answer seemingly simple questions. Attorney George asked her if she were ill, or still under nervous stress, and she answered by saying that some one, pointing to Klein, was trying to influence her.

"There is a mental influence coming constantly from that direction. My mind is too strong for him to completely influence it, but he sets me back in my thoughts, and causes me to entirely forget happenings," she said.

## SPEAKER CANNON AFRAID OF HIS JOB
