MILLIONAIRE'S SON FIRED FATAL BULLET

San Francisco, April 22.—With a bullet fired with his own hand still embedded in his brain, Eugene Moore, son of the late millionaire, Davis Moore, of Plainfield, N. J., is still alive at the Affiliated Colleges Hospital in this city.

With the exception of the apparent loss of his sight, and the nervous shock which naturally followed the wound, his condition is close to normal. It is stated today that he had a fair chance for recovery.

The physician is considering an attempt to remove the bullet, and an operation may be undertaken tomorrow.

Troubles with his wife, who was formerly Miss Elma Stewart, of Plainfield, and financial difficulties, are said to have caused Moore to attempt to end his life. Mrs. Moore returned to Plainfield a year ago, and since that time her husband has been living under the name of M. Carter.

TEN THOUSAND IS REPAID FOR HUNDRED

Grass Valley, Cal., April 22.—Captain S. H. Dille, a pioneer resident of this city, is rejoicing today over the news that a loan of \$600 made 50 years ago is to be repaid one hundred fold.

In the early days of California, Dille and William Jester of San Francisco were partners in several mining ventures in this vicinity. After saving \$600 Jester determined to try his fortunes in new fields, and departed for the east after securing the loan of an additional \$600 from Dille.

During the years that have intervened, the men have corresponded, but the loan was never repaid. Yesterday Dille received notice through a legal firm that his former partner was dead. Jester, according to the information received, had gone to Argentina, where he had prospered. A clause in his will provided for the payment of \$10,000 for each \$100 of Dille's original loan.

STATE SUNDAY SCHOOL CONVENTION NEXT WEEK

Salem people will be interested to know that what will probably be the most important if not the largest religious convention to be held in this state this year will meet in Salem next week. This is the twenty-fourth annual convention of the Oregon State Sunday School Association, which is to convene in the First Congregational church Wednesday evening, April 28, and will continue through the 29th and 30th. This convention is made up of delegates from Sunday schools of the various denominations and is undenominational, or inter-denominational in character. About sixty speakers have been placed on the program, and the list includes several of national reputation. A large number of delegates is expected, and the local churches are making arrangements for their accommodation.

This convention will be preceded by the Marion County Sunday School convention, which meets at the Christian church Wednesday, April 28, in the forenoon and afternoon. Several of the speakers from abroad who are to be here for the state convention will be present at the county convention and have places on the program.
