## THE CALL ATTACKS PHELAN

SAN FRANCISCO POLITICAL CIRCLES ARE STIRRED TO DEPTHS OVER THAT PAPER'S ATTACK—CHRONICLE PUBLISHES INTERVIEW WITH YOUNG SPRECKELS

## SHOULD BE IN PEN

Says Spreckels, and Adds, "The Call Charged Phelan With Felony, and Said He Should Be Wearing Stripes and That Is Also My Opinion of Him."

San Francisco, June 28.—Political circles are in a turmoil here today, following the attack on James D. Phelan by the "Call," the charges that the "people's ballot," sent out by the Good Government's League committee campaign bore marks under the stamps on the envelopes, by which the straw voter's identity could be determined, and an interview printed by the "Chronicle" with James D. Spreckels, Jr.

The waiter had not been so observing, for he did not recognize his mother until she went to the retiring room, and asked the head waiter to send him to her.

"Mother," the waiter shouted, and mother and son fell into each other's arms and wept silently for a few seconds.

## CUSTOM OFFICERS CAPTURE OPIUM

## A FIGHT UP IN THE CLOUDS

TWO UNIVERSITY OF CHICAGO STUDENTS HAVE A TERRIFIC BATTLE WITH CARE-TAKER OF THE SUMMIT HOUSE ON PIKE'S PEAK.

## ALL BADLY HURT

Students Are in Jail and Robinson Is Lying in the Hospital Unconscious and May Die—Claim Robinson Attacked Them and They Only Defended Themselves.

Colorado Springs, Colo., June 28.—Battered and bruised and suffering from dangerous scalp wounds received in a midnight death struggle with two University of Chicago students on the summit of Pike's Peak, Howard H. Robinson, government care-taker of the Summit house, lies near death in the St. Francis hospital in this city. The students, John A. Clark and George Shipley, are in jail.

Shipley and Clark, who are on a vacation tour, arrived in this city three days ago. Yesterday they walked to the summit, arriving about midnight.

Weak and cold after their long climb, the men aroused Robinson and were given food. During negotiations for rooms for the remainder of

## HENEY COMES TO PORTLAND

WILL ACT AS COUNSEL FOR THE DAILY NEWS OF PORTLAND IN A LIBEL SUIT GROWING OUT OF THAT PAPER'S CHARGES AGAINST CATTLE MEN.

## ONE IS CONVICTED

Hanley, One of the Men Against Whom the News Made Charges of Fencing Government Land, Has Been Convicted and Fenced Land Thrown Open to Settlers.

Portland, Ore., June 28.—Francis J. Heney, the famous prosecutor of graft, is en route to Portland in an automobile, in accordance with the promise that he made that as soon as the verdict in the Calhoun trial was reported, he would come north to act as advisory counsel for the Portland Daily News in libel suits growing out of charges of land grabbing made by the paper against certain prominent Oregon men.

Henev is accompanied by his wife and physician. They are expected here late tonight or early tomorrow. Since the Daily News published the charges involving William Hanley, the wealthy rancher of Harney county, Oregon, and C. E. S. Wood, his attorney, of Portland, Hanley has been found guilty by a federal court jury on the accusations brought against him by the newspaper.

An appeal which he took is pending.

The stories which offended Hanley and Wood were printed last fall. They accused Hanley of illegally fencing thousands of acres of land in Harney county. The charges were of such a grave nature that the government's legal department in Portland took immediate steps to prosecute the cattle rancher.

Fifty-nine thousand of the 80,000 acres of the government land around which Hanley was accused of building a fence, and driving other ranchers therefrom, were canceled.

After a brief trial, at which C. E. S. Wood acted as counsel for the defendant, Hanley, the latter was convicted. Colonel Wood secured 60 days in which to file a bill of exceptions. When the case is again called it will be determined whether or not he will be granted another trial. It is expected that the libel suits will be brought to trial in September.

All efforts to communicate with Heney failed early today.

## OSWALD WEST HURT

## THREE RIBS BROKEN AND NECK INJURED IN RUNAWAY

Oswald West of the railroad commission is lying in bed today at Corvallis with three ribs broken and his neck badly injured as the result of a team which he was driving on his way to Corvallis from the West farm near that place running away and throwing him and his hired man out onto the hard road.

Mr. West and his man, who is employed on the West farm a few miles from Corvallis, were on their way to town, where Mr. West was intending taking the train for Salem, when a big automobile was met. The horses west was driving were young and fractious, and as the auto passed them they became frightened and started to run. After racing over the road a short distance one hind wheel of the buggy came in contact with some object in the road, throwing the occupants of the buggy high in the air. Mr. West struck the ground in a doubled up position which resulted in breaking three ribs, injuring his spinal cord and otherwise bruising him seriously. The hired man escaped serious injury and at once went for medical assistance. Mr.

West was removed to the Corvallis hotel, where he is now confined to his bed.

Mrs. West was notified as soon as possible and is now with her husband.

## LOST HER POSITION TOOK HER LIFE

Oakland, Cal., June 28.—Christiana Brown, 63 years of age, is dead by her own act, the result of despondency, caused by the loss of a position she held 19 years. The aged woman swallowed the contents of a phial of carbolic acid, and, despite the efforts of physicians, who were hastily summoned, she died late yesterday.

Since coming to this country from Scotland, Mrs. Brown had worked in an East Oakland factory. Old age and illness lowered her efficiency, and she was cut adrift.

## BOY IS CHARGED WITH MURDER

Modesto, Cal., June 28.—Formal charge of murder was placed against Frank Hopkins, the 12-year-old slayer of his brother Theodore, aged 6 years, today by Probation Officer H. K. Pittman. The child's case will be called Thursday by Superior Judge L. W. Fulkert, sitting as a juvenile court.

Young Hopkins maintains his attitude of indifference toward his fate since he confessed that his brother was not yet dead when he buried him in a hog pen, after having shot him in the back with a shotgun.

## OREGON'S GUNS ON PARADE

## MEMENTOES FROM BIG BATTLESHIP AT CHERRY FAIR

There will surely be one feature in the Cherry Fair parade that was never seen before anywhere, and that is the two guns from the good battleship Oregon. These guns arrived here yesterday and are the property of the state. They will be placed on the state house grounds eventually, but in the meanwhile will be a feature in the big parade at the Cherry Fair on the opening day. All Oregon is proud of the wonderful fighting machine that bears, and honors, the name of our state, and every heart grows warm as the great race the Oregon made around the horn, reporting ready for service when she arrived, and of her subsequent work when she raced after the Spanish fleet and at the distance of three miles sent a shot plowing through one of the Spanish vessels. Everybody will be pleased to see these little guns that made part of her armament and they will have the chance July 8.

Another feature that is not yet certain but that may materialize is that the figurehead from the same good ship is likely to be presented to the state, and may reach here in time to be seen in the same parade.

In the meanwhile the committees are all busy and the Cherry Fair carnival is now in splendid shape, with all preliminary arrangements complete. Besides, the cherries are in splendid condition and the exhibit will be the greatest and finest ever shown. If you miss the Cherry Fair you will always regret, so don't do it.

## FAVORS AMENDING THE CONSTITUTION

Washington, June 28.—Senator Aldrich today reported from the senate finance committee a joint resolution proposing an amendment to the constitution to permit the levying of a tax on incomes. The resolution will be allowed to lie on the table until the conclusion of the debate on the corporation tax.

The end of the tariff schedules was reached this afternoon and adjournment taken until tomorrow, when the corporation tax will be considered.

## TWELVE DIE OF HEAT IN CHICAGO SUNDAY

Chicago, June 28.—Twelve persons died in Chicago as the result of heat in the last 24 hours, according to reports made by the coroner early today.

The mercury hovered near 90 degrees all day yesterday and today is just as bad. The thermometer had reached 89 degrees at 9 o'clock this morning.

## STREET RAILWAY STRIKE

STREET CAR SYSTEM IN PITTSBURGH IS TIED UP BY STRIKE AND NOT A CAR IS RUNNING TODAY—COMPANY MAY EMPLOY STRIKE BREAKERS.

## RIOTING IS FEARED

Fourteen Strike Breakers Are Driven From Car Barn by Armed Strikers and a Detective Was Seriously Wounded—Leaders and Managers Confer Without Results.

Pittsburg, Pa., June 28.—Fourteen strike-breakers, employed by the Pittsburg Railway Company, were driven from the company's car barn by a mob of armed strikers today. In a fusillade of shots that were exchanged County Detective Engliert was seriously wounded.

The affair was the first rioting of the strike, and Sheriff Gumbert is distributing forces of armed deputies throughout the city, fearing further demonstrations.

The fleeing strike-breakers were pursued by the angry strikers. Three hundred employees of a construction plant nearby left their work and joined in the pursuit.

## Not a Car Running.

Pittsburg, Pa., June 28.—Not a car of the Pittsburg street railway system is running today. The various lines are tied up effectively by the striking employees, who today reaffirmed their intention to hold out for their demands.

Early today the strike leaders met the officials of the Pittsburg Railway Company in conference. The entire morning was spent behind locked doors, without appreciable results toward a settlement. Mayor Magee today expressed the hope that the strike would be settled amicably and without the violence that characterized the bloody Homestead strike.

In response to a request from President J. D. Caller, of the company, Sheriff Gumbert is prepared to act if violence is threatened. It is rumored that the company's officials are considering the advisability of securing the aid of professional strike-breakers, if an agreement is not reached today.

The strike-breakers, in charge of Engliert and Detective Brown, arrived on a Pittsburg & Lake Erie train at the Rankin station.

Word of their arrival spread rapidly, and a crowd gathered about them, when they started to make their way to the car barn. Leaders of the striking carmen attempted to dissuade the imported workmen from interfering. The men, however, unanimously declared their intention of fulfilling the contract under which they were brought to the city.

As the men under Engliert and Brown reached the car shed some one in the crowd of strikers discharged a revolver. The strikers rushed the little party, that had taken refuge in the barn, and a pitched battle followed.

The strike-breakers put up a stubborn fight, and many of them received painful injuries. When they were driven from the barn, they were met by a shower of bullets.

## THROUGH TRAINS CHICAGO TO SEATTLE

Portland, Or., June 28.—The first Harriman train to be operated between Portland and Seattle over the joint line of the Northern Pacific and the Union Pacific will be placed in service one week from today, according to the present plan of the Harriman officials.

The train is to be a new limited between Chicago and Seattle, and the tentative plans of the Harriman system provide for a stop in Portland. J. D. Farrell, general manager of the Oregon & Washington railroad; E. E. Ellis, general agent of the Harriman lines at Seattle, and Robert Lee, general agent at Tacoma, are in Portland today to meet with General Manager J. P. O'Brien and Assistant General Passenger Agent John M. Scott, General Passenger Agent McMurray in Chicago, arranging the eastern end of the deal, whereby the Harriman lines will have a through train between Chicago and Puget Sound.

Mr. Scott said he was not ready to make any announcement of the plans for through trains yet. However, it is known that the competition for business to the Northwest is growing keener, and that the Harriman lines realize that the only way they can keep up their end is to run through Chicago-Puget Sound trains.
