**TOTAL ONE BILLION:
ONE MINE \$350,000,000**

An inquiry sent to The Journal horse editor asks: "The total production of the Comstock mines in Virginia City, Nevada, and what mine was the greatest producer."

The first question is impossible to answer, because no one knows. In the earlier days vast sums were taken from the mines while they were in the hands of individuals, or close corporations. The lowest estimate, however, is \$600,000,000. In fact this can hardly be called an estimate, but rather the absolutely known production. Another factor is the "Union Mill and Mining Co.," which was owned by the leading men in the mines, and which worked the companies' ores, under contracts let by themselves. As they all got rich on the "unearned increment," in the shape of "tailings," which belonged to the mill company, a vast amount was never put on the books to the credit of the mines. Those who have studied the matter closely, old Comstock miners, place the total yield above \$1,000,000,000. In answer to the second question, the Consolidated Virginia (which included the California) produced, as its books will show, and not counting rake-offs by the mill company aforesaid, \$335,000,000. The larger portion of this was taken out in four years.

COURT OPENS, JUDGE HAMILTON PRESIDING

Judge Hamilton of the Second judicial district opened department No. 1 of the circuit court for this county this morning, having changed benches with Judge Burnett, who is holding court this week in Corvallis. This change was made principally in order that the long fought suit of Catlin & Linn vs. W. S. Jones could be tried again. This case has been tried twice before Judge Burnett and each time the decision was reversed.

There were two arraignments made this morning, they being the cases of the State vs. A. B. Smith and State vs. George Mason. Attorney W. M. Kaiser appeared for Smith and on the consent of District Attorney McNary was given until Wednesday at 9 a. m. in which to plead. Smith has secured the services of four attorneys to defend him—W. M. Kaiser and M. E. Pogue and Carson & Brown. Smith's physical condition has improved considerably within in the past few days and although being somewhat weak, he is able to get about with assistance.

George Mason, the other party arraigned, is charged with selling drugs without a registered permit, but owing to a request from the state board of medical examiners, District Attorney McNary consented to postpone the trial after Mason had pleaded not guilty, until the next regular term of court.

Five applications for admittance to citizenship were granted this morning. They were: Richard Lowenfeld, a native of Austria; Peter Swann, Sweden; George A. Johnston, Canada; Chris Peterson, Denmark, and James Westery, England.

THREE ARE INJURED IN FRISCO FIRE

Score of Occupants Have Close
Call—Property Damage
About \$55,000.

San Francisco, July 12.—Three firemen seriously injured, one of them probably fatally, and a score of occupants of a rooming house narrowly escaped death early today when a block of wooden buildings in Clement street between Sixth and Seventh avenues was destroyed by fire. The property loss is estimated at \$55,000. J. C. Christie, in whose butcher shop the fire originated, was summoned to police headquarters this morning and questioned as to the cause of the blaze.

The injured firemen are Lieutenant Michael Drury and Hosemen Edward McGonigle and Louis Andrews. Drury and McGonigle were crushed by a falling wall, and Andrews received probably fatal injuries when he came in contact with a high power electric wire.

The buildings were the property of the Sault Real Estate Company. They were occupied by W. R. Kennerly's rooming house, the Sault Company's offices, Christy's butcher shop, Harris Bros. shoe store, the Olympia restaurant, Prague & Green's saloon and H. F. Allen's shoe store.

It is said he became jealous because of the attention the young woman was paying to other men, and pulled a revolver from his pocket, same time threatening her. The stenographer tried to get possession of the weapon, and it was accidentally discharged. Schegelmilch and the girl recently came here from Boston. He was superintendent of the Bohannon Bar Placer Company at Salmon.
