Investigating Municipal Grifts.

Chicago, April 27.—The Merriman commission investigating charges of graft in municipal affairs is today preparing to prosecute further the counts already uncovered indicating that the city has lost more than \$55,000 within 20 months through crooked transactions in coal.

Forgeries of coal contracts, mutilations of coal records, payments for thousands of tons of coal that, so far as the bookkeeping shows, were never delivered, disregard of specifications and double payments when coal was transferred from one city department to another, are some of the counts listed by the commission.

INVITED TO JOIN DEMOCRATS

SENATORS BAILEY AND RAYNER EXTEND INVITATION TO INSURGENTS TO JOIN DEMOCRATIC PARTY—SAYS THERE IS NO DIFFERENCE BETWEEN THEM NOW.

Washington, April 27.—Republican insurgents in the senate were invited to join the Democratic party today. The invitation was extended by Senator Isidor Rayner, Democrat, Maryland, and was seconded by Senator Joseph W. Bailey, of Texas.

Senator Rayner was speaking on the administration railroad bill when he tendered the invitation.

"There is scarcely any difference between us now," he said, after asking the insurgents to become Democrats, "if we eliminate all non-essentials."

"Are the insurgents in sympathy with us, or they merely flirting with us? We are growing weary of being embraced, only to be rejected when the supreme moment comes."

Later Senator Dolliver, speaking on the same measure, gently declined Rayner's invitation on behalf of the insurgents, of whom Dolliver is a leader.

Senator Rayner began his speech with an attack on the constitutionality of the railroad regulation bill. The insurgents have vigorously attacked the measure and demanded a number of amendments. After speaking of the insurgent attitude on this measure, he declared it was identical with the belief of the Democrats, and suggested that they join forces.

Senator Bailey, who followed, declared that political gravitation would compel the insurgents and the Democrats to join each other sooner or later.

He declared the Republican party was torn with internal strife, and said: "You are not strong enough in any state or in any district to fight the Democrats and each other at the same time."

Senator Dolliver, in his reply, declared that the insurgents were merely fighting wrong in their party to eliminate corporation control.

"We will fight wrong in the Republican party, not to injure the party, but to destroy control by special interests that now dominate the party," Dolliver declared.

"The insurgents," he said, "had sympathy with the Democratic party, but little confidence in it."

"The present political evil," he continued, "is that a few men have grown so strong that they are knocking the heads of the two old parties together."

"The party of the future will be based on Lincoln's doctrine of an unfettered start and a fair chance to every man."

Canal to Be Opened in 1914.

Washington, April 27.—The Panama canal will be opened early in the year 1914, according to the highest official authority here today. The same authority, however, refused to change the official announcement that the canal will be opened in 1915 because of the possibility of an unforeseen delay causing a postponement.

MAN WHO FLIRTS WITH DEATH WANTED.

San Diego, Calif., April 27.—Detectives in an auto are searching the country surrounding the village of Sorrento, just north of here on the Santa Fe railroad for a well dressed stranger who has been flirting with death to the consternation of the ruralists in that vicinity for the last two days.

The man takes delight in waiting on the Santa Fe track for the approach of a train. He holds his ground until the train has almost struck him and then dives head first from the roadbed and laughs.

He seated himself in the aisle of the track on his suit case yesterday. He sat there until a passenger engine was within a few yards of him when he rolled off the track. His suit case was run over and his effects scattered along the track. He has refused water and food offered him by the ranchers and villagers and remarks with apparent delight that he is going to starve himself.

ELECTRIC CHAIR FOR WOLTER

New York, April 27.—Albert Wolter, convicted of the murder of Ruth Wheeler, was today sentenced to be electrocuted at Sing Sing during the week beginning June 6. Since the jury returned a verdict of guilty, Wolter has been waiting apparently unmoved for Judge Foster to pronounce the verdict.

Today he was taken to the court and Judge Foster delivered the sentence.

Ruth Wheeler, a young girl, according to the evidence, answered an advertisement calling for a stenographer. It is declared she went to Wolter's room.

Her body was afterwards found mutilated and charred. Part of it was in a grate, and part on the fire-escape outside his window.

A woman who lived in his apartments told of having heard Wolter busy about the fire place on the night it was supposed the murder was committed.

Wolter's defense was an attempted alibi.

BLUE STOCKING BILL MAY PASS

Rockford, Ill., April 27.—Rockford bettors are laying two to one today that the proposed ordinance for a "blue stocking" regulation of all saloons here will be passed at the meeting of the city council Monday.

The ordinance provides for the abolishment of all articles of furniture in saloons, with the exception of the bar and fixtures, and stools for bartenders. Any other furniture, such as screens, tables, chairs, settees and the like, that might lure the thirsty to linger, are forbidden.

Liquor is not to be sold on credit nor are checks to be accepted in payment for drinks.

The sign "No Treating Allowed" is to be placed prominently in every barroom, and its rule enforced.

Women, minors, drunkards and blacklisted persons must not frequent saloons, nor must they be served with drinks.

Applications for licenses must be made individually, and not under guise of agents for breweries.

POOL ROOM OPERATOR IS ARRESTED

San Rafael, Cal., April 27.—Jos. Abbott, charged with having operated a fake poolroom at Sausalito for the purpose of swindling race track bettors, confessed to the grand jury here this afternoon his participation in operations of a gang of wire tappers, according to District Attorney Boyd.

Abbott, Boyd says, implicated Police Commissioner Harry Flannery, of San Francisco. The alleged connection of Flannery with the case, based on Abbott's confession, is that Flannery is said to have invited the wire tappers to San Francisco, assuring them in ambiguous terms of an opportunity of plying their trade.

District Attorney Boyd would not give out the details of the confession nor would he disclose whether the authorities here would take action against Flannery.

According to the authorities here it is alleged that Flannery sent a telegram to Abbott at Seattle shortly after the recent San Francisco municipal election. It is believed to have said that the people had won a verdict and were free.

PAULHAN IS AFTER BIG PRIZE

LEFT HEMSTEAD THIS AFTERNOON — PASSED BERKHAMSTEAD AND WAS FLYING AT GREAT ALTITUDE — CROWDS CHEER HIM WILDLY.

London, April 27.—Louis Paulhan started from Hemstead at 5:22 o'clock this afternoon for Manchester in an effort to win the \$50,000 prize of the London Mail. Paulhan is sailing in a Farman biplane. Claude White, the aviator who made a long flight Saturday in an effort to win the prize, will sail later today. His start was interrupted by high winds.

Forty-five minutes after his start, Paulhan passed Berkhamstead, 28 miles from the place where he started. He is flying at a great altitude.

Just an hour after the start he passed Blotchley, 47 miles from the starting point.

A great crowd assembled at Hemstead the London suburb from which the start was made. The people cheered wildly as the Frenchman sailed away. Many persons tried to follow in automobiles.

Paulhan shipped 16 gallons of petrol and expected to make the flight to Manchester without descending. By the terms of the Mail's offer, the aviator is allowed two descents.

SILVER LAKE RAPIDLY RISING

FEARED THAT IT WILL CAUSE A FLOOD LIKE THE SALTON SEA, WHICH DESTROYED PROPERTY VALUED AT MILLIONS.

San Bernardino, Calif., April 27.—Tracks and roadbed of the Tonopah and Tidewater railroad north of Ludlow, Calif., are threatened by the rising waters of Silver Lake, according to reports received here today. The message stated that the waters are rising so rapidly that levees are being built to protect the roadbed and a powerful pumping plant will be installed to remove the excess flow.

Silver Lake is the point where the Mojave river rises to the surface after running underground for 50 miles. It is feared that it may cause a flood similar to that of the Salton sea which destroyed millions of dollars worth of Southern Pacific property in southern California.
