**COMMISSION SIXTY TWO YEARS OLD**

SHERIFF MINTO HAS THE COMMISSION OF WILLIAM HERREN AS SHERIFF OF MARION COUNTY FRAMED IN HIS OFFICE.

Sheriff Harry Minto is the proud possessor of what is, if not the oldest, at least one of the oldest commissions ever issued in the state, or rather, territory of Oregon. It is that of William Herren, who was elected sheriff of Marion county on the first Monday in June, A. D. 1850. Ed. Herren in looking through some old papers of his father's, came across the document, and asked Harry if he would like to have it.

"Sure," was the quick reply, "and I will frame it and hang it up in the office."  
This he proceeded to do—and the venerable document now has a place of honor in the sheriff's office.  
It is as follows:  
Oregon Territory  
Marion County  
Kintzing Pritchette,  
Acting Governor of Said Territory.  
To William Herren, of the County of Marion, Esquire.

Sends Greeting:  
Whereas it appears from the returns of the election, held in and for the county of Marion, on the first Monday of June on the year of Our Lord one thousand eight hundred and fifty, that you have been chosen by the citizens thereof, sheriff of the said county of Marion.

NOW KNOW YOU: That I have commissioned and by these presents commission you the said William Herren, to be sheriff of the said county of Marion, with the appurtenances, and the peace, within the same, to your care and defence; authorizing and commanding you, the said William Herren, to do and perform all the several acts and things, in the county of Marion, that to the office of sheriff, according to the laws of said territory, do in anywise belong.

To hold, exercise and enjoy the said office, with all the rights, fees, perquisites, emoluments and advantages from thence lawfully accruing, or thereunto of right appertaining, for the term of two years, to be computed from the first Monday of June, A. D. 1850, and until your successor be duly qualified.

Given under my hand and the Great Seal of the Territory, at Oregon City this tenth day of July in the year of Our Lord one thousand eight hundred and fifty.

**CIRCUS IS BIGGEST OF THEM ALL**

Walter Murphy, general contracting agent of the Sells Floto Circus, which comes here on May 30, who was a visitor recently, speaking of the big attraction which made such a universal hit in the Northwest last season, said:

"Five years ago a director of amusements who prophesied an era of popular prices, such as we are having in the theatrical world today, would have been rated as being nothing short of a lunatic. But strange things happen as the wheel of time turns, so that today we find people demanding more for their money than ever before in the history of the world, and proprietors of attractions seeking to meet that demand. Perhaps the exception to this has been the circus, and barring one instance, all the old line shows adhere to the scale of prices which prevailed two decades ago.

The management of the Sells Floto Circus, however, for the past three seasons, has inaugurated a new policy, no doubt believing that in doing so, they could retain and hold the greater portion of public patronage. When the simple statement is made that we have cut the regular price, which from time immemorial has been the rule of the circus, in half, few people stop to consider what this means in the regular totaling of the season's receipts. But coming right down to figure, it shows a primary discrepancy of almost \$100,000, when compared with the sum total of a season at the old price.

Considering the fact that it costs more than \$3000 a day to operate a big amusement enterprise of this kind, one can get some idea of the risk involved when the management of the circus decided to cut the admission to 25 cents. All their rivals in the circus business expressed the opinion that such a feat of financial jugglery could not be successfully carried out, but the last three years have proven that these people builded wisely, and that from an intensely business standpoint, was possibly the wisest move they could have made. The records show that the attendance has been more than doubled and that it is possible to give more now at the cut price and to enlarge the performance in every way than it was under the old system.

This season the 25-cent tariff will be enforced everywhere the Sells-Floto Circus appears. The admission price admits patrons to the big show in its entirety, and there are seats for 10,000 purchasers of these tickets. The management followed with the statement that there is absolutely no deviation from this rule. We carry no so-called "accommodation wagons" where a greater sum is charged.
