TAFT REPUBLICANS ARE SHUT OUT PROGRESSIVES BEAT THEM TO IT

NAMES ON ITS TICKET FOR PRESIDENTIAL ELECTORS ARE FILED AS REPUBLICANS

Roosevelt Followers Controlled the Convention and the Taft Supporters Bolted--While the Taft Men Were Considering Their Action the Roosevelt Wing Named Their Presidential Electors and Filed Them, Making Them the Republican Electors of California--Governor Johnson's Father Says He Will Vote the Democratic Ticket.

Sacramento, Cal., Sept. 26.—It developed here today that filing of the names of its ticket of presidential electors in the office of the secretary of state by the Roosevelt convention was accepted, while the Taft delegates were still delaying their bolt. When the Taft men did get together in the evening and endorsed their own list of presidential electors, they discovered that they were the second party to claim the name Republican on the ballot.

Notable differences between the Roosevelt and the Taft platforms, aside from their endorsement of their respective national tickets, are the Roosevelt declaration for a program of social and industrial justice and the Taft demand that the San Francisco harbor control be given by the state to

the city government. The pledge of social and industrial legislation proposed by the Taft platform is modified by a pledge to promote legitimate business.

A feature of the Taft convention was the speech of Grover L. Johnson, father of Governor Hiram Johnson, who said he probably would vote the national Democratic ticket in order to "wipe out these bull moosers."

Freed from the discordant presence of the 13 Taft delegates who withdrew when the majority had endorsed Roosevelt and Johnson, and had repudiated Taft and Sherman by a vote of 89 to 14, the Roosevelt Republican convention adopted its platform yesterday afternoon without a dissenting vote and then nominated the new state central committee, on which there are five women.

END OF THE REBELLION IS IN SIGHT

GENERAL OROZCO'S OFFICERS ARE DESERTING HIM AND SEEKING SAFETY ON THIS SIDE OF THE RIO GRANDE

El Paso, Tex., Sept. 26.—Early collapse of the Orozco rebellion in Mexico is seen in advices received here today which say that General Salazar, one of Orozco's chief lieutenants, has deserted his command and fled to the United States, crossing the border immediately south of Douglas, Arizona. Several days ago General Emilio Campa, another of Orozco's trusted men, deserted the rebel cause, crossing to the United States, where he was arrested by American troops. In addition to Campa and Salazar, Dr. Isidro Huerta Joaquin Equira and Jose Escandon, all rebel leaders, have deserted, coming to the United States for safety.

Fell 100 Feet.

SITUATION IN EUROPE IS TENDING TO WAR

WILL PUT UP A FIGHT AGAINST THE SINGLE TAX

Resolutions were passed by the legislative tax committee which held a session here yesterday afternoon in which the members declare themselves as unalterably opposed to the graduated single tax, which the people will vote on at the coming general election.

The committee also decided to wage an effective campaign against the measure, and in behalf of the measure which it has submitted to the people, and which they will have an opportunity to vote on when they go to the booths this fall. The plans call for a campaign embracing much publicity, and those interested in seeing the legislative tax committee's measures passed, and the single tax measures defeated will be asked to contribute to defray the expenses of the campaign.

Are Trailing Wilson.
New York, Sept. 26.—A corps of Republican speakers, domiciled in a special car, are on the trail of Woodrow Wilson in New England today for the purpose of answering the Democratic presidential nominee's tariff talk. Among those in the party are Secretary of Commerce and Labor Nagel, Congressman Gillett, of Massachusetts and former Governor Usher of Rhode Island. They plan to keep a day behind Wilson throughout the trip.

BIG SENSATION EXPECTED WHEN BIG MONEY KING TELLS HOW MUCH FINANCIER PAID

He Will Be Asked to Tell How Much Money the Trusts in Which He Is Interested Contributed to Both the Democrats and Republicans in the Last Three Campaigns--C. C. Togethoff, Secretary of the Late E. H. Harriman, Must Also Tell How Much Money Harriman Contributed and Who Got the Money.

Washington, Sept. 26.—J. Pierpont Morgan, of New York, the world's greatest trust organizer, and principal stockholder in America's strongest private banking institution, will be the first witness to testify when the senate campaign contributions investigating committee resumes its hearings here next Monday. The money king will be asked how much money the trusts in which he is interested have contributed to both the Democrat and Republicans in the last three campaigns.

Morgan's testimony is expected to develop the biggest sensation since John D. Archbold, president of the Standard Oil company, and Senator Penrose, of Pennsylvania, in testifying recently before the committee, swore that the oil trust contributed \$125,000 to the Roosevelt campaign for the presidency in 1904.

Another important witness to appear Monday will be Cornelius Bliss, Jr., whose father was treasurer of the Republican national committee in 1904, and to whom the Standard Oil company's contribution is alleged to have been made. The elder Bliss has been dead some years.

Harriman's Secretary, Too.
C. C. Togethoff secretary to the late E. H. Harriman, the railroad wizard, will also testify Monday. He will be asked what contributions, if any, Harriman made to the Republican campaign in 1904, and to explain the interest the latter is said to have taken in the political situation in New York during his campaign.

Ormsby McHarg, of Chicago, who argued the Roosevelt contest cases before the Republican national committee at Chicago in June, also is expected to testify Monday. It has not been developed just what the committee expects to learn from McHarg.

Interest also centers in the testimony to be given by Bliss. He will produce his father's papers and records bearing on the 1904 campaign, which are still intact. These are expected to show whether the Standard Oil company did pay \$125,000 to Treasurer Bliss in 1904 for Roosevelt's

**HE ADVISES
TAKING A BATH
OR TWO DAILY**

Washington, Sept. 26.—In addressing the International Congress of Hygiene and Demography in session here today, Dr. Woods Hutchinson, a writer on medical subjects, declared: "No man woman or child should neglect to bathe at least once a day. In fact cold baths or cold plunges ought to be taken twice or three times daily. No one ever caught cold through too frequent bathing. Really the only virtue in the bath is the stimulating effect imparted and the only real danger lies in having the skin too hot or the use of too much soap. Frequent bathing at home never injured any one's health as colds do not come through the pores, the mouth and the nose are the only parts of the body through which they are transmitted."

"Some folks have contended that they caught awful colds after emerging from a Turkish bath. Certainly, but the cold was communicated not from the effects of the bath, but from the thousands of germs pent up in the room and kept alive by the steam. These rooms are seldom ventilated, so that the occupant before, who may have had any disease, leaves the germs behind."
