Defeats Jimmy Fox in Sixth Round of Scheduled Ten-Round Fight at Oakland.

Oakland, Cal., June 11.—Johnny Kilbane, of Cleveland, Ohio, featherweight champion, defeated Jimmy Fox, a local boxer, here last night in the sixth round of a scheduled ten-round fight.

Fox was outclassed from the start, and in the sixth his seconds appealed the clamor of the crowd by throwing a towel into the ring. The fight was at catch weights, and the men entered the ring at about 124 pounds.

Kilbane landed his jabs and punches at will, while Fox displayed little skill and no punch.

RITCHIE AND RIVERS SIGN
FOR CHAMPIONSHIP BOUT

San Francisco, June 11.—Willie Ritchie, lightweight champion of the world, and Joe Rivers, of Los Angeles, challenger, late yesterday afternoon signed articles to fight 20 rounds for the championship in this city on the afternoon of July 4.

The men agreed to fight at 134 pounds ringside. The articles stipulate that the men must be in the ring ready to fight within 25 minutes after weighing in, failure to do so carrying a forfeit of \$1250. The forfeit for not making the weight is fixed at \$2500.

It is further agreed that the referee must be selected within ten days before the contest.

AMERICA DEFEATS ENGLAND
IN FIRST POLO MATCH

Whether Covaleskie's stay in the minors has helped him any will be seen shortly as he is to report to the Browns at once. If the Pole has been cured of stage fright he will be a winner.

A correspondent traveling with the Athletics claims that Cobb was squarely struck out in the game of May 20, before he made the hit that won the game for Detroit. The correspondent adds: "Greater liberties are permitted Cobb by umpires and teammates than are accorded any player in the game. Any other batter but Cobb, Umpire Connolly could not help but call him out but the feeling that Cobb must be given immunities and privileges denied to all other players has apparently influenced every one with whom he comes in contact. When Cobb rushes over into left field after an easy one for Veach, Jennings pats him on the back, while Cobb laughs at the disgruntled player who has been shown up by T. R.'s speed before the crowd."

The success of Cy Falkenberg who has pitched and won nine games for the Cleveland Naps, is an incentive to all

of the big league pitchers. Falkenberg is a comeback and is the sensation of the league thus far. He is playing on a team that has an excellent chance to win the flag in the American league because they are the heaviest batters. The Naps are not beaten until the last man is out. This was proven in a recent game at St. Louis. The Naps started the ninth inning in the rear by four runs, but heavy stick work turned defeat into victory.

Larry Lajole is back in the harness to help the fighting Naps in their future efforts to subdue the American league teams who claim that brawn and brains is responsible for the showing of the Cleveland team. The team is hitting stronger than any team in the circuit by 30 points and is ahead of the National league's best hitters which to date are the Cardinals. The one weak point of the Naps is believed to be on the path. Granting that they are weak there, a team that can slug the ball will fare better than the best base runners on any team, providing the latter are weak sisters with the willow.

SOUTHERNERS KNOW
NOTHING OF JULEP

United Press Man Gets Distinct Shock When He Inquires in Regard to Drinks.

Washington, June 11.—Dropping for the once the colossal affairs of state that occupy the major portion of his time, the United Press correspondent the other day poked around the Capitol building trying to find out whether the kind of mint juleps Col. Roosevelt said he occasionally imbibed while president were properly mixed. Henry Pickney, the negro factotum, who used to mix 'em, using greens from the White House mint bed, left behind his recipe, and it called for crushing of the mint.

Now the United Press correspondent used to live in the south years back, and he knew by reputation—purely by reputation—that the true julep isn't made by crushing the mint leaves. He thought himself that it would be a fine thing to get some southern congressman to "stand" for an interview roasting the late Henry Pickney for committing the crime of crushing the fragrant leaves.

But a distinct shock awaited said correspondent for he discovered nary a southern congressman who knew a darn thing about the mixing of juleps. A lot of them admitted drinking one occasionally, but there wasn't a one who knew exactly how to prepare the drink. Finally, in desperation, the correspondent found out that "Gunsloe Bill" Stone, of Missouri, had some ideas on the subject, and he came the nearest to giving what the correspondent remembered was the recipe of a famous darkey in Bowling Green, Ky., whom tradition says first invented the mint julep.

Where has the glory of Kentucky gone? None of the blue grass statesmen knew anything about the concoction of that alcoholic divinity, the julep. Moreover, the few who had tasted 'em declared they preferred their liquor straight. Only an elevator man, a "southerner" from South Dakota, went into ecstasies and repeated some poetry about mint juleps—and as poetry goes in South Dakota it was pretty fair.

Half of the congressmen looked frightened when the julep was mentioned. Most of them carefully looked around the corridor before they replied, and made answer in a whispered undertone: "For heaven's sake, don't mention my name in connection with that julep story. Such and such counties in my district are dry; and such and such others are wet, and I'm having the devil's own time trying to keep in with both camps."

"I haven't had a drink in a whole year," one Kentuckian confided with tears in his voice. Rep. Thomas, of the Blue Grass state admitted he had once—just once, mark you gentle reader, and he from Kentucky—tasted a mint julep. Representative Crisp, of Georgia, said he had tried the drink. Both declared they didn't like 'em.

"I had mine at a banquet in Louisville," explained Thomas. "Really I didn't like it." "My wife mixes the few juleps I take," remarked another southerner, who wanted his name to be kept secret. "I don't know how she makes 'em." "I've got a nigger boy at home who knows how—I don't question his recipe," said another.

To sum up, ninety per cent of the southern congressmen don't know what a julep is, six per cent have never tasted one, and four per cent have a vague idea that it contains sugar, whiskey and mint. An ex-slave bartender at a famous Pennsylvania avenue emporium, over a frosted glass gave the following recipe:

One lump of sugar, wetted with water so that it just begins to crumble, is placed in a silver cup. It must be a silver cup. Over this is poured a good "slug" of whiskey. Half a dozen tender mint leaves are placed in the liquid and the mixture is stirred thoroughly, great care being taken NOT TO BRUISE THE MINT LEAVES. Then this mixture is poured into a tall glass

tumbler, and a handful of fine chopped ice added, and the drink is stirred again. Finally some more ice is added, and the top garnished with sprigs of mint. If desired, some pineapple, maraschino cherries, or other fruit may also be put on the top. A straw is stuck through the ice, and he who drinks the julep must bury his nose in the mint as he sucks the beverage through the straw.

Will Invade the Sea

Washington, June 11.—Within a short time the United States will step in and wrest the naval supremacy of the Mediterranean sea from European powers which have been contesting it for years. It will be a bloodless, fightless invasion. When the eight dreadnaughts, thirteen pre-dreadnaughts and other naval craft flying the stars and stripes sail past Gibraltar for their cruise in Mediterranean waters, the fleets of France, Italy, Austria and Great Britain will be overshadowed for once, and for the time being, the United States will be supreme in those waters. A tentative itinerary of the fleet, announced at the navy department today, arranges for a stop at almost every Mediterranean port where formal welcome by the respective authorities awaits the Yankee officers and sailors.

Big Order for Shoes

WASHINGTON, June 11.—The navy department, after an exhaustive investigation of the best shoes for men in the service, today authorized the purchase of an extra 100,000 pairs of shoes for the men of Uncle Sam's ships. The style shoes ordered today were selected only after they had been thoroughly tried out and great satisfaction had been expressed by officers and men. The pattern has proved so popular that the navy department officials have experienced difficulty in supplying the demand that has risen throughout the rank and file of the navy. The value of the first award, it was announced today, was approximately \$300,000 and it affords a striking example of the gigantic scale upon which the navy department does its shoe buying.

Verdict in Woman's Case

Epsem, Eng., June 10.—"Killed by misadventure," was the verdict of a coroner's jury here today in the case of Miss Emily Davison, the suffragette fatally injured during the derby when she seized the bridle of King George's horse, Anmer, and went down beneath its hoofs. The jury took no cognizance that the King's horse killed the woman. Vast throngs attended the inquest, including hundreds of militant suffragettes whose sleeves bore mourning bands.

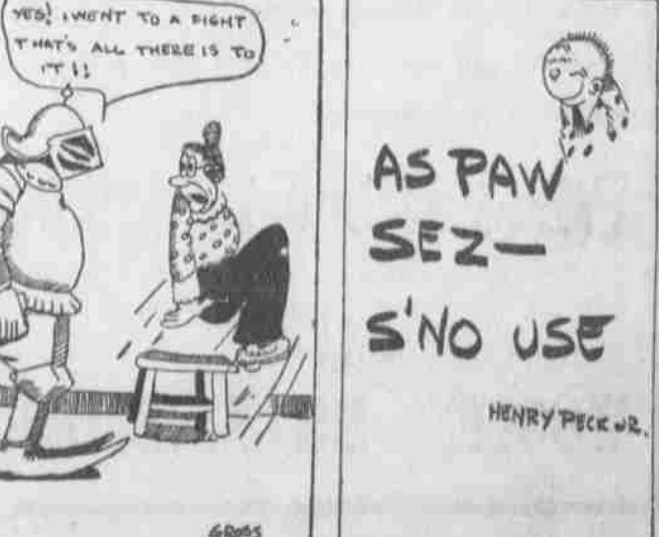
