

DELINQUENT TAX LIST OF MARION COUNTY FOR YEAR 1912

This advertised list of delinquent taxes for the year 1912, for Marion County, State of Oregon, is in pursuance of an act of the state legislature which is embodied in Chapter 275 of the General Laws of the 1911 Session. The taxes on the following advertised real property became delinquent on April 7th, 1913, and are subject to a penalty of 10 per cent and interest at the rate of 12 per cent per annum, and the cost of advertising, until paid.

Any day after the expiration of six months after the taxes charged against the following real property are delinquent, the sheriff is authorized upon demand of any person making application to issue to them a certificate of delinquency upon payment of the taxes, penalty, interest and cost of advertising. Certificates of delinquency shall bear interest from the date of issuance until redeemed at the rate of 15 per cent per annum.
