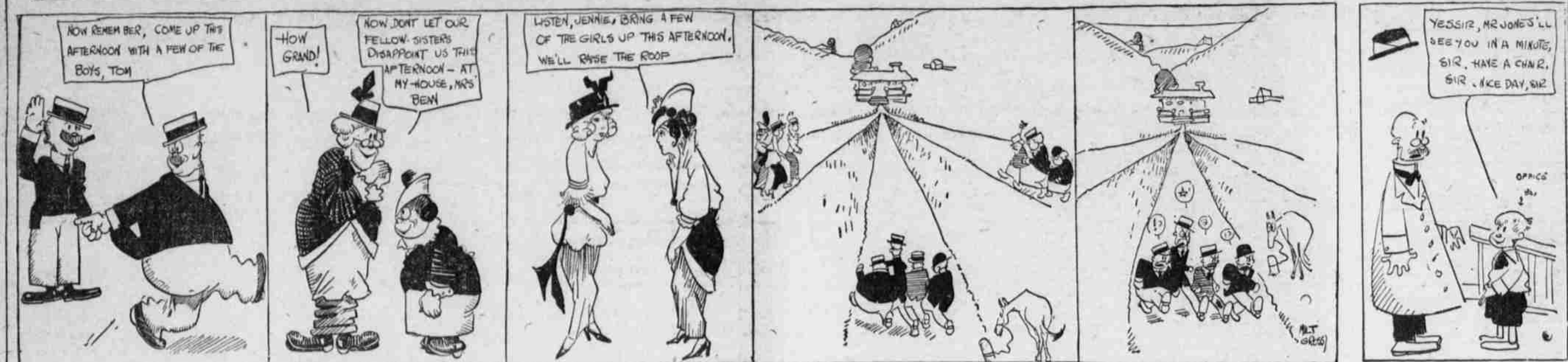

EUGENE CORRI LIKED AS FAIREST FIGHT REFEREE

Bob Edgren, Sporting Writer, Talks of Man Who Is To Officiate at the Ritchie-Weish Fight.

BROKER FOLLOWS BOXING AS AN ARDENT AMATEUR

Englishman Is Training His Boys to Box Just as Soon as They Are Able to Walk.

New York, June 13.—Bob Edgren, sporting editor of the New York World, says Eugene Corri is an honest referee. In a recent article Edgren has the following to say of Corri.

"When Tommy Burns went to England to fight Ginner Moir he asked me who was the fairest referee in England. Although there are many fair referees, I happened to know Eugene Corri well, having gone to many fights with him in England and visited at his country place. I knew that Corri knew at least as much as any other man in England about boxing and that there was no fairer and more determined referee in the world. So I recommended Corri. And afterwards Tommy Burns told me that Corri was the best referee he ever saw in a ring. Corri was literally 'in the ring' for he was the first English referee to break through the red tape of ancient custom and officiate within the ropes.

"Since Tommy Burns' trip many other American boxers visiting England have made Corri's refereeing a condition of their matches, and the result has always been satisfactory. Eugene Corri wouldn't give either man in the match the slightest unfair advantage under any possible circumstances. The fact that a world's championship title went with his decision, and that one contender was an American and the other an Englishman, would have no more influence on Corri's judgment than the color of the announcer's coat.

"Corri is an old member of the National Sporting Club, and a real amateur in boxing. He doesn't referee for money. He is a broker and follows boxing just as some enthusiasts follow golf, others trotting horses. He has a family of boys and each one is being brought up like Georges Carpentier, the Frenchman, who was taught to box as soon as he could lift a boxing glove."

SALLY SALVADOR HOLDS THE FAVORABLE DECISION

San Francisco, June 12.—Sally Salvador of Sacramento today holds a decision over Willie Hoppe of San Francisco as a result of their four round contest here last night. The Sacramento outfighter Hoppe at every angle of the game and there was not a dissenting voice when Referee Harry Foley raised Salvador's arm in token of victory.

It was evident that Hoppe either has not recovered from the recent illness that caused him to take a long layoff, or that he is never to be as good as formerly. His judgment of distance was poor and he lacked the strength to keep up his accustomed pace.

The other bouts resulted as follows: Otto Berg won a four round decision over Soldier Fred Nelson; Herb Brodie and Frankie Gage boxed a four round draw; Willie Meehan knocked out Jack Carroll in the third round; Willie Robinson and Frankie Jones went four rounds to a draw; Paul Peterson won the decision over Young Jack McKenney; and Kid Kairyannah went four rounds to a draw with Leo Pritchell.

OVERLAND TRACK TO OPEN.

Denver, June 13.—For the first time in eight years, except for a brief attempt at racing three years ago, a race meeting will be held at the old Cleveland track here beginning today. Running horses numbering 350 are here for the meeting which will continue until July 4.

The promoters plan a combination running and harness race meeting. The first six days two harness events will be on the program. Thereafter the cards will be made up of running events exclusively. This will be the first race meeting held under the new Colorado horse racing law which licenses such events. Under the law pari-mutuel betting is allowed. Overland track was built in 1883 and meetings were held annually until bookmaking wars forbade in 1906.

WILLIAMS LEAVES FOR NEW ORLEANS FOR HERMAN BOUT

Los Angeles, Cal., June 13.—Bantam-weight Champion Johnny Williams and his manager, Sammy Harris, will start for New Orleans late next week, to prepare for his meeting there July 4 with Kid Herman. This is the only match that Harris has yet arranged for his new champion. Williams probably will return here late in the fall to meet Charles Ledoux, the French champion.

LADY BARBERS TO ORGANIZE.

Seattle, June 13.—Believed to be the first of its kind in the United States a movement is on foot here today to organize a union of lady barbers, with a view to affiliating with the Central Labor Council.

Meadow Brook, La. 1, June 13.—Eager to see England and America struggle for the international polo trophy, thousands of New Yorkers and sport lovers from a score of cities, by steam and electric train, by automobile and by trolley, thronged here today for the first of the games which will settle supremacy for 1914.

Early in the day the first trainloads arrived and from then until the hour of the game they came in myriads packing to suffocation the spectators' stands which stretched unbroken in a long line along the expanse of smooth green turf where men and ponies were to fight for the honor of their country and their flag.

Over the Meadow Brook club house, over the gay marquees for the accommodation of the players and all along the rear of the grandstand bravely flew the Stars and Stripes and the Union Jack of the British challengers. In the field when the crowds arrived yellow puttees groomed walked the ponies of the teams along the side lines, red-capped groundkeepers moved about and waiters with black and shining faces scurried in perspiring streams to and from the red booths where refreshments for the throngs were provided. It was barely noon when the last seat was filled in the stands and more than 1500 automobiles were parked nearby. Every one of seven roads leading to the field was a solid stream of vehicles of all sorts. It was one of the biggest crowds ever seen at any similar event near New York, fit and more than fit, to be compared to the jam at a world series baseball game.

New York society with a capital S was there, the United States and Great Britain, Canada, Australia, France, Germany, all were officially represented. Wagering was heavy along the club house veranda, the tingling uncertainty drawing out big money. Odds were at even, however, for the untied teams—as teams—made it anyone's game. That was the sentiment when the ball was tossed into play.

The American team was favorite in the betting at odds of 10 to 6. It was estimated that at least 40,000 persons would witness the game.

EUGENIC MARRIAGES IN CLEVELAND, OHIO

Cleveland, O., June 13.—Announcement by a score of Cleveland ministers of refusal to marry persons who can not show a doctor's certificate of health will be made in a few days, according to the Rev. T. S. McWilliams, of Calvary Presbyterian church, one of the foremost leaders in the eugenic movement here. At the same time the ministers will go on record as favoring the teaching of sex hygiene in the public schools.

In carrying out their determination, the ministers will have the co-operation of the Cleveland physicians, who will examine thoroughly every candidate for marriage referred to them by any minister of the association.

PREDICTS NATIONAL SUFFRAGE IN 4 YEARS

Endorsement of Votes For Women Advance Cause at Least a Decade Declare Delegates to Convention.

Chicago, June 13.—Routine business occupied the attention of the delegates to the convention of the General Federation of Women's Clubs today. The suffrage element, however, was busy campaigning in an effort to place the federation on record as favoring votes for women.

"The endorsement of suffrage by the federation, said Mrs. Grace Trout of Illinois today, will advance the cause of suffrage at least a decade. With a million federated club women back of the move we should win nation-wide suffrage within four years."

TACOMA TO HAVE STRIDENT SUNDAY BLUE LAW

Tacoma, Wash., June 13.—Shakespearean players as well as some of the movie heroes will have to give Tacoma a wide berth if a measure proposed by the social service board today is passed by the city council. The board's bill would make it a misdemeanor to depict crime on the stage or movie screen. It will cost Brutus 30 days in jail or a \$100 fine every time he stabs Caesar, and the same will apply to Mary Pickford if she takes a potshot at the man who spurns her. The measure will be presented to the council at an early date. There is a clause in the bill that will prevent moving picture theaters and other indoor amusement places from opening on Sunday before 1 p. m. The object of the clause is to remove competition with the Sunday schools and morning church services.

BANDIT HOLDS UP RAILROAD STATION AT NORTH PUYALLUP

Tacoma, Wash., June 13.—Local police and railway detectives are searching today for a bandit who held up the Chicago, Milwaukee and St. Paul railway station at North Puyallup at midnight and robbed Night Operator Chaderton of a small sum of money. Chaderton was alone in the building when the robber, masked and armed with a big revolver, made his appearance and ordered the operator to turn over what money he had on his person. He then broke open the cash drawer, but this yielded only a few dollars. Then the bandit disappeared.

VIVIANI ACCEPTS FRENCH PREMIERSHIP AGAIN

Paris, June 13.—Rene Viviani today accepted the French premiership again. He was appointed to the post following Premier Dumergue's resignation but found himself unable to form a cabinet, so withdrew his acceptance. Premier Ribot, who then got the office, being forced to resign Friday, however, on his first appearance in the chamber of deputies, Viviani agreed to make a fresh attempt. It was said his plan was to reappoint all the members of the Ribot ministry with the exception of some one he will have to leave out to have a portfolio for himself.

ATLANTIC STEAMERS COLLIDE.

New York, June 13.—Wireless messages received here today from Captain Roberts of the American liner New York said that his vessel had collided at sea with the Hamburg-American liner Pretoria. The damage to both vessels, he said, was slight, and all passengers escaped injury. Captain Roberts estimated that the accident occurred 175 miles off Nantucket. The New York carried 600 passengers and the Pretoria 750.

COMMERCIAL TRAVELERS CONVENE MEETING

Public, Colo., June 13.—The annual convention of the United Commercial Travelers of America, jurisdiction of Colorado, New Mexico and Wyoming, convened today for a two-day session. Election of officers, discussion of legislation affecting traveling men, and interchange of business ideas will occupy the time of the delegates.

WILSON TO SIGN MONDAY.

Washington, June 13.—President Wilson was expected today to sign the Panama canal tolls repeal bill Monday. That he would express the opinion that the amendment adopted Thursday by the senate and concurred in by the house Friday was unnecessary was considered likely. However, having gained, essentially, what he wanted, it was deemed certain that he would accept the measure as amended.

At London.—Mrs. Jackson Gourand, 40 years old, daughter of Edwin Bryant Crocker, was married to Alexandre Miskinoff, Russian, 28 years old, her fourth husband.

At New Haven, Conn.—Despite two blood transfusions, Dr. Otto G. Ramsay, professor of gynecology and obstetrics at Yale, died of pneumonia.

At Christiana, Norway.—Testing an aeroplane he means to take on his next polar trip, Ronald Amundsen had a bad fall but escaped unhurt.

At Moundville, W. Va.—Dressed for the gallows and waiting to be led out to his death, Silas Jones, convicted of wife murder, was respite 30 days.

At McKittrick, Cal.—Jimmy Smith, former Oakland outfielder, was reported near death at his home.

At Los Angeles—Miss Helene Young, who passed a worthless check to aid her dying sister, was given probation by the superior court.

At Hartford, Conn.—Ascending for a race with Barney Oldfield, in an auto, Lincoln Beachey had a 45-foot fall with his aeroplane and was knocked unconscious, but not seriously hurt.

At Paris.—Editor Leon Daudet of Action Francaise, was wounded in a duel by Jacques Roujon, who challenged him on account of editorial criticisms of Daudet's father, late secretary of the academy of fine arts.

THE DAKOTA WOMEN FIGHT FOR VOTE

Fargo, N. D., June 13.—North Dakota women today began a strenuous campaign for the ballot. All schools, churches, women's clubs, colleges and women's societies will be united into a gigantic working organization. The petition for suffrage will be submitted to the male voters at the November election. Mrs. Elizabeth P. Anderson of Valley City, who is backing the movement, declares the women are confident of casting their ballots in the spring of 1915.

POMONA SHIPS GREATEST CROP OF ORANGES EVER

Pomona, Cal., June 13.—The largest crop of oranges in the history of the valley is the record of the season just closed, according to today's report from the San Antonio Fruit Exchange, which has shipped up to the present time 3,400 cars, 500 cars more than was ever before handled in one season from the present territory of this exchange. The Valencia crop, which will be shipped slowly during the summer, is estimated at 550 carloads.
