WILL SET THE RECORD FOR FINE EXHIBITS

That the state fair this year will set a record for size and number of exhibits was a statement made today by Frank Meredith, secretary of the state fair board. He said that the Eastern part of the state would be better represented than ever before.

"Mrs. Edith Tozier Weathered, a member of the board, who has just returned from the Eastern part of the state assures me," continued Mr. Meredith, "that many of the counties there that never exhibited before will have displays this year. Their decision to exhibit this year is due largely to the redistricting of the state so as to have different classifications for various sections. There are three districts and premiums will be awarded for each. Unatilla, Wasco, Wheeler, Baker and probably Sherman, Malheur and Morrow will have county exhibits. Hood River will have a big fruit exhibit."

THE FOURTH TRYOUT

Newport, R. I., July 13.—The fourth race in a series to select a defender of the America's cup started shortly after noon today on a 38-mile course off the Brenton reef lightship. The three yachts got away as follows: Resolute, 12:15:15; Vanitie, 12:15:18; Defiance, 12:15:36.

Weather conditions were favorable for a keen contest. Two of the yachts, the Resolute and the Vanitie, were new mainsails.

"I further believe," said Mr. Sugrue, "that the demands of the consumer have to be conformed with. The consumer cannot be overlooked but must be studied and catered to systematically. Special effort must be made at all times, in packing and shipping. This may not mean an increased result at the time, but it aids in the establishing of a market. This the grower is beginning to believe is the object at which he must aim."

Mr. Sugrue reports that the tonnage handled through the Union this year is estimated to be about 20 per cent greater than last year. This will bring the tonnage of the Union up to about 600 cars. Shipping is looked forward to start about ten days earlier this year, or about the 10th to 15th of September. "The crop of the Cashmere district is the quality crop," said Mr. Sugrue. "Last year we shipped thirty odd cars in the famous Shookum brand, and this year will have about three times that many. This means that the grower is recognizing the need for specialization in the pack. The sales last year through the Union were about 95 per cent f. o. b. Cashmere, which is the popular way with the grower, who realizes within a short time on his crop. Last year's averages for returns to our Union were about thirty days after shipment of cars," Mr. Sugrue further states that prices received last year through the Cashmere pool were more than favorable, by comparison with others.

THE CARROLL JURY UNABLE TO AGREE

Is Out 44 Hours and Stands Six to Six
—The Albert Quartier Case Is On
Trial This Afternoon.

The jury in the case of Roy Carroll, charged with the murder of John Zolliar of Gervais, was unable to agree after 44 hours of deliberation and reported their disagreement to the court at 10 o'clock this morning. The jury stood six for acquittal and six for a verdict of manslaughter. The jury in the previous trial was divided all the way from murder in the first degree to acquittal, but none of the jurors held for murder in the first or second degree in this trial. The case will be retried later at this term of court.

The opposing attorneys will set the date for the third trial at 9 o'clock tomorrow morning and in the meantime Carroll will remain in jail where he has been since the early part of December. J. M. Richards charged with violation of the corrupt practices act appeared in court this morning, represented by L. D. Mahone of Portland, and Walter Winslow, of this city, and his case was set for hearing tomorrow.

The selection of a jury in the case of the State against Albert Quartier, charged with perjury, took up the forenoon session of Judge Kelly's department this morning. Judge P. H. D'Arcy appeared for the defendant and Attorney Walter Winslow, was prosecuting the case for the State in the absence of District Attorney Ringo.

The jury which had been on duty since 2 o'clock Saturday on the Carroll murder case plainly showed the effects of the long vigil and Judge Kelly excused them from attendance in court until tomorrow morning in order that they might catch up with their sleep. In order to carry on the court business it was necessary to draw a special venire of jurors and the following were drawn: A. Dune, merchant of Salem; W. S. Gulvin, farmer of Marion; W. A. Budlong, Salem wood dealer; C. L. Prince, Salem merchant; George H. Bell, merchant of Sublimity; C. E. Bradley, Salem farmer; Charles Sappingfield, Salem farmer; C. H. Johnson, farmer Chemawa; C. H. Long, farmer Fairgrounds; Roy Barton, Salem accountant.
