ATTENTION CALLED TO FISH CANNERIES

Commission Asked to Investigate Canneries Where Conditions Are Asserted To Be Intolerable.

Seattle, Wash., Aug. 11.—Federal investigation of the conditions in the fish canneries in this state was this morning asked of the commission on industrial relations by Dr. Theresa McMahon of the social science department of the University of Washington and a former member of the minimum wage commission.

"The canneries are intolerable from an economic and filthy from a health standpoint," she said. THINKS AMERICA WILL GET INTO IT

The United States will be drawn into the great world conflict that has just started in Europe in the belief of Dr. D. N. McInturf, lawyer, preacher, and former missionary to Japan, who is practicing law in this city. He believes that the nations are so feverish and so like a tinderbox that the least inadvertence may throw this country into the maelstrom of war. He believes that Secretary of State Bryan's insistence of strict neutrality for the United States and the invariability of China will precipitate an attack that will compel the United States to resort to force.

"This conflict," declared Dr. McInturf, "may be the death struggle of barbarism in our modern lives and may mark the last great war of the world. The present conflict was inevitable on account of the crushing race for armament between the European nations. It had come to such a pass that someone must either fight or throw up the race and the die was cast for fighting.

"Again," he said, "the Adventists believe, this war marks the beginning of the end of the world, the Scriptures will be fulfilled. It was predicted that before the end of the world and the beginning of the millennium, at which Christ was to make his second appearance on earth, there should be wars and rumors of wars and finally one great, world-wide conflict.

"What the outcome may be none of us can tell. It is practically certain that the map of Europe will be changed. Probably there will be several republics born, or possibly a great United States of Europe."
