WIRELESS TELLS TALE OF SAN DIEGO FLOODS -- WATER SUPPLY SAFE

San Diego, Jan. 29.—(By wireless to Los Angeles).—United States cavalry today searched the devastated Otay valley for bodies of the 50 believed drowned when Otay dam broke and a 49 foot wall of water thundered through the orange groves and little ranches. The valley has been swept clean. Everything is gone. The estimate of 50 dead is believed correct.

Relief work for the few who escaped is under way, and a big sum has already been raised.

The San Diego water supply is absolutely safe. There are four other big dams to draw from, and a second system is in reserve.

Sorrowing relatives and friends of those hurled to death by the rush of water Thursday afternoon followed the cavalry horses through the devastated district today, aiding in the hunt. But there was nothing left. Not a tree, not a house, not a survivor. The once fertile Otay valley, where there were so many little homes, was a muddy waste.

The troops were called into service this morning. They headed a dreary procession from San Diego. Mourners followed at their heels, on horseback and in buggies, but none in automobiles on account of the mud.

At the edge of the valley, they found a huddled group of horrified survivors, who had refused to leave, preferring to remain and hunt in the Otay for some traces of friends swept into eternity without a chance for life.

Some of the corpses may come ashore along the beach, and it is thought possible a few may be drowned in the lower parts of the valley of death, where it is wider and the waters lost some of their terrific power.

In other parts of San Diego flood conditions continue grave.

At Old Town, the police and militia were called to aid rescue work and prevent looting.

The San Diego river at Lakeside became a menace and citizens heeded the

warning to flee.

Undermined, the Switzer dam broke, and water rushed from the canyons of Balboa along Fourteenth, Fifteenth, Sixteenth and Seventeenth streets. Dyamite blasts were fired to clear debris and keep the torrent from piling up.

Police saved many flooded houses. The residences on Sixteenth street were toppled over on their sides. Two residences on Sixteenth street were toppled on their sides. Apartment and private homes from the park to the bay were undermined. Occupants fled, carrying their valuables.

There was no loss of life in San Diego because those living in dangerous places fled when the dam became unsafe. Whistles were blown and warnings sounded.

Lodgers at the Howlands apartments fled down fire escapes. Horses were taken from the city stables while water rose around the stalls.

Torrents are eating at the protecting rip-rap of the Tia Juana race track. If they break through the entire plant may go.

Market street is under water. The entire yard of the old United States military barracks was inundated. The Santa Fe yards near Market and Atlantic streets were flooded. With the flood standing three feet deep on Broadway, the principal street car traffic practically halted.

It was impossible to reach Old Town by trolley and the district beyond the University avenue "short line" was marooned. Water got into the isolation hospital at Old Town and nurses had to fight it with sand bags.

BASEBALL MANAGERS PEEVED OVER TALK

San Francisco, Jan. 29.—A row of proportions that threaten to disturb seriously the harmony of the Pacific coast league resulted today between Walter McCredie, manager of the Portland club, and Henry Berry, owner of the Seals, over McCredie's charge that syndicate baseball still exists in the league.

Believing the charge was aimed directly at him, because of his former connections with the Vernon and Los Angeles clubs, Berry declared today he would force McCredie to retract the charge or he would "drive him out of baseball."

Berry's ire was particularly aroused by stories in Portland newspapers quoting McCredie as declaring that Berry is a stockholder in the Los Angeles and Vernon clubs, besides owning the Seals. "If McCredie made that statement, he is an unmitigated liar," said Berry. "I can produce my books and securities at any time to prove it. I own the San Francisco club and I do not own a single share of stock in any other club."

Dispatches from Los Angeles today indicated that Owner Powers of the Los Angeles club and Owner Minor of the Vernon club both backed up Berry's statement. Powers was very indignant.

"If Berry wishes to remove the franchise from Portland on account of McCredie's acts and words, I am for him, hook, line and sinker. We have tolerated McCredie's knuckle long enough. He is attacking the honesty of baseball. If he wants a fight he will get it."

President Baum of the Pacific Coast league today declared also that McCredie's purported statements are untrue.

Baseball fans predicted trouble at the special meeting here next week, if Walter McCredie, and not his uncle, Judge McCredie, attends the gathering.

San Diego, Cal., Jan. 29.—Damage to the Tia Juana race track as the result of the recent big storm in southern California in a week caused the announcement today that the race meeting would not be resumed until some time next week.

Ferris Bill Is Not Indorsed By Labor

Portland, Ore., Jan. 29.—While the Oregon Federation of Labor adopted a waterpower resolution in the closing hours of its session yesterday, it failed to sanction a motion that body memorialize congress to enact the Ferris bill now pending on this subject.

Delegate Lawrence had made the motion memorialize congress to enact the Ferris bill, but it was a latent opposition and the matter was sent over to the afternoon session for further consideration. However, nothing more was heard of the matter. It is suspected that debate on this proposition would have aroused antagonism and it was dropped.

The convention doubled the amount of its per capita tax on the unions affiliated with it, and returned it to a vote of the various unions for ratification. It was the purpose of some in the body to push the increase through without referendum, but Delegate McKenzie headed this off by moving the referendum. Debate was sharp and general over the proposition.

Heretofore the tax was one and a half cents for each member of every union affiliated with the federation. Hereafter it will be three cents a month, if the referendum is successful. The plan is to raise \$3500 during the current year, so as to finance the "people's land and loan bill" for the election in November. That is the single tax measure, which the federation, against the judgment of some, farmers particularly is advocating.
