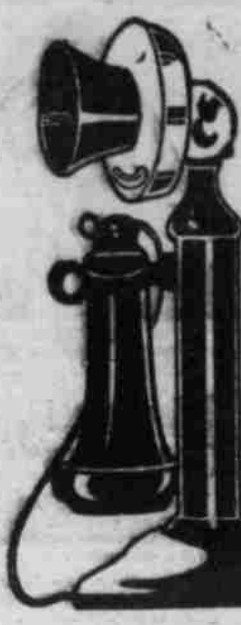

SUMMONS
In the Circuit Court of the State of Oregon for Marion County, Department No. 2.

W. H. Norris and Alice Norris, plaintiffs, vs. Geo. G. Nelson, Olive J. Nelson his wife, Falls City-Salem Lumber Company, a corporation E. H. Barnhardt, Ralph W. Farris, J. F. Day and Geo. A. Day, partners doing business under the firm name and style of Sunset Grocery Company, defendants.

To the above named defendants, Geo. G. Nelson, Olive J. Nelson, his wife, and Ralph W. Farris: You are hereby required to appear and answer a complaint filed against you in the above entitled court and cause within six weeks from the date of the first publication of this summons and if you fail so to appear and answer said complaint, plaintiffs will apply to the court for the whole of the relief demanded in their complaint, and more particularly, to wit: For a Decree foreclosing plaintiffs' mortgage on the following described real property, to wit:

Beginning at a point ninety feet East of the Northwest corner of Block Eighteen (18) of Nob Hill Annex to the City of Salem, running thence South parallel with Hazel Street one hundred (100) feet; thence East parallel with Electric Avenue thirty (30) feet; thence North parallel with Hazel Street one hundred (100) feet to the South line of Electric Avenue; thence West along said line thirty (30) feet to the place of beginning together with the following described premises, to wit:

Beginning at a point sixty (60) feet East of the Northwest corner of Block Eighteen (18) in Nob Hill Annex to the City of Salem, running thence South parallel with Hazel Street one hundred (100) feet; thence East parallel with Electric Avenue thirty (30) feet; thence North parallel with Hazel Street one hundred (100) feet; thence West parallel with Electric Avenue thirty (30) feet to the place of beginning.

That plaintiffs will take judgment against defendants, Geo. G. Nelson and Olive J. Nelson, his wife, for the sum of two dollars and fifty cents (\$2.50) paid for insurance on the buildings on said premises and for the further sum of four hundred sixty dollars (\$460) together with interest thereon at the rate of six (6) per cent per annum from the 15th day of May, 1916, until paid, and the sum of seventy-five dollars (\$75) reasonable attorneys' fees, and plaintiffs' costs and disbursements incurred in this suit.

Mrs. David Mills and daughter, Miss Lena Patton, of Shaw visited relatives here Sunday.

Uncle Sam is getting on his bonnet at last and believe me he's getting it on in good shape.

Yes, the city clerk and the unskilled city working man do feel the high cost of living as do we here in the country. While they buy practically everything they eat, we raise some of ours, yet it costs us something. We don't get biscuits and flap jacks and loaf bread for naught to say nothing about the labor of producing them. Let's see. Wheat in Salem was quoted in Monday's Capital Journal at \$1.50 a bushel. There is about 40 pounds of flour in a bushel of wheat. The cheapest flour is now more than 4 cents a pound, the dearest 5 cents.

At \$1.50 per bushel for wheat we get 2½ cents a pound and pay for our cheapest flour more than 4 cents, and for the higher grade 5 cents. And more it costs about 50 cents a bushel to get our wheat in the sack, so we in this way with dollar wheat at a little more than a cent and a half a pound buy flour at a little more than 4 cents a pound. Also our butter and eggs don't come free. They cost us something to produce. Even our present high priced potatoes cost us something too. Also our sugar and ten and coffee and clothing cost us the same as city folks pay. Again, scores of owners of small farms—10 and 15 acre tracts do not raise their own bread—have to buy flour and no wheat to buy it with. Many Oregon farmers with more than 20 acres pay out cash for their flour.

Wednesday G. O. Swales owner of "Crescent Stock Farm" sold at auction household and other personal property, cows, pigs, etc. He goes to Pullman, Wash., to take charge of his father-in-law's large ranch. He chartered a car and will take quite an amount of household and other personal belongings. Rev. Edward Simpson and family of Salem will in a short time occupy the farm home.
