GERMANY BEGINNING TO WORRY ABOUT IT

Realizes the Tremendous Force She Has Antagonized —Wants Peace with Some

By W. S. Forrest (United Press staff correspondent) Paris, June 21.—Germany is getting worried now about America's entrance into the war. Therefore she is redoubling her efforts toward a separate peace with any of the allies, according to the belief of Former Foreign Minister Cambon, in viewing developments in Athens, Stockholm and Petrograd.

Oregon Has \$395,486 of Its \$600,000 Quota

Portland, Or., June 21.—Totals compiled this afternoon showed that Oregon has raised \$395,486 of her \$600,000 allotment. Portland alone had contributed \$186,719 up to 1 o'clock this afternoon.

Asked to raise \$15,000, the district composed of Sherman and Wasco counties reported subscriptions totalling \$52,000 and the committees are still at work. Unattila county was subscribed its quota two thousand dollars this morning.

Oregon will fill her \$600,000 allotment in two days, E. L. Corbett, head of the campaign, said today.

Now that 53 have taken examinations in the various courses which have been given at the postoffice Red Cross rooms, it is hoped that these will not consider their work finished and that they are no longer needed there. In fact, so says Mrs. H. E. Clay, they are needed more than ever before, because of their superior knowledge, and of their more efficient training.

Packing of the supply boxes is under way at the postoffice today. There are many pairs of socks, many bandages and a great lot of surgical supplies which will be sent to San Francisco either today or tomorrow.

Mrs. Rita Squier Seely wishes the public to remember that \$1 pays for an annual membership and that there are no further dues or payments for membership. Such persons will be discovered if such solicitation continues, and their names will be made public.

ASKS STATE AID TO FIGHT FOREST FIRES

Flames Enter California Redwood Park and It May Be Destroyed

Santa Cruz, Cal., June 21.—An urgent call for state help in fighting the fire threatening the California Redwood park was telegraphed to Sacramento today by Professor C. B. Wing, secretary of the park commission in charge of fighting the flames. Park Warden Duol declared early today that the park is in serious danger of destruction unless fresh fire fighters are furnished immediately.

Last reports today from the scene of the blaze showed that the flames had entered the redwood park between the east and west forks of Waddell creek and that, if the wind should change to the south the entire forest would be in very grave danger. Some splendid timber is already in flames.

The fire fighters who have been at work without rest for 48 hours backfired in the park all night and early today. Many of these fighters have collapsed under the strain of their efforts. To relieve them, Professor Wing hurried to Boulder creek where he made an attempt to engage a large number of men.

Unless the fire is checked soon, the wind will carry it to Ben Lomond mountain and to the rich Bonny Doon fruit section and will also threaten the cement town of Davenport.

35 Miles Burned Over. San Jose, Cal., June 21.—The forest fire threatening to devastate the California redwood park, in Santa Cruz county, was reported early today to be only 3 miles from Big Basin and to be steadily advancing under a high wind.

So rapid is the progress of the blaze that one place the flames leaped nearly a mile. An area five miles by seven has already been burned over. In some sections the flames are reported beyond control.

A desperate shortage of men faces the authorities in charge of the fire fighters. Those who have been trying to stop the flames have already been working 48 hours without rest.
