The county court relief fund comes under the jurisdiction of the county court. From this court many cases are put on the pension list and according to past experience, one of the large duties of the county court is to give relief in the way of monthly pensions.

Individual relief is often through the information received by the Social Service Center.

It is a game of skilled diplomacy, but one of the chief faults is that the allies are playing it with a minister who is solely responsible to the Kaiser.

To my mind, the most satisfactory channel of communication available is provided by the German socialists and particularly by the minority socialists.

Personally, I would much rather consult with a German minority socialist during the war than with an official of an autocratic German government after the war.

If we really desire to see a democratic Germany, we should do all in our power to strengthen the democratic elements in Germany. If we intend that peace when it comes shall be a democratic and lasting peace, made by democratically elected representatives of all the people concerned, surely it would be better to address our speeches not to the German imperial chancellor, but to the servant of the Kaiser, but to the elected representatives of the German people.

So long as military effort is necessary there must be no slackening on the part of the allies, but that is no reason why, side by side with such effort, we should not attempt, by a wise and sensible use of the political weapon, to hasten the settlement of the war by a peace which shall be just, honorable and democratic.

Spokane Telephone Girls Out On Strike

Spokane, Wash., Nov. 21.—Demanding recognition of their union and the discharge of non-union electrical workers, members of the telephone girls' union walked out at midnight this morning.

D. P. Reid, secretary of the electrical workers' union, estimated today that only 75 out of 250 girls employed are on the job.

Downtown telephone service today is normal, but service in some of the residence districts is paralyzed.

Governor Appoints Advisory Draft Board

Governor Withycombe yesterday having a day off from his visiting list took occasion to appoint the central advisory board to handle the legal phases of the conscription act. Attorney General Brown is named as chairman; J. N. Teal, Portland; Colonel Sam White, Portland and Richard W. Montague also of Portland constitute the board. The principal work of this board is to make recommendations to the governor as to the membership of the local legal boards. Its first job is to decide on a number of these, and as they are to be so located as to be convenient to those liable to the conscription act, there will be quite a number of them. The governor nominates the men and they receive their actual appointment from the president. The local boards are to be made up mostly of lawyers and all of these are requested to place themselves at the disposal of the board. These local boards are simply to advise those whose names have been drawn for conscription as to their duties and the operation of the law as applied to individual cases.
