GENERAL HOLIDAY ON NEXT TUESDAY FOR BRIDGE OPENING

Practically All Business Houses Will Be Closed Most of Day

With the closing of all the leading stores of the city and an agreement of the grocers and meat markets to close at 10 o'clock, Salem will take on a holiday appearance next Tuesday when the Marion-Polk bridge is dedicated.

While the city hall, court house and state house may not be entirely closed, the indications are that the offices that do remain open will be put on a very limited force, in order that everybody in the city may take part in the holiday and enjoy the exercises.

The executive committee states that the plans of the day are as those already announced. At 9:30 o'clock Charles R. Archerd will auction off the privilege of first crossing the bridge. This will be under the bridge at the speakers stand. Then will follow the addresses of Justice Burnett, Dr. Carl Gregg Dorey and Dr. Esther Lovejoy.

At 1 o'clock the 2d battalion will assemble at the armory in uniform for the grand parade, which will be entirely military in character. According to plans as announced by W. E. Rigdon, chairman of the parade committee, the line of march will be as follows, beginning at the armory:

Commercial to State street.
State street to Waverly, between the State house and the Supreme court building.
Waverly to Court street.
Court street to Commercial.
Commercial street past Marion square.

The parade will be led by the governor and staff, followed by the Cherriens band and then the 2d battalion, including the three companies of Salem, the Silverton and Stayton companies and the new company formed last evening at the armory. After the battalion will march the Red Cross nurses, the parade closing with the boys scouts.

The governor and staff will review the parade at Marion square.

For the first time in the history of Salem, no civilians will be permitted in a parade, regarding the Red Cross nurses and Boy Scouts as auxiliaries of the army.

The parade will begin promptly at 2:30 o'clock and will lead to Marion square, where the principal amusement of the afternoon will be the dancing pavilion in charge of the Cherriens. Again in the evening there will be the community sing, the Cherriens band concert and the jitney dance by the Cherriens as a Red Cross benefit.

Traverse Lake Project Approved By Engineer

State Engineer Lewis has approved the applications of P. A. Phillips and others for the construction of the Traverse Lake reservoir and the Echo Lake reservoir in Baker county for the storage of water at the head of West Eagle creek, and the application for the appropriation of the stored water together with the waters of Goose Creek and West Eagle Creek for the irrigation of 2321 acres of land near Keating, Oregon. This project involves the construction of two small reservoirs at an estimated cost of \$7,000,000, and the distribution system is estimated to cost about \$45,000,000, the total length of the main canals being about 20 miles.

A permit has also been issued to the Big Creek Ditch Company of Medical Springs, Oregon, for the appropriation of 41.81 second feet of water from Catherine Creek for a supplemental supply for the irrigation of 3345 acres of land. It is proposed to construct a ditch about 4 1/2 miles in length across the divide from Catherine Creek to divert the water into Big Creek at an estimated cost of about \$8,000,000.

Farewell Reception For Miss Ruth Fields

In honor of Miss Ruth Fields, who is to leave in August as a missionary to India, a farewell reception will be given Monday night at the First Methodist church. The reception is being given by the church, the Sunday school, the Foreign Missionary society and the Epworth League, as she was active in all these branches of the church.

Miss Fields is being sent to India by the Columbia river conference of the Methodist church. She will teach music in a Methodist school at Calcutta.

At the reception a short program will be given as follows: Piano solo, Miss Genevieve Finley; short address, Dr. J. Talbot; vocal solo, E. D. Barton; short address, Dr. R. N. Avison; duet, Mrs. R. W. Walton and Miss Grace Smith; presentation of gifts, Mrs. Katherine Umeyer.

Austrian Socialist Want Early Peace

Cablegrams From Russia and Austria Indicate State Of Anarchy

Copenhagen, July 27.—That an early peace is 'absolutely essential to the life of Austria-Hungary, Bulgaria and Turkey,' was declared in a communication addressed to the Austrian ministry by socialist members of parliament, according to a Vienna dispatch received today.

Herr Ziz and Herr Seliger, socialists, asked the ministry whether it was prepared to negotiate with Germany regarding war aims, and demanded immediate preparation for peace negotiations. They also demanded that the ministry renounce all imperialistic and annexationist aims.

German Newspapers Admit Teuton's Defeat

Washington, July 26.—While numerous German papers are exhorting the public to maintain "sangfroid," the Rheinische Westphalesche Zeitung is reassuring the people that Von Hindenburg still holds the initiative, according to cables received today.

Consternation is spreading over the central empires at the allied successes and great surprise is evidenced over the failure of the plans of the general staff, Zurich cables state.

German Newspapers Admit Teuton's Defeat

Berlin, via London, July 27.—Fighting between Soissons and Rheims decreased, while French attacks east of Rheims were repulsed, the German war office announced today.

"Austrian the Scarpe unsuccessful attacks were made by the British," the statement said. "Between Soissons and Rheims, the fighting decreased. Astride (Perthes-Lez-Hulub) (30 miles east of Rheims), French partial attacks were repulsed."

"In the Vosges, the enemy was unsuccessful in reconnoitering operations near Sundgau."

Berlin Reports All Attacks Repulsed

London, July 27.—Turkish socialists are holding conferences for discussion for organization of an energetic agitation among the proletariat of Turkey for the downfall of the Turkish bourgeoisie and capitalists, an undated Moscow dispatch said today.

London, July 27.—A German report that the Russian general, Gourko, had been appointed commander in chief of the allied forces in the Murman district, was officially denied here today.

Stockholm, July 27.—The family of the former czar, is safe in the Abolaski monastery, a Moscow dispatch announced today.

Zurich, July 27.—Serious disorders

State House News

Mr. Nunn Said the Roads are in Splendid Condition for Traveling.

Five Fatal Accidents in Oregon Last Week

During the past week 582 accidents, of which five were fatal, were reported to the state industrial accident commission. The victims of the fatal accidents were Wm. Thos. Beagle, Medford; (Fireman); M. Nakayama, Doc. Lumbering; Dick Baker, N. Portland, shipbuilding; J. F. Smith, Seaside, lumbering; C. B. Anderson, Portland, shipbuilding.

Of the total number reported, 544 were subject to the provisions of the compensation act; 27 were from firms and corporations which have rejected the provisions of the compensation act; and 11 were from public utility corporations not subject to the provisions of the compensation act; one of which was a non-trespasser who was injured.
